CITY MANAGER:

COVID-19 Updates:

The 6th and **FINAL** round of the California Relief Grant is now open for applications. If a business has already applied for a previous cycle and been put on the waitlist, they **DO NOT** need to re-apply. If a business started an application in a previous round, they could log-in and finish the application during the Round 6 application period. Applications are due May 4th, 2021.

Links as to how to apply, step-by step instructions, webinars in multiple languages and other pertinent information was posted to the Corning Chamber of Commerce Facebook page.

According to Tehama County Public Health, a new variant of COVID-19 has been confirmed within the County that is more contagious with more severe effects than the original. The variant, known as B.1.1.7, can be prevented with all available vaccines.

Appointments can still be made for a vaccination by visiting https://myturn.ca.gov/ at the Red Bluff Community Center. All Tehama County residents ages 16 and over are eligible. There are plenty of time slots available.

4th Quarter 2020 Sales Tax:

I met with a representative from Hinderliter de llamas (HdL), the City's sales tax consultants, on April 28th. 4th quarter 2020 sales tax receipts came in higher than anticipated, which were due to auto sales more than offsetting sales tax decreases from fuel, restaurants, and businesses and industry. Economic impacts from the pandemic are not as great as anticipated statewide. Other states are being impacted by the COVID-19 pandemic to a much larger degree. Cities in California that are most impacted heavily rely on travel and tourism. For example, Anaheim and Monterey. At mid-year budget I projected sales tax receipts to come in approximately \$500,000 more than budgeted or \$3,170,000. HdL now projects the City to receive \$3,270,000 in Fiscal Year 2020/2021. Measure A revenues are projected to come in at \$1,100,000.

I attended a Special Groundwater Commission meeting on the evening of April 28th. POLICE DEPARMENT:


Patrol:

In addition to responding to 191 calls for service, a total of 30 officer reports were taken and there were 83 officer-initiated incidents, including 22 traffic stops. Officers made 7 misdemeanor and 2 felony arrests. Officers issued 19 citations, of which; 8 were misdemeanors, 1 was an infraction, and 10 were parking during the period of April 21, 2021 through April 28, 2021.

Training:


Officers continue to participate in POST Portal training and Lexipol Daily Training Bulletins. Other POST on-line training continues for Patrol and Dispatch personnel.
