CITY MANAGER:

COVID-19 Updates:

According to Tehama County Public Health, there are currently 1,320 Tehama County residents in isolation. There have been 47 deaths, with 3 deaths occurring in the last 14 days. 11 individuals are currently hospitalized, and no ICU beds are available in Tehama County.

Comprehensive 5-Year Economic Development Strategy (CEDs):

3CORE is coordinating the Butte Glenn and Tehama Comprehensive 5-Year Economic Development Strategy (CED). A CEDs is the result of a regionally owned planning process designed to build capacity and guide the economic prosperity and resiliency of an area or region. It is a key component in establishing and maintaining a robust economic ecosystem by helping to build regional capacity (through hard and soft infrastructure) that contributes to individual, firm, and community success. The CEDs provides a vehicle for individuals, organizations, local governments, institutes of learning, and private industry to engage in a meaningful conversation and debate about what capacity building efforts would best serve economic development in the region. A meeting was held on February 4th to identify stakeholder partners to interview.

POLICE DEPARTMENT:

Patrol:

In addition to responding to 135 calls for service, a total of 24 officer reports were taken and there were 111 officer-initiated incidents, including 50 traffic stops. Officers made 10 misdemeanor and 5 felony arrests. Officers issued 12 citations, of which; 10 were misdemeanors, 1 was an infraction, and 1 was parking during the period of January 27, 2021 through February 3, 2021.
