A. CALL TO ORDER: 6:30 p.m.

 - 1. May 17th 23rd as National Public Works Week: Proclamation was read by City Clerk Lisa M. Linnet.

F. PUBLIC COMMENTS AND BUSINESS FROM THE FLOOR:

City Manager Miller provide a COVID 19 update and announced that another COVID 19 positive has been noted in Tehama County bringing our number up to 4. She announced that hair salons and barber shops are now allowed to open with social distancing. Private pools are being allowed to open with certain mandates, public pools are not allowed; we anticipate them to be allowed in late June or early July. The City is working with the City's Pool Manager to come up with a Plan for opening our City Pool. Nail salons are still not allowed to open.

Councilor Demo stated he had been approached by a member of the public regarding the pool opening. He also thanked Staff for removing the handwashing stations and porta potties. He asked about the Farmers Market resuming. He also asked the Police Chief about the Motor Home in front of the former Green Doors; Chief Fears stated that they are working on it.

A member of the public (Dawn Curtis) spoke asking if they could have access to the pool for swim team use. City Manager Miller stated that she would have to check with the County Public Health Officer. She will need to confirm if Swim Team will fall under Stage 2 of the Governor's Plan.

Councilor Valerio moved to approve Consent Items 2-5; Councilor Snow seconded the motion. Ayes: Hatley, Snow, Valerio, Burnett, and Demo. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

- I. PUBLIC HEARINGS AND MEETINGS: None.

J. REGULAR AGENDA:

6. Request City Council direction to sell used Playground Equipment from Yost Park as One Lot and As Is.

Presented by Recreation Coordinator Christina Meeds who stated that the Yost Park Playground equipment had been removed and is being stored at the Blackburn Well Site. She announced that the City has received interest to purchase this equipment from 3 people. Staff, with Council approval would like to sell the equipment as is in one lot. Kristina stated that some others might be interested. Ms. Meeds stated in response to a question of the value, that she had researched this and was unable to find a value due to the age of the equipment.

Council and Staff discussed possibly advertising the sale and the associated legalities of such sale.

Councilor Burnett moved to direct Staff to sell or dispose of the playground equipment removed from Yost Park by the methods listed in the Staff Report. Councilor Snow seconded the motion.

, to sell by method listed above. Ayes: Hatley, Snow, Valerio, Burnett, and Demo. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

7. Authorize City Fire Chief to submit a Volunteer Fire Assistance Grant Application with CALFIRE and approve the 50% grant match funding by the City in the amount of \$5,340.

Presented by Fire Chief Tom Tomlinson who stated that it is a \$10,000 grant with a 50% grant match by the City and then listed the equipment that would be funded by the grant if awarded. He stated that the total cost for all the listed equipment would be \$10, 680 and the City's 50% portion would be \$5,340.

Councilor Snow moved to authorize the Fire Chief to sign and submit a Volunteer Fire Assistance Grant Application with CalFire and approve the 50% grant match funding to be funded from Safety Items/Fire, fund number 001-6552-2300 in the amount of \$5.340. Councilor Burnett seconded the motion. Ayes: Hatley, Snow, Valerio, Burnett, and Demo. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

8. Adopt Resolution 05-26-2020-01 declaring a public nuisance on one (1) property within the City and authorize the Fire Chief to initiate abatement procedures.

Presented by Fire Chief Tom Tomlinson. He stated that this is an ongoing problem property and a Notice was mailed and it has been 18 days without a response.

Councilor Snow moved to declare that a Public Nuisance exists on the one property listed on Exhibit A, to find that such conditions are seasonal and recurrent nuisances, and authorize the Fire Chief to initiate abatement procedures on the property/parcel as outlined in the City's Municipal code. Councilor Demo seconded the motion. Ayes: Hatley, Snow, Valerio, Burnett, and Demo. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

9. Approve Annual Agreement and Membership with 3CORE Economic Development District and the annual cash match of \$7,500.

Presented by City Manager Miller. She explained the various benefits/programs provided to the City by 3CORE. She stated that 3CORE receives a Federal Grant totaling \$75,000 which requires a dollar for dollar local match and the City's portion is of this match is \$7,500.

With no further questions, Councilor Demo moved to approve the annual participation in 3CORE and authorize payment on July 1-2020 for the City's share of the local grant match in the amount of

\$7,500 from fund 001-7408-4010, Economic Development. Councilor Burnett seconded the motion. Ayes: Hatley, Snow, Valerio, Burnett, and Demo. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

10. Adopt Resolution 05-26-2020-02 a Resolution adopting Fiscal Year 2020/2021 Street Project List that will utilize SB1 Funding, the Road Repair and Accountability Act of 2017.

Presented by Public Works Consultant Robin Kampmann. She stated that annually the City is required to submit a plan, and have it approved by Resolution and submitted to the California Transportation Commission (CTC) annually by May 1st before receiving funding under SB1 Funding, however due to COVID-19 the submittal date has been moved to July 15th. She stated the proposed streets are the following:

- Colusa Street Maintenance/Rehabilitation: Cape sealing of Colusa Street between Houghton Avenue and 3rd Street, approximately 0.50 miles, with a useful life of 7-10 years.
- Toomes Avenue Maintenance/Rehabilitation: Cape sealing of Toomes Avenue between Solano Street and Blackburn Avenue, approximately 0.50 miles, with a useful life of 7-10 years.
- 2nd Street Maintenance/Rehabilitation:

Cape sealing of 2nd Street between Solano Street and Fig Lane, approximately 0.50 miles, with a useful life of 7-10 years.

South Street Maintenance/Rehabilitation:

Cape sealing of South Street between 2nd Street and Marguerite Avenue approximately 0.50 miles, with a useful life of 7-10 years.

Hoag Street Reconstruction:

Reconstruction/overlay of Hoag Street between Solano Street and Tehama Street approximately 0.30 miles, with a useful life of 10-15 years.

She further stated that the topographic survey & design for these projects will be completed during Fiscal Year 2019/20 with the work to be completed in Fiscal Year 2020/12 if funding is available and stated that the project list is not "set in stone" should the Council decide to change the location; the list shall not limit flexible use of funds provided that funds are only used for eligible projects. Should another street project be proposed, and funding is available, an amendment could be approved and sent.

Mrs. Kampmann explained that in order to receive the funding, the City must annually expend from its General Fund for street and road purposes an amount not less than the annual average of its expenditures from its General Fund during fiscal years 2009-2012, this is known as the Maintenance of Effort (MOE). If the City fails to meet the MOE in a fiscal year, it can be made up the following fiscal year. The City of Corning's MOE required to meet State set standards is #234,447. City Manager Miller stated that we will need to ensure funding for those Streets associated with the Safe Routes to School Project. Council Demo asked if we were locked into these streets; he was informed no.

Councilor Snow moved to adopt Resolution 05-26-2020-02 adopting the Fiscal Year 2020/2021 Street Projects List that will utilize SB1 Funding, the Road Repair and Accountability Act of 2017. Councilor Burnett seconded the motion. Ayes: Hatley, Snow, Valerio, Burnett, and Demo. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

11. Adopt Resolution 05-26-2020-03 authorizing the City Manager to execute and submit the CARES ACT Airport Grant Agreement, Grant No. 3-06-0053-008-2020 for Corning Municipal Airport.

Presented by Public Works Consultant Robin Kampmann. She stated that the City of Corning submitted to FAA a Coronavirus Aid, Relief, and Economic Security Act (CARES ACT) application

dated May 11, 2020 for a grant of federal funds associated with the Corning Municipal Airport. These funds are to provide eligible Airports with funding to help offset a decline in revenues arising from diminished airport operations and activities resulting from the COVID-19 Emergency. As a result, the City has been offered a grant in the amount of \$20,000. The grants period of performance ends 4 years from date of acceptance, therefore the City has 4 years to utilize these funds and the funds must only be used for purposes directly related to the Airport such as airport operational and maintenance expenses or debt service payments; new airport development projects may not be funded with this Grant unless the Grant Agreement is amended or superseded by a subsequent agreement.

Councilor Burnett moved to adopt Resolution 05-26-2020-03 and authorize the City Manager to sign all required documents for execution of the Cares Act Grant Offer, Grant No. 3-06-0053-008-2020 for Corning Municipal Airport. Councilor Snow seconded the motion. **Ayes: Hatley, Snow, Valerio, Burnett, and Demo. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.**

12. Request approval of the proposed Easement Agreement and Easement Purchase and Sale Agreement with MTBEMAC, LLC for the 30-ft Utility Easement to enable future expansion of water and sewer services on the west side of Interstate 5.

Presented by Kristina Miller who stated that the City has been working on getting these services to the west side of I-5 for some time. She stated that the owner has agreed to the offer of the appraised value for the 30-ft. Utility Easement. This Agreement grants the City access to the property for maintenance and prevents the owner from building on top of this Utility Easement. Fire Chief Tomlinson confirmed that this Easement is by Bartels.

Councilor Snow moved to approve the proposed Easement Agreement with MTBEMAC, LLC, approve the 30-ft. Easement Purchase & Sale Agreement with MTBEMAC, LLC at a cost of \$38,000, and authorize the City's Mayor to sign all associated documents on behalf of the City. Councilor Valerio seconded the motion. Ayes: Hatley, Snow, Valerio, Burnett, and Demo. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

13. City of Corning Capital Improvement Program and Measure A Funding Priorities for Service.

Presented by City Manager Miller who stated that the Capital Improvement Program (CIP) is the combination of three City Departments, Fire, Police and Public Works Capital Improvement Proposals. She explained that the CIP represents the City's long-range plan of action for funding public improvements in support of existing residents, users, and businesses and to accommodate future development. City Council adoption of the CIP establishes a Policy for priority spending however, approval of the priorities does not assure funding; funding is determined by the City Council when the Final Budget is approved.

City Manager Miller stated because of the COVID-19 Pandemic, the City will experience significant decreases in sales tax, transactions and use tax (Measure A), and transient occupancy taxes. As a result, the City will significantly dip into its General Fund Reserves to balance the budget in FY 2020/21. The Fiscal Year 2020/21 losses due to COVID-19 are currently estimated to be:

- Expects an estimated 5% or more loss in Transient Occupancy Tax
- Expects an estimated 9% or more loss in Sales tax
- Expects an estimated 8% or more loss in Measure A Funds
- Expects an overall estimated \$800,000 budget deficit due to the reduced revenues stated.

City Manager Miller informed the Council that the City has close to \$ 3,000,000 in General Fund Reserves and stated that many Cities do not and are in panic mode, some are doing layoffs. She then explained the rational to fund large items/equipment over time and the process. She then presented the requested items and proposed funding associated with each of the three Departments and stated that as a result of Measure A funding, General Fund dollars, and the Enterprise Fund dollars, the City will be able, with City Council approval, to complete the proposed Capital Improvement projects listed at a total combined cost of \$575,885 for all three Departments. Councilor Burnett stated her appreciation for the City Managers forethought related to the budget.

City Manager Miller presented the items requested for each Department as listed in the Staff Report Councilor Snow stated his concerns in purchasing another patrol vehicle versus other equipment. Police Chief stated that although other areas have reduced due to the COVID 19 situation, crime has not. He stated that the safety of his Officers is of upmost concern, they need their safety items. He also stated he would entertain putting off the purchase of one of the vehicles at this time. He also clarified that the number of rifles requested and noted a reduction in the cost of the computer server.

She then presented the equipment requested for Public Works.

Councilor Snow moved to approve the Fiscal Year 2020/2021 Capital Improvement Priorities as presented with the change to the Police Department proposal to remove replacement of one vehicle but approving all other items. Councilor Burnett seconded the motion. Ayes: Hatley, Snow, Valerio, Burnett, and Demo. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

SUMMARY:

The Fire Department seeks authorization to declare the 1995 Ford Emergency Response Rescue Squad as surplus and sell it through BidCal, an online Auction.

Originally the Department intended to covert the 1995 Squad to the Chief's Truck. It has since been discussed and decided that the most cost effective would be to surplus the squad with the eventual purchase of a new Mini-Attack Chief's Truck. It is requested that the funds from the sale go toward this purchase.

BACKGROUND:

In April 2019, the Fire Department purchased a 2020 Ford F-350 Emergency Response Rescue Squad which was received and put into service in April 2020 replacing the 1995 Ford Emergency Response Rescue Squad.

RECOMMENDATION:

THAT MAYOR AND COUNCIL AUTHORIZE THE FIRE DEPARTMENT TO:

- 1. SURPLUS AND SELL THE 1995 S-7 EMERGENCY RESPONSE RESCUE SQUAD THROUGH BIDCAL; and

UPDATED INFORMATION:

BACKGROUND:

Staff has been asked to present a proposal to the Planning Commission and City Council that would allow the development of residential parcels smaller than the minimum size of 6,000 square feet (sq. ft) for interior lots, and 7,000 sq. ft. for corner lots as currently established in Section 16.21.030 (A) and Section 17.10.040 of the Corning Municipal Code (CMC). The proposal would create a "Small Lot Designation" that would allow the establishment of residential parcels with a minimum lot size of 4,000 sq. ft. for interior lots and 4,500 sq. ft. for corner lots. The creation of smaller parcels requires the establishment of height, bulk, and space requirements that would be applicable to the development of these parcels. Height, bulk, and space requirements establish minimum lot size, width, building coverage, front, back and side yard setbacks, building height & width requirements, etc.

PLANNING COMMISSION ACTION:

On April 21, 2020 the Corning Planning Commission voted 5-0 to recommend that the City Council adopt the 3 Factual Subfindings and Legal Findings as presented in the Planning Commission staff report and adopt and approve Ordinance No. 688, the Ordinance to implement Rezone 2020-1. With their motion, the Planning Commission recommended that new height, bulk, and space requirements be adopted as follows for the small lot designations. Therefore section 17.10.032 would add the following height, bulk, and space requirements applicable to the development of small lot parcels.

- A. Minimum Lot Area 4,000 sq. ft. interior lots, 4,500 sq. ft. corner lots,
- B. Minimum Lot Width 40 feet interior lots, 45 feet corner lots,
- **C.** Maximum Building Coverage Sixty percent of lot area with a minimum width of any residential structure of twenty feet,
- D. Minimum front yard setback of ten feet to residence/porch and a garage must be set back to twenty feet.
- E. Side yard shall not be less than five feet for each side yard. Three feet shall be added to each required side yard for each story above the first story of any building. The side yard on the street side of each corner lot shall not be less than ten feet. A twenty-foot minimum side yard shall be required where a two-story residential structure will be located on a lot which abuts the rear yard of a single-family lot,
- F. Rear yard shall not be less than ten feet,
- G. Building height limit, two and one-half stories, but not exceeding thirty-five feet,
- **H.** Main building area, the main building shall have a minimum floor area of eight hundred square feet, living space. The definition of "main building" includes a mobile home.

On May 12th Staff presented the information below relative to the adoption of Ordinance 688 and Rezone 2020-1 that would create a "Small Lot Designation" within the Municipal Code. At the meeting Staff recommended adding language to clarify the length of eaves for residences constructed on these small lot parcels. After further Staff discussion, the following Sections were amended and the Ordinance was readvertised.

Section 17.10.032,

E. Side yard shall not be less than five feet with a two-foot overhang on each side. Three feet shall be added to each required side yard for each story above the first story of any building. The side yard on the street side of each corner lot shall not be less than ten feet. A twenty-foot minimum side yard shall be required where a two-story residential structure will be located on a lot which abuts the rear yard of a single-family lot,

I. No portion of a structure, excluding two-foot eaves shall be constructed in a Public Service or Utility Easement as depicted on a recorded map.

GENERAL PLAN:

The 2014-2034 Corning General Plan contains goals throughout the plan.

Table LU-1 provides "General Plan Land Use Classifications." For Single Family Residential (SFR) classifications the plan states: "Provide single-family and two family residential living environments receiving a full range of urban services - Maximum densities 14 dwelling units per acre."

Development of parcels of 4,000 sq ft. minimum permits 10.89 units per acre so creating a "Small Lot Designation" that permits these lots would be consistent with the General Plan.

ENVIRONMENTAL:

The California Environmental Quality Act (CEQA) Section 15061 (b) (3) states: "a project is exempt from CEQA if: The activity is covered by the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. Where it can be seen with certainty that there is no possibility that the activity in question may have a significant effect on the environment, the activity is exempt from CEQA."

This section is based on the idea that CEQA applies jurisdictionally to activities which have the potential for causing environmental effects. Where an activity has no possibility of causing a significant effect, the activity will not be subject to CEQA. This approach has been noted with approval in a number of appellate court decisions including the State Supreme Court opinion in *No Oil, Inc. v. City of Los Angeles.*

Ordinance 688 and Rezone 2020-1 are creating new regulations that would allow the creation of single-family residential parcels pursuant to a "Small Lot Designation". This project does not permit any type of physical development without following the procedures set forth in the California Subdivision Map Act and additional CEQA review on a case-by-case basis for the land proposed for development. Therefore, creating regulations that permit the creation of smaller parcels that are consistent with the City of Corning 2014-2034 General Plan will not have a significant impact on the environment.

STAFF RECOMMENDATION:

Staff recommends the following Factual Subfindings, Legal Findings and Action for consideration by the City Council:

Factual Subfinding #1

Ordinance Number 688 and Rezone 2020-1 will establish a "Small Lot Designation" within the Corning Municipal Code. Minimum lot size of 4,000 sq. ft. for interior lots and 4,500 sq. ft. for corner lots are consistent with the 2014-2034 Corning General Plan. Creation of lots at these densities will require following the procedures set forth in the California Subdivision Map Act and additional CEQA review on a case-by-case basis.

Legal Finding #1

Creating regulations that will permit lots that are consistent with the General Plan and subject to additional CEQA review prior to creation will not have a direct or indirect impact on the environment and therefore, the adoption and approval of Ordinance 688 and Rezone 2020-1 are exempt from CEQA pursuant to Section15061 (b) (3).

Factual Subfinding #2

Creating a "Small Lot Designation" within the Corning Municipal Code will allow for the development of minimum parcels at 4,000 sq. ft. for interior lots and 4,500 sq. ft. for corner lots. These size parcels will allow for densities of approximately 10.89 units per acre.

Legal Finding #2

Table LU-1 allows for maximum densities of 14 units per acre in Single-Family Residential land use designations. Providing for parcels developed at 4,000 sq. ft. for interior lots and 4,500 sq. ft. for corner lots does not exceed the maximum densities as set forth in the General Plan therefore, Ordinance 688 and Rezone 2020-1 are both consistent with the Land Use Element of the 2014-2034 Corning General Plan.

Factual Subfinding #3

The 2014-2034 Corning General Plan contains goals throughout the plan.

Community Goal #1 states that the city should: "Preserve and enhance the quality of life by providing a variety of living environments and accommodating growth."

Land Use Goal LU-6 states: "Encourage a sense of community "village" quality and character throughout the City."

Land Use Goal LU-7 states: "Improve existing neighborhood aesthetics."

Legal Finding #3

Adoption of a Small Lot Designation within the Corning Municipal Code is consistent with community and land use goals set forth in the General Plan.

Factual Subfinding #4

On April 21, 2020 the Corning Planning Commission held a duly noticed public hearing to review and make a recommendation to the City Council regarding Ordinance 688 and Rezone 2020-1, the regulations that would create a "Small Lot Designation" within the Corning Municipal Code.

Legal Finding #4

The City of Corning Planning Commission voted 5:0 to recommend that the City Council adopt the Factual Subfindings & Legal Findings as presented in the staff report and adopt Ordinance 688, the Ordinance to implement Rezone No. 2020-1.

Height, bulk and space requirements shall be as follows: Minimum lot area 4,000 square feet, 4,500 square feet for corner lots, Minimum lot width 40 feet, 45 feet for corner lots, maximum building coverage of sixty percent of lot area with a minimum width of any residential structure of twenty feet.

- B. Minimum Lot Width 40 feet interior lots, 45 feet corner lots,

- D. Minimum front yard setback of ten feet to residence/porch and a garage must be set back to twenty feet.
- E. Side yard shall not be less than five feet with a two-foot overhang on each side. Three feet shall be added to each required side yard for each story above the first story of any building. The side yard on the street side of each corner lot shall not be less than ten feet. A twenty-foot minimum side yard shall be required where a two-story residential structure will be located on a lot which abuts the rear yard of a single-family lot,
- F. Rear yard shall not be less than ten feet,
- G. Building height limit, two and one-half stories, but not exceeding thirty-five feet,
- **H.** Main building area, the main building shall have a minimum floor area of eight hundred square feet, living space. The definition of "main building" includes a mobile home.
- I. No portion of a structure, excluding two-foot eaves shall be constructed in a Public Service or Utility Easement as depicted on a recorded map.

SUMMARY:

On May 26, 2020 the City Council adopted Resolution 05-26-2020-01 declaring a "Public Nuisance" on the one (1) property located at 1216 South Street within the City of Corning. A Public Hearing is required to accept comments/appeals by the "Nuisance Property" Owner (as listed on the attached Exhibit "A") and the property owners have been notified by certified letter, (Exhibit "B") of their opportunity to appear and appeal this action at this meeting. Following this appeal, Staff is seeking the following actions:

- Adoption of Resolution 06-09-2020-01 declaring the property located at 1216 Corning, California to be a public nuisance and the property owners to be guilty of a misdemeanor for each day such violation continues and set civil penalties of not less than two hundred fifty dollars (\$250) or more than one thousand dollars (\$1,000) for each day the violation continues;
- Authorize the Fire Chief to move forward with abatement procedures on the property declared a public nuisance; and
- Authorize the City Clerk to initiate the lien process to recoup any costs associated with the abatement process.

BACKGROUND:

Pursuant to Municipal Code Chapter 8.14, the City's Weed Abatement Officer, in this case the Fire Chief has identified three (3) remaining properties within the City Limits as being a public nuisance. The Corning Municipal Code provides the following direction relating to Weed Abatement:

Section 8.14.020: Definitions:

- (a) "Weed Abatement Officer" means the Corning Fire Chief or other public officer designated by the City Council to perform the duties imposed by this article upon the superintendent.
- (b) "Weeds" means weeds which when mature bear wingy or downy seeds, which will attain such a large growth as to become a fire menace when dry, or which are otherwise noxious or dangerous. The term "weeds", as used in this article also include any of the following:
 - 1) Weeds which bear seeds of a downy or wingy nature.
 - 2) Sagebrush, chaparral, and any other brush or weeds which attain such large growth as to become, when dry, a fire menace to adjacent improved property.
 - 3) Weeds which are otherwise noxious or dangerous.
 - 4) Poison Oak or Poison Ivy when the conditions of growth are such as to constitute a menace to the public health.
 - 5) Dry grass, stubble, brush, litter, or other flammable material which endangers the public safety by creating a fire hazard.

Section 8.14.030 Violations of Chapter: This Section stipulates that any person violating the provisions of this Section or any other provision of this Chapter shall be guilty of a misdemeanor for each day such violation continues and sets civil penalties of not less than two hundred fifty dollars (\$250) or more than one thousand dollars (\$1,000) for each day the violation continues.

(Ord. No. 2005-01 (part), 674, 6-12-2018);

Section 8.14.040 – Periodic Council Resolutions declaring nuisances: Authorizes the City Council to periodically, by Resolution, declare as public nuisances and abate:

(a) All weeds growing upon the streets, sidewalks, or private property in the City; and

(b) All rubbish, refuse and dirt upon parkways, sidewalks or private property in the City. (Ord. No. 656, § 2, 10-14-2014);

Section 8.14.170 - Council order to proceed. If objections have not been made or after the City Council has disposed of those made, it shall order the Weed Abatement Officer to abate the nuisance by having the weeds, rubbish, refuse, and dirt removed. The order shall be made by motion or resolution.

(Ord. No. 656, § 2, 10-14-2014)

Section 8.14.230 - Abatement by private contractors. Abatement of the nuisance may in the discretion of the City Council be performed by contract awarded by the City Council on the basis of competitive bids let to the lowest responsible bidder pursuant to Government Code Sections 37903, 37904, 37905 and 37931 to 37935 inclusive. In such event the Contractor shall keep the account and submit the itemized written report for each separate parcel of land.

(Ord. No. 656, § 2, 10-14-2014)

Section 8.14.240 - Special assessment process. The cost of abatement in front of or upon each parcel of land and the costs incurred by the City of Corning in enforcing abatement upon the parcels, including investigation, boundary, determination, measurement, clerical and other related costs constitutes a special assessment against that parcel.

After the assessment is made and confirmed, a lien attaches on the parcel upon recordation of the order confirming the assessment in the office of the Tehama County recorder, except that if any real property to which such lien would attach has been transferred or conveyed to a bona fide purchaser for value, or if a lien of a bona fide encumbrancer for value has been created and attaches thereon, prior to the date on which the first installment of such taxes as imposed by Government Code Section 39578 would become delinquent, then the lien which would otherwise be imposed by this section shall not attach to such real property and the costs of abatement and the costs of enforcing abatement, as confirmed, relating to such property shall be transferred to the unsecured roll for collection.

SUMMARY:

The City of Corning was awarded Active Transportation Program (ATP) funds in Cycle 4 for the West Street and Olive View School Connectivity Projects. Staff submitted a request for allocation for the first phase of funding through Caltrans to complete the Environmental Studies & Permits and the Preliminary Engineering for both projects, \$30,000 for each project. The California Transportation Commission approved this request at their March meeting. The attached Program Supplement No. U72 and U73, once executed will be returned to the City of Corning along with an approved Finance Letter that will allow the City to start spending the funds to complete the first phase of the design process for both projects.

Staff is requesting the City Council's authorization for the City Manager to sign all required documents for executing the program supplement agreements.

BACKGROUND:

The City has received grant funding in the amount of \$2.4 million for two ATP – Safe Routes to School Projects. The Olive View School Project and the West Street School Project. Both projects will consist of install new sidewalks, curbs, gutters, and crosswalks to close gaps in the existing sidewalk infrastructure adjacent to the schools. In addition to improvements adjacent to the school, the West Street School Project also includes installing a flashing pedestrian signal at the unsignalized intersection of Solano Street and Hoag Street adjacent to Les Schwab Tires.

Once the Environmental Studies & Permits and the Preliminary Engineering for both projects is complete staff will submit a request for funding allocation for Plans, Specifications and Estimates, the next phase of both projects. It is anticipated that this request for allocation will be made by the end of 2020. Construction is anticipated to be completed for both projects FY 22/23.

ITEM NO.: J-13 AUTHORIZE LETTER SEEKING INCREASED CARES ACT FUNDING NEEDED DUE TO COVID-19 FISCAL IMPACTS ON CALIFORNIA CITIES

SUMMARY:

The League of California Cities requested letters of support be provided to assist cities in dealing with the impacts of revenue losses and increase in expenditures as a result of the COVID-19 pandemic. The League of California Cities is arguing all California Cities, regardless of population, urgently need CARES Act funding to help continue to fight COVID-19 and protect residents through the summer months and beyond. No City can be left behind. Thus far, only cities with populations over 500,000 have been given financial assistance through the CARES Act.

As with many businesses, the City has been financially impacted in many ways due to local business closures and/or reduced patronage. These losses consist of Sales Tax, Transient Occupancy Tax (TOT), and Transaction and Use Tax (Measure A Funds) with an estimated overall total loss of \$800,000 in projected revenues. The City has expended unplanned funds in response to the COVID-19 Pandemic on such items as:

- a. Plexi-glass barrier at City Hall.
- b. Employee overtime related to COVID-19.
- c. Increased hand sanitizer, sanitizing spray and wipes.
- d. Handwashing Stations and Porta-Potties (2) for homeless encampments.
- e. Masks and Gloves
- f. Equipment to facilitate employees working at home such as scanners, remote access to the City server, etc.
- g. Costs associated with facilitating virtual meetings, i.e. City Council, Planning Commission, Recreation Commission, etc.

Many smaller cities similar in size to the City of Corning are in deep financial despair due to revenue losses.

RECOMMENDATION:

MAYOR AND COUNCIL AUTHORIZE A LETTER SEEKING INCREASED CARES ACT FUNDING DUE TO COVID-19 FISCAL IMPACTS ON CALIFORNIA CITIES.

Dear Assembly Member Gallagher and Senator Nielsen:

The City of Corning thanks you for your efforts to protect and support Californians during this unprecedented public health crisis. Since the beginning of the COVID-19 outbreak, cities have been coordinating across jurisdictional lines, enacting emergency measures to slow the spread of the coronavirus pandemic, taking action to protect individuals and small businesses, and incurring significant unplanned expenses to protect public health and the economy. These actions have saved lives and serve as a model for the country. But these actions come at a cost.

The City of Corning appreciates the May Revision allocation of \$450 million of the State's CARES Act funding to cover COVID-19-related costs by cities. However this is not nearly enough cover the costs that all local governments in the State are incurring to provide adequate levels of personal protective equipment to front line workers, to disinfect and sanitize public facilities, or to take other needed public health actions to facilitate the process of reopening.

We are calling on the Legislature and the Governor to increase the State's CARES Act funding allocation to cities to \$500 million and establish a floor allocation of \$50,000 per City. Cities need additional funding and a minimum allocation to ensure that CARES Act funding is distributed fairly and equitably and is a meaningful amount for all jurisdictions.

CARES Act funding will help our City recover from this pandemic faster and reopen our communities without furthering city revenue shortfalls and threatening core city services.

It is important to note that CARES Act funding is only for COVID-19-related expenses. Our City still needs direct State and Federal Funding to address the devastating impact Stay-At-Home Orders have had on our budget and local economy. In total, cities around the State are facing a nearly \$7 billion revenue shortfall over the next two years, and this shortfall grows by billions of dollars as modified Stay-At-Home Orders extend into the summer months and beyond. The City of Corning appreciates your consideration of our budget requests and looks forward to further discussing how together we can continue to best protect Californians and reopen our economy. Thank you again for your leadership and partnership during these uncertain times.

ITEM NO.: J-14 REQUEST CITY COUNCIL DIRECTION ON PROCEEDING WITH CITY POOL SEASON DUE TO COVID-19 PANDEMIC

June 9, 2020

TO: HONORABLE MAYOR AND COUNCILMEMBERS

FROM: KRISTINA MILLER, CITY MANAGER ROBIN KAMPMANN, PE; PUBLIC WORKS/ENGINEER CONSULTANT

SUMMARY:

Staff is preparing a Reopening Plan (Plan) to allow the pool to reopen for general swimming when allowed and approved by the State and County Public Health Department. At this time, we do not know when that will be but hope it may be by mid-July.

A summary of operations is as follows:

- o Adult Lap Swim lessons will be limited to only one swimmer per lane.
- o Swim Lessons will not be offered due to:
 - Inability to maintain social distancing between teacher and students
 - Inability to maintain social distancing between students
- o Public swim hours will operate as follows:
 - Patrons will be allowed to register for attendance for 1.5 2 hour time blocks 2 times per week for 4 weeks
 - Registration will be required through the City of Corning recreation software RecDesk. All registrations must be in advance, no admittance to walk-ins
 - Swimming will be restricted to 30 patrons total (no more than 10 for the small pool and no more than 10 for the big pool), or whichever limit is allowed within Stage 3.
 - Patrons will not be able to go back and forth between the big and small pool.
 - Only 1 non-swimming parent/guardian will be allowed. This person must adhere to all protective measures and social distance from other parents.
 - Games such as Shark and other tag games will not be allowed.
 - Interactions among non-household units will be discouraged
 - Locker rooms will be closed to the public. Patrons will be required to prepare to swim from home.
 - The diving board and slide will not be allowed to be used.
- o Adult Water Aerobics
 - The number of participants will be limited to 10 to ensure proper physical distance

Major changes to the facility are as follows:

- Plexiglass or other material will be placed on the guard shack window and on top of halfdoor to the office to protect both the employee and the customer from aerosols.
- Hand sanitizer dispensers (using at least 60% alcohol) installed in the pool guard shack (office), at the entryway, outside of locker rooms and bathrooms, and near the wading pool.
- Additionally, deck organization of chairs and social areas will be reconfigured to adhere to Social Distancing recommendations.
- Provided visual cues (marked distances on the ground for lines to diving boards, bathrooms, and locker rooms) and signs to ensure that staff, patrons, and swimmers stay at least 6 feet apart.

- Place signage throughout the facility at specific locations (facility entrance, near benches of the small pool and big pool, bathrooms/locker rooms) to address the following:
 - Screening criteria and questions
 - o Cloth face-covering requirements
 - Hand hygiene and covering cough/sneeze

Employee training, control measures and screening, cleaning and disinfection, physical distancing, lifeguard providing care, lifeguard performing rescues and resuscitation are also included in detail in the Plan. Please note, all of the above may need to be adjusted based on guidance from the County Public Health Officer and/or the State. Safety is of utmost concern.

Staff propose to plan for an opening date of Friday July 10th. A significant amount of work will need to be performed to get the pool operational by this date and certified by Tehama County Environmental Health. Due to a reduced number of patrons at the pool, the City will not need to hire additional lifeguards this year. The returning lifeguards will need to have a physical before returning to work. Lifeguard and CPR recertification may also need to occur for some guards. Recreation Coordinator, Christina Meeds, will also need to enter the time slots into RecDesk, which will take a considerable amount of time. I am concerned that if our "guess" of a date is wrong, we will have to issue a significant amount of refunds and have many disappointed/upset children and parents/guardians. For this reason, I chose to be safe with a proposed opening date of July 10th.

At this point, staff propose the pool remains open until school resumes on August 13th. Lifeguards currently don't know the status of their College and other schedules due to the COVID-19 pandemic. Because of this uncertainty, we cannot guarantee there will be enough lifeguards to operate the pool beyond this date. As more information is available Staff will readdress this at the direction of Council.

The State has threatened to take away funding from local jurisdictions should they defy the State's Order. For this reason, I highly recommend the City not defy the Order and open the pool earlier than allowed.

FINANCIAL:

Annually the pool runs in the red by about \$63,000. With a reduced pool season the City can expect expenditures to be reduced by roughly 40% to \$38,000. Revenue for the one-month operating period from July 10 to August 8 would be \$2,560 assuming all time slots are filled to capacity. This results in an operating loss of approximately \$36,000. If you were to extend the pool season an additional month (pending lifeguard availability), the operating loss would be an additional \$30,000, for a total operating loss of \$66,000 for the season.

RECOMMENDATION:

MAYOR AND CITY COUNCIL:

- 1. AUTHORIZE THE CITY POOL TO REOPEN WHEN APPROVED BY THE STATE; or
- 2. AUTHORIZE THE CITY POOL TO CLOSE FOR THE 2020 SUMMER SEASON; AND
