CITY MANAGER:

COVID-19 Updates:

The 6th and FINAL round of the California Relief Grant is now open for applications. If a business has already applied for a previous cycle and been put on the waitlist, they DO NOT need to re-apply. If a business started an application in a previous round, they can log-in and finish the application during the Round 6 application period. Applications are due May 4th, 2021.

Corning Restaurants financially impacted by COVID-19, don't miss your opportunity to apply for funds from the Restaurant Revitalization Fund. It is first-come first-served until the funds run out! The funds will provide restaurants with funding equal to their pandemic-related revenue loss up to \$10 million per business and no more than \$5 million per physical location. Recipients are not required to repay the funding as long as funds are used for eligible uses no later than March 11, 2023 (see: <https://www.sba.gov/funding-programs/loans/covid-19-relief-options/restaurant-revitalization-fund#section-header-2>).

Waste Reduction Recycling and Senate Bill 1383 Meeting with Waste Management

Staff from the Tehama County Solid Waste Management Agency and I met with Waste Management to discuss public education and outreach and implementation of Senate Bill 1383 (Organics Recycling) on May 6th.

PUBLIC WORKS DEPARTMENT:

Yost Park Playground Installation:

The Contractor has finished the installation but unfortunately, we are missing a few of the ropes/nets. Staff has requested replacement pieces from the manufacture and as soon as we receive the pieces the equipment will be open to the public.

City Street Striping:

As part of our annual street striping contract, Apply-A-Line will be restriping Edith Avenue between Colusa and Donovan, Solano Street from Edith to Toomes Avenue, and Marguerite to the eastern City Limits. This work is anticipated to be complete by the end of this week.

Wastewater Treatment Plant Transfer Switch Update:

The automatic transfer switch installation at the Wastewater Treatment Plant is tentatively scheduled by Patterson Electric for May 12, 2021.

Fire Season Preparation:

Due to high winds and red flag warnings the Public Works Staff has delayed the placing of fire breaks/mowing on City property to prepare for this upcoming fire season. This work will continue as the weather improves.

Part-Time Public Works Landscape and Maintenance Worker:

Applications are currently being accepted thru May 28, 2021 for the part-time Landscape and Maintenance Worker position. Applications can be found on the City website.

Street Tree Pruning – Southwest Quadrant:

West Coast Arborists has tentatively scheduled the street tree pruning within the southwest quadrant of the City to start on May 17th and go through May 28th.

POLICE DEPARTMENT:

Patrol:

In addition to responding to 190 calls for service, a total of 26 officer reports were taken and there were 106 officer-initiated incidents, including 38 traffic stops. Officers made 13 misdemeanor and 2 felony arrests. Officers issued 19 citations, of which; 10 were misdemeanors, 1 was an infraction, 2 were unclassified and 6 were parking during the period of April 28, 2021 through May 5, 2021.

Officers continue to participate in POST Portal Training and Lexipol Daily Training Bulletins. Other POST on-line training continues for Patrol and Dispatch personnel.
