A. CALL TO ORDER: 6:30 p.m.

C. BUSINESS FROM THE FLOOR:

Corning Condors President Dean Utterback addressed the Commission stating that they would like to do a Fun Fly or Swap Meet at the Airport later this summer. He also stated he would like to see a new sign listing the Airport name and date established placed at the Airport to replace the existing sign.

Commissioner Davies asked Mr. Utterback if he or other members of the Condors have seen any cows loose at the Airport; Mr. Utterback stated that he saw some on the taxiway.

D. REGULAR AGENDA:

Melodie Poisson asked if there was a plan for stocking and cleaning the Airport bathroom and emptying/dumping the Airport garbage cans; stating that they were very heavy. Public Works/Engineering Consultant Robin Kampmann informed her that the City has been purchasing supplies (toilet paper, and cleaning) and stated that she would check on this as well as the possibility of moving the Airport dumpster inside the gate. Also discussed was the frequency of dumping needs.

Public Works/Engineering Consultant Robin Kampmann announced that she has plans to remodel the Airport restrooms making them ADA compliant utilizing COVID-19 Funds if allowed under the funding criteria. This is currently being investigated and discussed by City Staff.

Commissioner Davies stated that he turned off the Airport propane tanks due to lack of need at this time. He also stated that he fixed an unnecessary light switch so that it cannot be used.

1. Approve Minutes of the January 4, 2021 Airport Commission Meeting.

Commissioner Poisson moved to approve the Minutes of the January 4, 2021 Airport Commission Meeting; Commissioner Beck seconded the motion. Ayes: Boot, Davies, Beck, and Poisson. Absent/Abstain/Opposed: None. Motion was approved by a 4-0 vote with one vacancy remaining on the Commission.

2. Discussion on Airport Gate Sign.

Chairperson Boot stated her believe that a sign with the gate code should be installed on the interior side of the gate for those flying into the Airport. Melodie Poisson and Commissioner Davies suggested utilizing the CTAF (Common Traffic Advisory Frequency) code. That was agreeable to the Commission. It was suggested that during events the gate could be propped open. Mrs. Kampmann stated the City does have the ability to change the gate code if necessary.

Commissioner Davies asked about utilizing a permit process and charging a use fee for crop dusters using the Airport and having them log in prior to use and do some type of inspection

following their use. It was suggested that the Crop Dusters would probably be willing to pay a fee and the funds could be utilized to improve the gravel areas.

3. Fiscal Year 2021 ACIP Project Update; Informational Item Only.

Public Works/Engineering Consultant Robin Kampmann stated that the City used the 2020 FAA Grant funds for the new gate and fencing installation. She announced that there currently is \$488,074 in Entitlement Funds available for use at the Airport. Mrs. Kampmann then provided the following information for the proposed 2021 Projects:

- Preparation of an Updated Airport Land Use Plan (ALP) at an estimated cost of \$333,333, with \$300,000 funded with AIP Funds and \$33,333 in City Funds;
- PMMP (Pavement Maintenance and Management Plan) completed at an estimated cost of \$35,000; and
- > Staff hopes to include within the plans above, required studies for a potential future fueling area.

Mrs. Kampmann stated that with the latest round of funding allocations, projections are that no local matching funds will be required, therefore Staff hopes to utilize as much of these funds as possible this year. She also stated that Staff is currently planning no projects in FY 2022.
