## "Corning Does It Bedder" Bed Race Rules

- ❖ Each team must have four (4) persons to a team.
- Rider must wear a helmet
- Two beds will race at a time. Teams will compete in Double Elimination.
- ❖ All beds must be decorated.
- ❖ Any size wheels are permitted.
- ❖ No breaking devices allowed.
- No steering devices allowed.
- Pushing the bed only during the race, no pulling.
- ❖ All team members need to pass the finish line with the bed to be considered a finish.
- One rider at a time, rider and one runner must swap places at the halfway point.
- ❖ Beds cannot be bigger than a twin size (6X8).
- ❖ All beds must have a mattress.
- ❖ All beds must pass tech inspection.
- ❖ All riders must sit or lay flat.
- Push bars are allowed but cannot exceed the width of the bed.
- Damage incurred or caused will be the sole responsibility of the involved team.

"The Corning Chamber of Commerce has 3 beds available for use on a first come first serve basis. The captain of the team is responsible for the borrowed bed and must return the bed to the Chamber Office."

#### **AGREEMENT. WAIVER. AND RELEASE**

This release is intended to release and discharge in advance THE CITY OF CORNING (its directors, elected officials, officers, employees, volunteers, contractors, and agents) from all liability arising out of or connected in any way with my VOLUNTARY participation in said Bed Races. It is understood that these Bed Races involves an element of risk of accidents INHERENT TO THE RECREATIONAL ACTIVITY and knowing those risks I hereby VOLUNTARILY assume those risks. It is further agreed that this Agreement, Waiver, and Release is to be binding on my heirs and assigns. I agree to indemnify and to hold the above persons or entities free and harmless from any loss, liability, damage, cost, or expense which they may incur as the result of my death or injury or property damage that I may sustain while participating in said Bed Races. I agree that if any portion of this Agreement, Waiver, and Release is held to be invalid, the balance shall remain in full force and effect.

Parental/Legal Guardian Consent: (This form must be completed and signed by a parent/guardian if applicant is under 18 years of age.) I hereby consent to my son/daughter/ward's participation in the Bed Races and as described in the flyers, correspondence, newsletters, website, text, social media, and/or e-mail and I hereby execute this Agreement, Waiver, and Release on his/her behalf. I certify and represent that said minor is in good health and physically able to participate in said Bed Races. I for myself and said minor's personal representative, assigns, heirs, and next of kin, hereby waive, release, and discharge all claims for damages for personal injury, death or property damage which I and/or said minor may have, or which may hereafter accrue, as a result of participation in said Activity. I fully understand that the Bed Races involve unknown risks and dangers and I fully accept all such rights and responsibilities for losses, costs and damages incurred because of his/her participation in the Bed Races. This release is intended to release and discharge in advance the CITY OF CORNING (its directors, elected officials, officers, employees, volunteers, contractors, and agents) from all liability arising out of or connected in any way with said minor's participation in said Bed Races. It is understood that these Bed Races involve an element of risk and danger of accidents INHERENT TO THE RECREATIONAL ACTIVITY and knowing those risks I hereby assume those risks. It is further agreed that this Agreement, Waiver, and Release is to be binding on all heirs and assigns. I hereby agree to indemnify and hold the persons and entities mentioned above free and harmless from any loss, liability, damage, cost, or expense which they may incur as a result of the death or injury or property damage that said minor may sustain while participating in said Bed Races. I agree that if any portion of this Agreement, Waiver, and Release is held to be invalid, the balance shall remain in full force and effect.
