1. Introduction of Corning Volunteer Fire Department Officers by Fire Chief Tom Tomlinson.

Chief Tomlinson introduced the new Corning Volunteer Fire Department Officers which are: 1st Assistant Chief Daymon Schlereth; 2nd Assistant Chief Jeff Nelson; Captain's Rocky Peterson, Jerod Smith, and Billy Wooten. Chief Tomlinson stated that although Councilman and Fire Department Volunteer Dave Demo has stepped down as an Officer of the department after many years of service; he still remains an active and valued member of the Volunteer Fire Department.

5. PUBLIC COMMENTS AND BUSINESS FROM THE FLOOR:

Police Chief Fears addressed the Council regarding Police Department staffing levels and budget. He stated that staffing within the Police Department has remained the same for many years with some positions remaining frozen. He further stated that over these same years, there have been within the City, an increase in new Housing Developments, Commercial businesses, Parks, etc. which all require additional service by the Police Department. He requested that the staffing level at the Department be reviewed, and consideration be given to filling some, if not all, of the frozen positions in light of the City growth and current need.

Items 10 & 11 were presented prior to Item 9 as City Auditor Don Reynolds was not yet present.

10. Annual Mid-Year Budget review and General Discussion of Fiscal Year 2021/2022.

Presented by City Manager Kristina Miller who stated that this report largely relies on information from the fiscal year mid-point, which is December 31, 2022. She stated that the Fiscal Year 2021/22 Budget projected total revenues (excluding transfers) of \$13,395,853. The General Fund Revenues (including Measure A) projected total revenues of \$7,417,609 or 55.4% of total revenues. General Fund Revenues are faring very well, to the point of almost returning to pre-pandemic levels. The City Council maintains primary discretion over how these funds are expended.

The remainder, about 44.6% (\$5,978,244 of revenues originate from sources other than General Fund revenues and must be allocated (expended) for specific purposes such as grant funded projects, or for Sewer, Water, and Street Maintenance, etc. (these are referred to as non-discretionary because the Council has little choice regarding how they are spent).

City Manager Miller presented the projected Sales Tax, emphasizing that the City is heavily reliant on sales tax from fuel sales which has been decreasing significantly in the last six years. That being said, we expect sales tax from fuel to increase as compared to previous years. Currently the City has complete sales tax data for two calendar quarters for FY 2021/22; the 2nd and 3rd quarters of 2021. Those receipts are on target for exceeding the \$3.23 million budget for the General Fund and the \$1,170,000 in Transactions and Use (Measure A) tax. She stated that the City should expect to receive approximately \$430,000 more than budgeted or \$3,660,000 for General Fund Account 4121, and Account 4090 (Measure A) is expected to come in \$180,000 higher than budgeted.

- Transient Occupancy Taxes (TOT's) are expected to come in higher at \$120,000 higher than budgeted (from \$525,000 to \$645,000).
- Vehicle license fees are projected at \$60,000 higher than expected.
- Building fees are proposed to be reduced \$30,000 to \$120,000 and plan check fees expected higher at \$5,000 to \$30,000.
- Franchise Fees (PG&E, Comcast Cable TV, and Waste Management) are expected to come in as anticipated. Property Taxes collected by the County make up about 12% of the City's General Fund and are projected to meet budget as proposed.
- Various Minor Revenue adjustments are proposed to Homeowners Exemption (Account 4515), Public Works Miscellaneous Income (Account 4540), Credit Card Processing Fee (Account 4588), and Park Lights (Account 4655) based on current receipts. These adjustments equate to a (\$1,500) decrease in revenue total.

The total of these General Fund Revenue Adjustments amounts to a projected increase by \$583,500 at year's end.

Enterprise Funds have to be used for specific purpose. The sewer funds are coming in as expected, however electrical costs are higher than expected. Water fees are also experiencing higher electrical costs. She mentioned the deficits in water and sewer delinquent debts and possible options for the City to recoup these debts.

The City is experiencing increases in overtime costs in Police and Fire Dispatch as a result of coverage for employees on quarantine/isolation orders and medical leave. The budget is proposed to be increased by \$49,000 total for Police and Fire Dispatch, as indicated in Exhibit A.

She concluded by stating the total fund balance as of June 30, 2021 is \$4,723,051 for the General Fund (including Measure A). The total fund balance projected as of June 30, 2022 is anticipated to be \$4,793,902 including the Measure A Fund. She emphasized that these fund reserves are necessary to provide stability within the City during the next economic downturn.

Mayor Snow stated that one of the adjustment costs is for the Clark Park improvements approved during the budget process and mistakenly left out of the Budget; part of the adjustment amount is to correct this.

Ms. Miller explained the depreciation process and the need for setting aside funds for building accommodation for staff growth.

Mayor Snow stated his belief that we need to start now looking at budgeting for long term staffing levels. Councilors Demo and Burnett agreed.

Councilor Demo moved to approve the proposed Budget Adjustments as depicted in Exhibit A and B and receive the Mid-Year Budget Report as presented. Councilor Hargens seconded the motion. Ayes: Snow, Demo, Burnett, Valerio, and Hargens. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

Presented by City Attorney Collin Bogener. Councilor Demo moved to adopt Resolution 02-252-2022-01, a Resolution to approve without any revisions the City of Corning Conflict of Interest Code. Councilor Burnett seconded the motion. Ayes: Snow, Demo, Burnett, Valerio, and Hargens. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

SUMMARY:

The City of Corning Police Department has been notified by the Tehama County Auditor-Controller that there is an unencumbered overage in the COPS fund in the amount of \$82,313.43. These funds are restricted to front-line law enforcement and may not be used to supplant services already budgeted.

BACKGROUND:

State law establishes in each County Treasury a Supplemental Law Enforcement Services Fund that receives an annual allocation from the State. These funds cannot be transferred to the City until the Supplemental Law Enforcement Oversight Committee certifies receipt of an approved expenditure plan, by Resolution, from the City Council. The City Council, at a public hearing, must appropriate the anticipated monies exclusively to fund front-line law enforcement services in accordance with a written request submitted by the Chief of Police.

The Corning Police Department has requested, and received approval from, the Tehama County Auditor-Controller and the Tehama County Chief Administrator on February 18, 2022, that a portion of these funds (approximately \$69,480.87) can be spent on the purchase of CCTV Security Camera System equipment at an approximate cost of \$69,480.87

In your memo dated October 19, 2021, we were informed that there is an unencumbered overage in the COPS fund for the City of Corning in the amount of \$82,331.43. We would like the Oversight Committee to consider that a portion of these monies be encumbered toward the purchase of the following:

(1) CCTV Security Camera System

City staff currently has two distinct challenges that can be addressed by a single unified solution. First, the repeated and expensive vandalism that has occurred at the city parks, coupled with the lack of staffing to provide continuous patrol necessitates new thinking, and a new solution. Surveillance/monitoring camera technology has flourished in recent years and can provide relief for overburdened Public Works and Police personnel.

Second, the Police Department has the ongoing responsibility of interviewing subjects and recording said interviews. Modern evidentiary procedures require that virtually all interviews and interrogations be recorded. A case may be won or lost based on the existence of a secure, recorded interview.

Staff is proposing a single "smart" camera solution that would address both issues. The "Parks" system would allow authorized personnel to monitor in real-time and search historical activity at the Corning Skate Park and Woodson Park. Multiple cameras will continuously monitor the security of these parks and display this information on two large monitors located in the police dispatch center. Its advanced features will allow users to "move and zoom" to a desired area of the park. It will alert city staff if activity is detected at an inappropriate time of day. It is designed to be expandable, so other parks, offices or even intersections could one day be included. Connectivity is secure and wireless, facilitated by the generosity of DM Tech, current Internet Service Provider for the City of Corning.

The "Interview" system would record interviews in both rooms at the Police Department. It will allow command staff, officers, and dispatchers to watch interviews in real time and monitor the security, safety, and well-being of anyone in these rooms. Without this technology, adequate supervision can be difficult to provide in a small department such as ours.

All controlling hardware and software will be physically located in the highly secure dispatch center at the Corning Police Department. The item under consideration is sold, installed, and maintained by Gaynor Telesystems, a local and well-known telecom vendor with a long and successful partnership with the City of Corning. The Corning Police Department requests \$69,480.87 to accomplish this goal.

ADOPT RESOLUTION 03-08-2022-02 REAUTHORIZING RESOLUTION 01-25-2022-01 PURSUANT TO AB-361 AND ALLOWING THE CITY OF CORNING CITY COUNCIL TO CONTINUE TO HOLD MEETINGS REMOTELY WITHOUT COMPLIANCE WITH THE PROVISIONS OF GOVERNMENT CODE SECTION 54953(B)(3).

SUMMARY:

On January 25, 2022, pursuant to AB-361 the City Council adopted Resolution 1-25-2022-01 authorizing remote teleconference meetings of the legislative bodies of the City of Corning pursuant to Brown Act provisions.

Assembly Bill 361 provides that, if the State of Emergency remains active for more than 30 days, a local agency must make the following findings by majority vote every 30 days to continue using the bill's exemption to the Brown Act teleconferencing rules:

- The legislative body has reconsidered the circumstances of the emergency; and
- Either of the following circumstances exist: The State of Emergency continues to directly impact the ability of members to meet safely in person, or State or local officials continue to impose or recommend social distancing measures.

The City still needs flexibility to allow teleconferencing in the event staff or members of the City Council are on quarantine or isolation orders. Not doing so, could prevent the effective administration and continuation of City business at a very busy time.

Following the California Department of Public Health's release of new indoor masking guidance, Governor Gavin Newsom, on February 28, 2022 signed an Executive Order that updates the Division of Occupational Safety and Health (Cal/OSHA) COVID-19 Emergency Temporary Standard (ETS) in keeping with the current guidance. The Order also extends the current Emergency Temporary Standard through May 5, 2022 to ensure the Occupational Safety and Health Standards Board has time to review the new guidance in anticipation of the next readoption of the ETS.

In California, starting March 1st, masks will no longer be required for unvaccinated workers indoors, consistent with the update CDPH guidance, but will be strongly recommended for all individuals in most indoor settings. Employers must still provide a face covering upon request of an employee.

BACKGROUND:

On June 11, 2021, Governor Newsom issued Executive Order N-08-21, which among other things rescinded his prior Executive Order N-29-20 and set a date of October 1, 2021, for public agencies to transition back to public meetings held in full compliance with the Brown Act.

Recently, the legislature has taken action to extend the COVID-19 exceptions to the Brown Acts' teleconference requirements, subject to some additional safeguards. AB 361 allows a

local agency to use teleconferencing in any of the following circumstances without complying with the Brown Act provisions:

- The legislative body holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing.
- The legislative body holds a meeting during a proclaimed state of emergency for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.
- The legislative body holds a meeting during a proclaimed state of emergency and has determined, by majority vote that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

A local agency that holds a meeting under these circumstances would be required by AB 361 to follow the steps listed below, in addition to giving notice of the meeting and posting agendas as required under the Brown act. These additional requirements are intended to protect the public's right to participate in the meetings of local agency legislative bodies. Pursuant to AB 361 local agencies are required to do all of the following in addition to meeting notice requirements under the Brown Act:

- Allow the public to access the meeting and require that the agenda provide an opportunity for the public to directly address the legislative body pursuant to the Brown Act's other teleconferencing provisions.
- In each instance when the local agency provides notice of the teleconferenced meeting or posts its agenda, give notice for how the public can access the meeting and provide public comment.
- Identify and include in the agenda an opportunity for all persons to attend via a call-in or an internet-based service option; the legislative body needs not provide a physical location for the public to attend or provide comments.
- Conduct teleconference meetings in a manner that protects the statutory and constitutional rights of the public.
- Stop the meeting until public access is restored in the event of a service disruption that
 either prevents the local agency from broadcasting the meeting to the public using the
 call-in or internet-based service option or is within the local agency's control and
 prevents the public from submitting public comments (any actions taken during such a
 service disruption can be challenged under the Brown Act's existing challenge
 provisions).
- Not require comments be submitted in advance (though the legislative body may provide that as an option) and provide the opportunity to comment in real time.
- Provide adequate time for public comment, either by establishing a timed public comment period or by allowing a reasonable amount of time to comment.
- If the legislative body uses a third-party website or platform to host the teleconference, and the third-party service requires users to register to participate, the legislative body must provide adequate time during the comment period for users to register and may not close the registration comment period until the comment period has elapsed.

The above rules will need to be adhered to by the City of Corning if the Resolution is adopted.

AB 361 also provides that, if the state of emergency remains active for more than 30 days, a local agency must make the following findings by majority vote every 30 days to continue using the bill's exemption to the Brown Act teleconferencing rules:

The legislative body has reconsidered the circumstances of the emergency; and

• Either of the following circumstances exist: The state of emergency continues to directly impact the ability of members to meet safely in person, or State or local officials continue to impose or recommend social distancing measures.

The goal of AB 361 is "to improve and enhance public access to local agency meetings during the COVID-19 pandemic and future applicable emergencies, by allowing broader access through teleconferencing options" consistent with Executive Order N-29-20. The bill contains an urgency clause, which became effective upon signing with a sunset of January 1, 2024.

RECOMMENDATION:

MAYOR AND CITY COUNCIL:

- Reconsider the State of Emergency and find that the State of Emergency continues to directly impact the ability of council members and staff to meet safely in person when on quarantine or isolation orders; and
- Reauthorize Resolution No. 01-25-2022-01 pursuant to AB 361 allowing the City of Corning City Council to continue to hold meetings remotely without Compliance with the Provisions of Government Code Section 54953(b)(3).

A RESOLUTION OF THE CITY OF CORNING REAUTHORIZING RESOLUTION NO. 01-25-2022-01 PURSUANT TO AB 361 AND AS A RESULT OF A LOCAL EMERGENCY, AND AUTHORIZING REMOTE TELECONFERENCE MEETINGS OF THE LEGISLATIVE BODIES OF THE CITY OF CORNING PURSUANT TO BROWN ACT PROVISIONS.

WHEREAS, the City of Corning is committed to preserving and nurturing public access and participation in meetings of the City Council; and

WHEREAS, the Brown Act, Government Code section 54953(e), makes provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions; and

WHEREAS, a required condition is that a State of Emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558; and

WHEREAS, on March 4, 2020, the Governor proclaimed pursuant to his authority under the California Emergency Services Act, California Government Code section 8625, that a State of Emergency exists with regard to a novel coronavirus (a disease now known as COVID-19); and

WHEREAS, on June 4, 2021, the Governor clarified that the "reopening" of California on June 15, 2021 did not include any change to the proclaimed State of Emergency, or the powers exercised thereunder; and

WHEREAS, as of the date of this Resolution, neither the Governor nor the Legislature have exercised their respective powers pursuant to California Government Code section 8629 to lift the state of emergency either by Proclamation or by concurrent Resolution in the State Legislature; and

WHEREAS, the continued local rates of transmission of the virus and variants causing COVID-19 are such that meeting in person would present imminent risks to the health or safety of attendees of public meetings;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CORNING HEREBY RESOLVE AS FOLLOWS:

Section 1. Recitals. The Recitals set forth above are true and correct and are incorporated into this Resolution by this reference.

Section 2. Proclamation of Local Emergency. The City Council hereby proclaims that a local emergency now exists throughout the City, and social distancing orders are currently in place and needed to protect the health and safety of the citizens.

Section 3. Remote Teleconference Meetings. The staff and legislative bodies of the City of Corning are hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution including, conducting open and public meetings in accordance with Government Code section 54953(e) and other applicable provisions of the Brown Act.

Section 4. Effective Date of Resolution. This Resolution shall take effect immediately upon its adoption and shall be effective until the earlier of thirty (30) days from adoption of the Resolution or such time the City Council adopts a subsequent Resolution in accordance with Government Code section 54953(e)(3) to extend the time during which the legislative bodies of the City Council may continue to teleconference without compliance with paragraph (3) of subdivision (b) of section 54953.

ORDINANCE NO. 697; AN ORDINANCE OF THE CITY OF CORNING ADDING CHAPTER 15.35, VEHICLE CHARGING STATIONS TO THE CORNING MUNICIPAL CODE. (Introduction & First Reading)

SUMMARY:

The proposed Ordinance is in response to State legislative changes regarding Electric Vehicle Charging Stations that the State of California now requires by all jurisdictions.

BACKGROUND:

Existing law requires a City, County, or City and County to administratively approve an application to install an Electric Vehicle Charging Station through the issuance of a Building Permit or similar nondiscretionary Permit subject to a limited review by the Building Official of that City, County, or City and County. Existing law allows the Building Official to require the Applicant to apply for a Use Permit if the Official finds that the Station could have a specific adverse impact upon the public health or safety and prohibits the City, County, or City and County from denying the application for a Use Permit to install an Electric Vehicle Charging Station unless it makes written findings that the proposed installation would have a specific, adverse impact upon the public health or safety, and there is no feasible method to satisfactorily mitigate or avoid the specific, adverse impact.

Recently adopted Assembly Bill 970 requires an application to install an Electric Vehicle Charging Station to be deemed complete if, either 5 business days or 10 business days after the application was submitted (depending on the number of electric vehicle charging stations proposed in the application) the City, County, or City and County has not deemed the application to be incomplete or issued a written correction notice detailing all deficiencies in the application, as specified. The Bill requires an application to install an Electric Vehicle Charging Station to be deemed approved if 20 business days or 40 business days after the application was deemed complete, depending on the number of electric vehicle charging stations proposed in the application, (1) the City, County, or City and County has not approved the application, (2) the Building Official has not made a finding that the proposed installation could have an adverse impact upon the public health or safety or required the Applicant to apply for a Use Permit, (3) the Building Official has not denied the Permit, and (4) an appeal has not been made to the Planning Commission of the City, County, or City and County, as specified. The Bill provides that these requirements do not expand or restrict the role or responsibility of a local publicly owned electric utility in providing new electric service to an Electric Vehicle Charging Station in a manner consistent with safety, reliability, and engineering requirements. The Bill requires a City, County, or City and County to reduce the number of required parking spaces to accommodate the Electric Vehicle Charging Station, as specified.

This Bill's provisions became operative on January 1, 2022, but for every City, County, or City and County with a population of less than 200,000 residents, the Bill's provisions would apply beginning on January 1, 2023.

The Bill includes findings that changes proposed by this Bill address a matter of statewide concern rather than a municipal affair and, therefore, apply to all cities, including charter cities.

In developing an expedited permitting process, the Bill requires the adoption of a checklist of all electric vehicle charging station requirements and to have the checklist published on a publicly accessible internet website that belongs to the City.

The City of Corning is considering adopting proposed Ordinance No. 697 which would add Chapter 15.35 Electric Vehicle Charging Stations to Title 15 of the Corning Municipal Code. Adoption of proposed Ordinance 697 would also add a "Checklist" to the City's website that will allow for the expedited process of establishing an Electric Vehicle Charging Station.

GENERAL PLAN:

The 2014-2034 Corning General Plan contains goals throughout the Plan. Proposed Ordinance 697 is consistent with the City's General Plan's Sustainability and Resource Conservation Element as it encourages the use of electric vehicles.

ENVIRONMENTAL:

Proposed Ordinance 697 is exempt from review under the California Environmental Quality Act (CEQA), Guidelines Section 15061(b) (3) because it can be seen with certainty that it will have no significant negative effect on the environment.

RECOMMENDATION:

- MOVE TO INTRODUCE FOR FIRST READING, ORDINANCE NO. 697, AN ORDINANCE OF THE CITY OF CORNING ADDING CHAPTER 15.35, VEHICLE CHARGING STATIONS AND THE ASSOCIATED REQUIRED CHECKLIST TO THE CORNING MUNICIPAL CODE AND AUTHORIZE STAFF TO MAKE CHANGES AS REQIRED BY STATE LAW FROM TIME TO TIME.

CITY OF CORNING ORDINANCE NO. 697

AN ORDINANCE OF THE CITY OF CORNING ADDING CHAPTER 15.35 "ELECTRIC VEHICLE CHARGING STATIONS" TO PROVIDE EXPEDITED PERMITTING PROCESS CONSISTENT WITH STATE LAW

WHEREAS, the City of Corning seeks to comply with State Law, Assembly Bill 1236 (Gov. Code, § 65850.7), through adoption of Corning Municipal Code section 15.35, which provides for the creation of an expedited, streamlined permitting process for electric vehicle charging systems; and

WHEREAS, the Ordinance is consistent with the City's General Plan, Sustainability and Resource Conservation Element, as it encourages the use of electric vehicles; and

WHEREAS, the Ordinance is in the interest of the public health, welfare, and safety of the City of Corning as it assures the effective and streamlined approval of electric vehicle charging stations, which will encourage the use of less-polluting electric vehicles; and

WHEREAS, the Ordinance is exempt from review under the Environmental Quality Act, Guidelines section 15061(b)(3) because it can be seen with certainty that it will have no significant negative effect on the environment; and

WHEREAS, on March 8, 2022, the City Council conducted a public hearing on the proposed Ordinance.

NOW, THEREFORE, the City Council of the City of Corning does ordain as follows:

SECTION 1. Chapter 15.35 "ELECTRIC VEHICLE CHARGING STATIONS" is hereby added to Title 15, "BUILDING AND CONSTRUCTION" as follows:

Chapter 15.45 - ELECTRIC VEHICLE CHARGING STATIONS 15.45.010 - Definitions.

The following words and phrases, whenever used in this article, shall be construed as hereafter set out, unless it shall be apparent from the context that they have a different meaning:

"A feasible method to satisfactorily mitigate or avoid the specific, adverse impact" includes, but is not limited to, any cost-effective method, condition, or mitigation imposed by a City or City on another similarly situated application in a prior successful application for a permit.

"Building Official" means the city's senior Building Inspector or his or her designee.

"Electric Vehicle Charging Station" means any level of electric vehicle supply equipment station that is designed and built in compliance with Article 625 of the California Electrical Code, as it reads on the effective date of this section, and delivers electricity from a source outside an electric vehicle into a plug-in electric vehicle.

"Electronic submittal" means the utilization of one or more of the following:

- 1. Email.
- 2. The internet.
- 3. Facsimile.

"Specific, adverse impact" means a significant, quantifiable, direct, and unavoidable impact, based on objective, identified, and written public health or safety standers, policies, or conditions as they existed on the date the application was deemed complete.

15.45.020 - Purpose.

The purpose of this chapter is to promote and encourage the use of electric vehicles by creating an expedited, streamlined permitting process for electric vehicle charging stations while promoting public health and safety and preventing specific adverse impacts in the installation and use of such charging stations. This chapter is also purposed to comply with California Government Code Section 65850.7.

15.45.030 - Building Permit required.

A Building Permit is required to install an Electric Vehicle Charging Station. An application for a Building Permit to install an Electric Vehicle Charging Station shall be processed in accordance with Section 65850.7 of the Government Code.

15.03.040 - Review of applications.

Corning is adopting this chapter in order to create an expedited, streamlined permitting process for Electric Vehicle Charging Stations.

- A. To facilitate an expedited permitting process, the Building Official is hereby authorized and directed to develop and adopt a checklist of all requirements with which electric vehicle charging stations shall comply to be eligible for expedited review.
- B. The expedited, streamlined permitting process and checklist may refer to the recommendations contained in the most current version of the "Plug-In Electric Vehicle Infrastructure Permitting Checklist" of the "Zero-Emission Vehicles in California: Community Readiness Guidebook" as published by the Governor's Office of Planning and Research. The checklist shall be published on the City of Corning internet website.
- C. Prior to submitting an application, the Applicant shall verify that the installation of an Electric Vehicle Charging Station will not have a specific, adverse impact to public health and safety and building occupants. Verification by the Applicant includes, but is not limited to: Electrical system capacity and loads; electrical system wiring, bonding, and overcurrent protection; building infrastructure affected by electric vehicle charging station equipment and associated conduits; and areas of electric vehicle charging station equipment and vehicle parking.
- **D.** An application under this section may be submitted by personal, mailed, or electronic (including electronic signatures on all forms, applications, and other documentation) submittal together with any required permit processing and inspection fees.
- E. An application that satisfies the requirements in the checklist, as determined by the Building Official, shall be deemed complete. Upon receipt of an incomplete application, the Building Official shall issue a written correction notice detailing all deficiencies in the application and any additional information required to be eligible for expedited permit issuance.
- F. Upon confirmation by the Building Official of the application and supporting documentation being complete, meeting the requirements of the checklist, and being consistent with all applicable laws and health and safety standards, the Building Official shall administratively approve the application and issue all required permits or

authorizations. Such approval does not authorize an Applicant to energize or utilize the Electric Vehicle Charging Station until all required inspections have been finaled by the City of Corning. Such approval also does not authorize an Applicant to connect the Electric Vehicle Charging Station to the local utility provider's electricity grid. The Applicant is responsible for obtaining such approval or permission from the local utility provider.

- G. An Electric Vehicle Charging Station shall meet all applicable health and safety standards and requirements imposed by State and City permitting authorities and shall meet all applicable safety and performance standards established by the 2016 California Electrical Code, the Society of Automotive Engineers, the National Electrical Manufacturers Association, and accredited testing laboratories such as Underwriters Laboratories and, where applicable, the rules of the Public Utilities Commission regarding safety and reliability.
- H. Any conditions imposed on an application to install an Electric Vehicle Charging Station shall be designed to mitigate the specific, adverse impact upon the public health or safety at the lowest cost possible. The Building Official shall not condition the approval of any Electric Vehicle Charging Station Permit on the approval of such a system by an association, as that term is defined by Civil Code Section 4080.
- I. If the Building Official makes a finding, based on substantial evidence, that the Electric Vehicle Charging Station could have a specific, adverse impact upon the public health or safety, the Applicant shall be required to apply for a Conditional Use Permit. The decision of the Building Official that the Electric Vehicle Charging Station could have a specific, adverse impact upon the public health or safety may be appealed to the Planning Commission.
- J. When making a decision on a Conditional Use Permit for an Electric Vehicle Charging Station, the Planning Commission, as well as the City Council on appeal, may not deny the Conditional Use Permit to install an Electric Vehicle Charging Station unless it makes written findings based upon substantial evidence in the record that the proposed installation would have a specific, adverse impact upon the public health or safety, and there is no feasible method to satisfactorily mitigate or avoid the specific, adverse impact. The findings shall include the basis for the rejection of potential feasible alternatives of preventing the adverse impact.

15.45.050 - Inspections.

- **A.** Inspections shall be required and performed by the building division for electric vehicle charging stations.
- **B.** The inspections shall be done in an efficient inspection process, in a timely manner, and should include consolidated inspections when applicable; inspection measures taken should be consistent with safety requirements that ensure that the electric vehicle charging stations are properly installed.
- C. If electric vehicle charging stations fail inspections, a subsequent inspection is authorized but need not conform to the requirements of this chapter.

SECTION 3. Severability.

If any section, subsection, phrase, or clause of this Ordinance is for any reason held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this Ordinance. The City Council hereby declares that it would have passed this Ordinance and each section, subsection, phrase, or clause thereof irrespective of the fact that any one or more sections, subsections, phrases, or clauses be declared unconstitutional.

SECTION 5. Publication and effective date.

This Ordinance shall be published in accordance with the provisions of Government Code section 36933.

This Ordinance shall take effect 30 days after its final passage.

The City Clerk shall certify to the adoption of this Ordinance and shall cause it to be posted and/or published in accordance with the law.

SUMMARY OF AN ORDINANCE OF THE CITY OF CORNING ADDING CHAPTER 15.35 "ELECTRIC VEHICLE CHARGING STATIONS" TO PROVIDE EXPEDITED PERMITTING PROCESS CONSISTENT WITH STATE LAW

Pursuant to Government Code Section 36933(c), the following constitutes a summary of Ordinance No. 697 introduced by the Corning City Council on March 8, 2022 and scheduled for consideration of adoption on March 22, 2022 at its meeting held in the City Council Chambers at 794 Third Street, Corning, California.

The City of Corning seeks to comply with State Law, Assembly Bill 1236 (Gov. Code, § 65850.7), through adoption of Corning Municipal Code section 15.45, which provides for the creation of an expedited, streamlined permitting process for electric vehicle charging systems. The Ordinance is in the interest of the public health, welfare, and safety of the City of Corning as it assures the effective and streamlined approval of electric vehicle charging stations, which will encourage the use of less-polluting electric vehicles.

This Ordinance shall be in full force and effective thirty (30) days after its adoption and shall be published and posted as required by law.
