SUMMARY:

At the April 6, 2022 Library Commission Meeting, the Commission approved a recommendation to the Corning City Council to approve the purchase of furniture suggested by the County Librarian from DEMCO at a total cost of \$33,226.83. The purchase is to be funded from the Ridell Trust and the furniture colors are to be determined by the Library Commission.

The City Council approved this purchase at the April 12, 2022 City Council meeting.

BACKGROUND:

Following discussion/direction provided at a previous Library Commission Meeting, County Librarian Todd Deck created a list of proposed furniture to be purchased to replace the broken/obsolete existing furniture at the Corning Library. The Commission concurred that the proposed furniture, with colors to be determined, is needed at the Corning Library. The total cost for these items including tax and shipping is \$33,226.83.

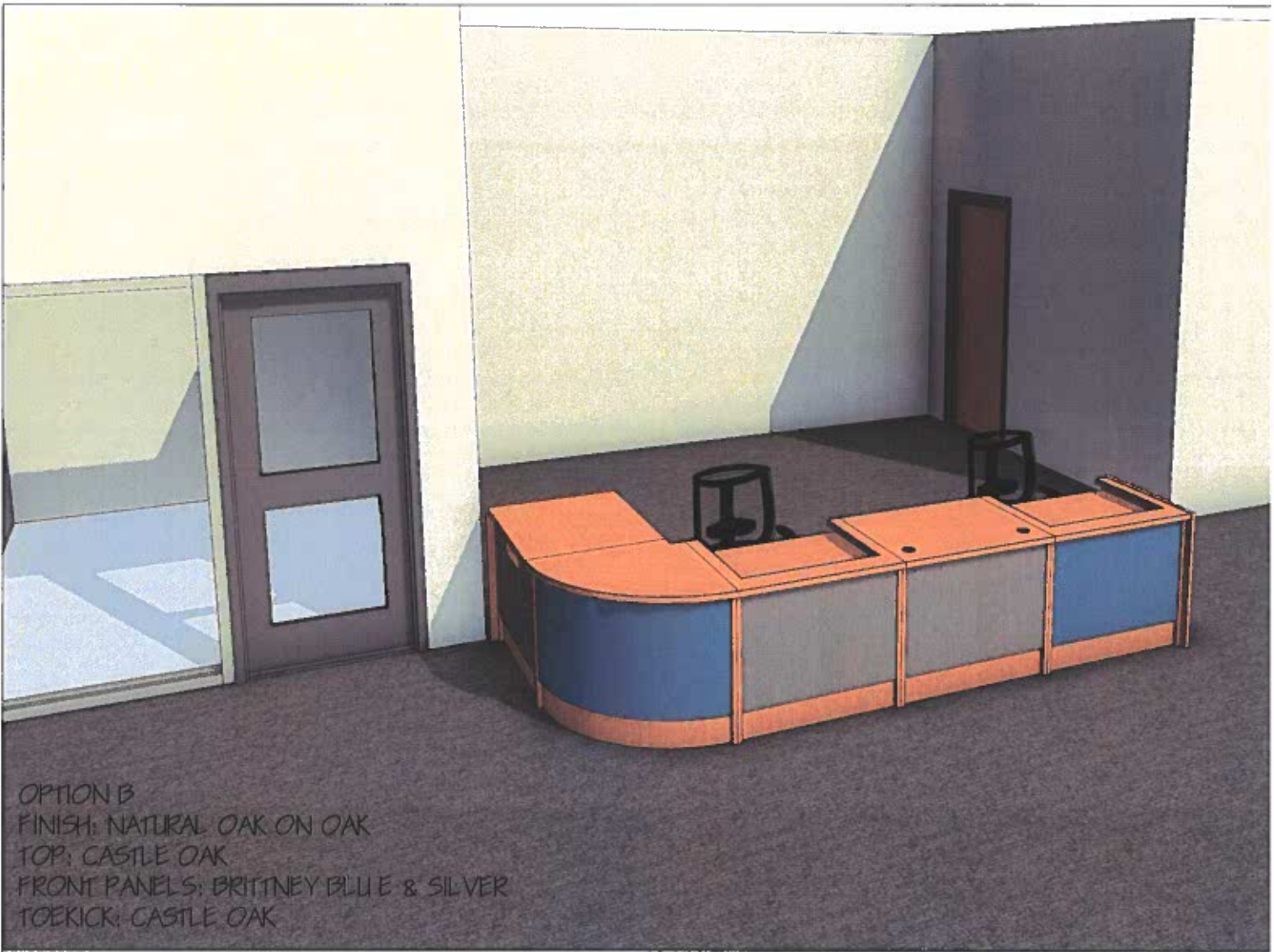

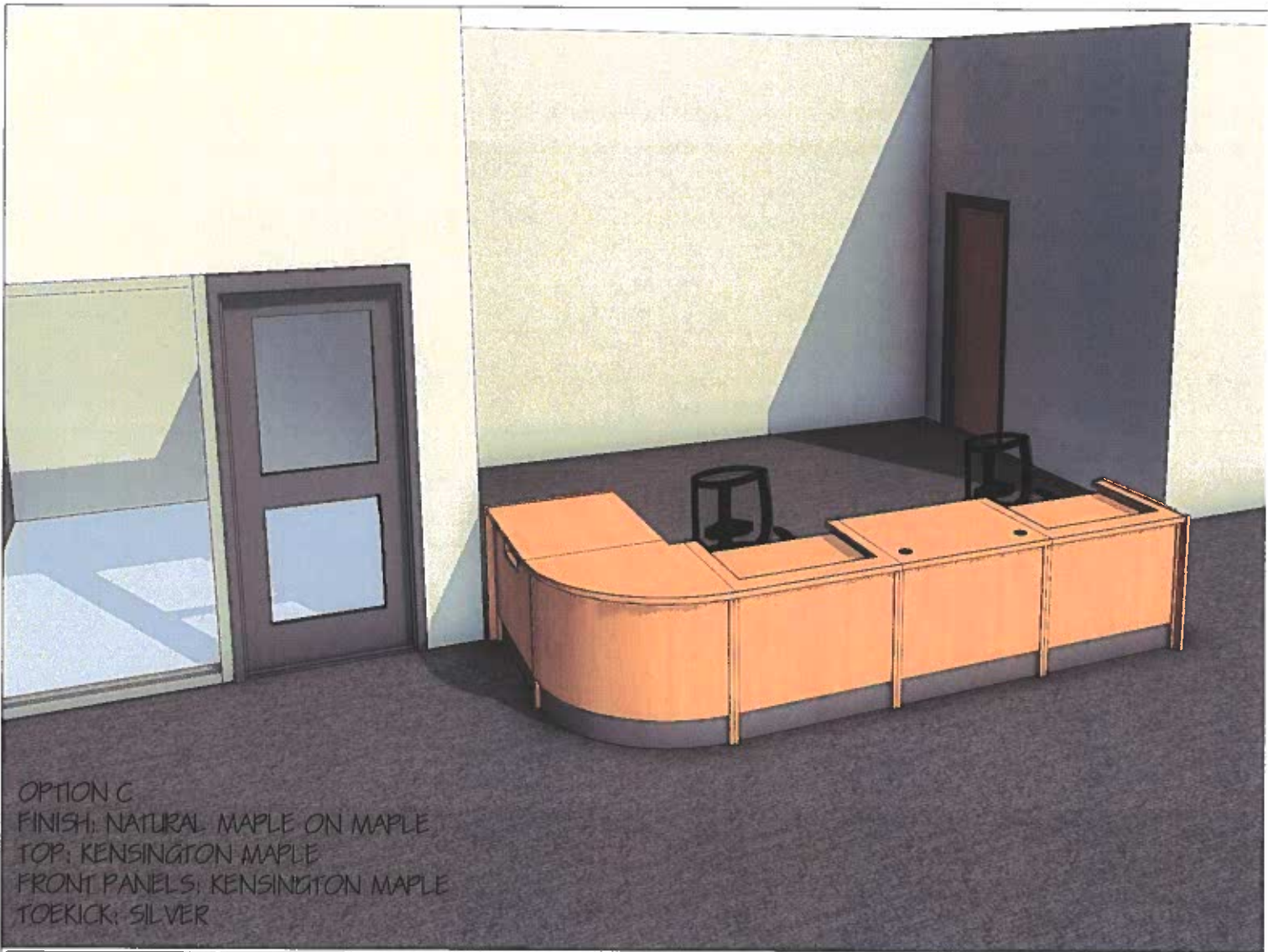
