Julie Johnson stated that adjacent to I-5 northbound there is a homeless camp behind Reilly's Muffler. Chief Fears announced that the Corning Police Department and City Public Works have addressed this issue on a number of occasions.

Brooke Smith thanked City Public Works for changing the locks at the Corning Senior Center.

Councilor Valerio moved to approve Consent Items 1-11; Councilor Hargens seconded the motion. Ayes: Snow, Demo, Valerio, Hargens, and Lomeli. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

- I. PUBLIC HEARINGS AND MEETINGS:
  - 12. Public Hearing: Adopt Resolution 06-27-2023-02, a Resolution of the City of Corning Authorizing the Adoption of the City of Corning Water Shortage Contingency Plan.

Presented by City Public Works Consultant/City Engineer Robin Kampmann who stated in September 2021 Senate Bill 552 (SB 552) was signed by Governor Newsom and enacted into law and includes new responsibilities/requirements at both the State and local level to help small water suppliers and rural communities reduce their risk of inadequate water supply amid a water shortage event. Senate Bill 552 (2021) also requires small water suppliers serving 1,000 to 2,999 service connections to develop a water shortage contingency plan per CA Water Code

section 10609.60. The Water Shortage Contingency Plans are required to be completed by July 1, 2023, posted on the water supplier's website, and available to the State Water Board and public upon request. The Plans must be updated every 5 years.

She stated that the attached Water Shortage Contingency Plan was prepared for the City of Corning utilizing the template provided by the California Water Board. The Plan will regulate or prohibit water use that is considered to be non-essential during a period of determined drought conditions. The proposed Water Shortage Contingency Plan is consistent with CA Water Code section 10609.60 and will replace Municipal Code Section 13.14. The Public Hearing was opened at 6:37 pm; with no comments the public hearing was closed at 6:37pm.

Councilor Demo moved, having conducted the Public Hearing, and receiving no protests; moved to adopt Resolution 06-27-2023-02 authorizing the adoption of the City of Corning Water Shortage Contingency Plan; Councilor Valerio seconded the motion. Ayes: Snow, Demo, Valerio, Hargens, and Lomeli. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

13. Approve for first reading, Ordinance 704, an Ordinance repealing Section 13.14 of the Corning Municipal Code to ensure compliance with the California Water Code Section 10609.60.

Presented by City Attorney Collin Bogener who stated that Ordinance 704 is being presented for 1<sup>st</sup> reading tonight and is associated with the changes required under Senate Bill 552 (SB552) discussed under the previous Public Hearing. He confirmed that any future changes will be made by Resolution.

Councilor Hargens moved to adopt for 1<sup>st</sup> reading Ordinance 704 repealing Section 13.14 of the Corning Municipal Code to ensure compliance with the California Water Code Section 10609.60. Councilor Valerio seconded the motion. Ayes: Snow, Demo, Valerio, Hargens, and Lomeli. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

#### J. REGULAR AGENDA:

14. Reject the two (2) Request for Proposals (RFP's) received for the Corning Library Design & Space Planning due to adequate funding not available.

Presented by City Public Works Consultant/City Engineer Robin Kampmann who stated that the Library Commission, upon review of the two (2) proposals received, one from COAR in the amount of \$71,870, and the other from LPAS in the amount of \$85,517, both of which do not include construction or materials, recommended rejecting the proposals due to adequate funding not being available. The Commission have instead appointed an Ad Hoc Committee consisting of two members of the Commission and the County Librarian (or County Librarian's selected representative) to prepare a listing of suggested Library Improvements for review and prioritization to be submitted for authorization by the City Council at a future meeting.

Councilor Demo moved that Mayor and Council approve the Library Commission recommendation and reject the two (2) Request for Proposals (RFP's) received for the Corning Library Design & Space Planning due to adequate funding not available. Councilor Hargens seconded the motion. Ayes: Snow, Demo, Valerio, Hargens, and Lomeli. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

15. Approve Agreement with DigitalPath, Inc. for tower lease space at the Corporation Yard located at the 1106 Butte Street water tower site.

Presented by City Public Works Consultant/City Engineer Robin Kampmann who stated that City Staff have negotiated a new Agreement with DigitalPath, Inc. to lease premises at 1106 Butte Street (City Corporation Yard) for its equipment, personal property, and improvements associated with Tenants internet business. This proposed Agreement will allow the existing DigitalPath antennas to remain on the water tower located at this site, as well as allow the premises to be used for the construction, installation, operation, maintenance, repair, additions, modification expansion, enhancement, upgrading, removal, relation, or relocation, or replacement of any and all Antenna Facilities with City Council approval. A summary of the new Agreement is provided below:

Rent of \$975 per month and with each successive renewal term increase by three (3%) percent each year. Should the Tenant desire to place additional antennas of the same kind on the structure beyond what is listed in Exhibit A, the Tenant agrees to receive approval from the City and adjust rent upwards by Fifty Dollars (\$50.00) per additional antenna per month.

- Initial Term of the Lease shall be five (5) years commencing on the date of Tenant's exercise of the Option (the Commencement Date) and ending on the day immediately preceding the fifth (5<sup>th</sup>) anniversary of the Commencement Date (Initial Term). The Initial Term shall automatically renew for two (2) successive renewal terms of five (5) years provided that Tenant may elect not to renew by providing notice in writing prior to the expiration of the then current term.
- The tenant shall maintain Commercial General Liability Insurance in amounts of \$2,000,000 per occurrence and \$4,000,000 aggregate.

The proposed Agreement would provide the City \$11,700 annually, and with each successive renewal term increase by three (3%) percent each year. Should the Tenant desire to place additional antennas of the same kind on the structure beyond what is listed in Exhibit A, the Tenant agrees to receive approval from the City and adjust rent upwards by Fifty Dollars (\$50.00) per additional antenna per month.

Councilor Hargens moved for Mayor and Council to approve the proposed Agreement with DigitaPath Inc. as presented and authorize the Mayor to sign the Agreement. Councilor Valerio seconded the motion. Ayes: Snow, Demo, Valerio, Hargens, and Lomeli. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

#### 16. Award Bid for the West Street School Connectivity Project to Builder Solutions, Inc. in the amount of \$575,977.02 and authorize Staff to execute the Contract.

Presented by City Public Works Consultant/City Engineer Robin Kampmann who stated that Staff received two (2) Formal Bids on Wednesday, June 21, 2023, for the West Street Connectivity Project. The project consists of removal and replacement of concrete curb ramps adjacent to and surrounding West Street Elementary School and installation of new sidewalk. Various other items of work include removing and replacing portions of the surround road, removing and replacing drainage inlets, installing new signage, improving pavement markings, installing new traffic striping, and other incidental work to be completed within the limits of work shown on the Project Plans.

Mrs. Kampmann stated that Staff is seeking authorization to award the project to Builder Solutions, Inc., who has been determined to be the lowest responsive and responsible bidder. Funding is provided form the ATP Grant awarded to the City for the West Street School Connectivity Project in the amount of \$1,304,000.00 to prepare plans, and to construct new sidewalks, curbs, gutters, and crosswalks to close gaps in the existing sidewalk infrastructure adjacent to the school. The grant funding awarded for the construction portion of the project is \$1,009,000.00. The funding is located in account 9007-118-7710.

Councilor Demo moved for Mayor and Council to Award the Bid for the West Street School Connectivity Project to Builder Solutions, Inc. in the amount of \$575,977.02 and authorize Staff to execute the Contract. Councilor Valerio seconded the motion. Ayes: Snow, Demo, Valerio, Hargens, and Lomeli. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

#### 17. Award Bid for the Olive View School Connectivity Project to Builder Solutions, Inc. in the amount of \$534.530.98 and authorize Staff to execute the Contract.

Presented by City Public Works Consultant/City Engineer Robin Kampmann who stated that Staff received four (4) Formal Bids on Wednesday, June 21, 2023 for the Olive View Connectivity Project. The project consists of removal and replacement of concrete curb ramps adjacent to and surrounding Olive View Elementary School and installation of new sidewalk. Various other items of work include removing and replacing portions of the surrounding road, removing and replacing drainage inlets, installing new signage, improving pavement markings, installing new

traffic striping, and other incidental work to be completed within the limits of work shown on the Project Plans.

Staff is seeking authorization to award the project to Builder Solutions, Inc., who has been determined to be the lowest responsive and responsible bidder at \$534,530.98. Funding will be from the ATP Grant awarded to the City for the Olive View Elementary School Connectivity Project in the amount of \$1,118,000 for plans, and to construct new sidewalks, curbs, gutters, and crosswalks to close gaps in the existing sidewalk infrastructure adjacent to the school. The construction portion of the awarded grant for the project is \$850,000.

Councilor Valerio moved for Mayor and Council to Award the Bid for the Olive View School Connectivity Project to Builder Solutions, Inc. in the amount of \$534,530.98 and authorize Staff to execute the Contract. Mayor Snow seconded the motion. Ayes: Snow, Demo, Valerio, Hargens, and Lomeli. Absent/Abstain/Opposed: None. Motion was approved by a 5-0 vote.

ORDINANCE NO. 704 REPEALING SECTION 13.14 OF THE CORNING MUNICIPAL CODE TO ENSURE COMPLIANCE WITH CALIFORNIA WATER CODE SECTION 10609.60. (Second Reading & Adoption)

#### **BACKGROUND:**

In September 2021, Senate Bill 552 (SB 552) was signed by Governor Newsom and enacted into law. SB 552 includes new responsibilities and requirements at both the State and local level to help small water suppliers and rural communities reduce their risk of inadequate water supply amid a water shortage event.

Senate Bill 552 (2021) requires small water suppliers serving 1,000 to 2,999 service connections and nontransient noncommunity (NTNC) schools to develop a Water Shortage Contingency Plan per CA Water Code section 10609.60. The required Water Shortage Contingency Plan is an abridged version of the urban water management plans mandated for completion by urban water suppliers every 5 years.

Water Shortage Contingency Plans are required to be completed by July 1, 2023, posted on the water supplier's website, and available to the State Water Board and public upon request. The Plans must be updated every 5 years.

At this meeting, the City Council will be adopting a Water Shortage Contingency Plan consistent with Water Code section 10609.60. However, this Plan is inconsistent with Chapter 13.14 of the Corning Municipal Code, titled "Proposed Water Conservation Program." That Chapter was adopted in 1994 and is no longer in step with California law. To ensure that no conflicts exist between the Municipal Code and State law, staff proposes that Chapter 13.14 be repealed in its entirety.

A repeal of an Ordinance is similar to enactment of an Ordinance, requiring two readings, with the repeal going into effect 30-days after the second reading. If adopted this Ordinance will repeal previous Ordinances 545 and 660. The introduction and first reading of the proposed Ordinance was at the June 27, 2023 City Council meeting. The Ordinance is being presented tonight for the second reading and adoption.

#### ORDINANCE NO. 704

## AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CORNING REPEALING SECTION 13.14 OF THE CORNING MUNICIPAL CODE IN ITS ENTIRETY TO ENSURE COMPLIANCE WITH STATE LAW

WHEREAS, the State Legislature recently enacted Water Code section 10609.60 which requires small water suppliers serving 1,000 to 2,999 service connections to develop and maintain a Water Shortage Contingency Plan for drought planning purposes by July 1, 2023; and

WHEREAS, The City of Corning ("City") has prepared and adopted a Water Shortage Contingency Plan consistent with the requirements of Water Code Section 10809.60; and

WHEREAS, Section 13.14 of the Corning Municipal Code, adopted in 1994, contains provisions inconsistent with the Water Shortage Contingency Plan and State Law; and

WHEREAS, the City Council of the City of Corning seeks to repeal section 13.14 in its entirety to ensure there are no inconsistencies between the Municipal Code and the Water Shortage Contingency Plan.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF CORNING DOES ORDAIN AS FOLLOWS:

Section 1. The City Council repeals Section 13.14 of the Corning Municipal Code in its entirety.

**Section 2. Severability.** If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, is for any reason held to be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity or enforceability of the remaining sections, subsections, subdivisions, paragraphs, sentences, clauses or phrases of this Ordinance, or its application to any person or circumstance. The City Council of the City of Corning hereby declares that it would have adopted each section, subsection subdivision paragraph, sentence, clause, or phrase hereof, irrespective of the fact that any one or more other sections, subsections subdivisions paragraphs, sentences, clauses, or phrases hereof be declared invalid or unenforceable.

Section 3. CEQA. The City of Corning finds that this Ordinance is not a "project" according to the definition set forth in the California Environmental Quality Act ("CEQA"), and, pursuant to CEQA Guidelines sections 15060(c)(2) (the activity will not result in a direct or reasonably foreseeable indirect physical change in the environment) and 15061(b)(3) (there is no possibility the activity in question may have a significant effect on the environment), the adoption of this Ordinance is therefore not subject to the provisions requiring environmental review.

#### **SUMMARY:**

Annually the City of Corning must declare its intention to levy assessments for the individual zones within City of Corning Lighting and Landscaping District 1. In compliance with State law, the City publishes a legal notice, and letters are sent to affected property owners informing them of the date and time for the public hearing associated with the assessments. The public hearing is held prior to levying the annual assessments and placing them upon the property tax rolls.

Landscape and Lighting District 1, Zone 5, Magnolia Meadows Subdivision Tract Map 20-1001 is located along west side of Marguerite Avenue just north of the Moon Road/Marguerite Avenue intersection and consists of fifty-three (53) residential lots of Tract Map 20-1001.

The City Engineer has filed the attached Annual Engineer's report for the District Assessments. No change is proposed in the current fiscal year assessment of \$128 per residential parcel. The attached Resolution, if adopted, would set the Fiscal Year 2023/2024 assessments at the rate of \$128 per parcel.

#### BACKGROUND:

The California Streets and Highway Code contains the Landscaping and Lighting Act of 1972 beginning with Section 22500. The Act provides for the establishment of Landscaping and Lighting Districts and for the levying of annual assessments to the property owners within the District.

Street & Highway Section 22626 provides for a notice of public hearing and includes a provision requiring a ten (10) day legal notice to the individual property owners along with publication in the newspaper when there is no proposed increase in the annual assessment. In this case, notice of this hearing was mailed to the affected property owners and published on June 2023. There is a more extensive notice requirement if assessments are proposed to be increased.

APPROVE ADDENDUM TO AGREEMENT BETWEEN THE CITY AND CORNING UNION HIGH SCHOOL DISTRICT FOR SCHOOL RESOURCE OFFICER SERVICES

#### BACKGROUND:

For several years, the City has provided an Officer to serve as a School Resource Officer at Corning Union High School. Funding for this has previously been provided through various grants.

Beginning in Fiscal Year 2018/19 the School Resource Officer (SRO) position cost was shared on a 50/50 basis between the City and the Corning Union High School District. The City's portion is budgeted 100% from the General Fund.

The proposed Addendum to the Agreement between the City of Corning and the Corning Union High School District will allow funding to continue the assignment of a School Resource Officer (SRO) shared between Corning High School and Centennial High School. If approved, the Addendum will allow this Agreement to commence on July 1, 2023 and shall thereafter terminate on June 30, 2026. It will also allow the Agreement to be extended for a greater duration upon the mutual and written assent of the parties to be affixed to this Agreement as an addendum."

#### **FINANCIAL IMPACT:**

If approved, under this Agreement, Corning Union High School District agrees to the following:

- Total monies paid to City if the Addendum to Agreement is completed with zero (0) SRO absence from the District for critical incidents and/or emergencies would be \$74,546 (this amount is for a 9-month period (Sept. through May and reflects recent salary increases approved during labor negotiations.). This equates to 50% of the total SRO salary, inclusive of benefits;
- The rate shall be billed on a 40-hr. week and payable to the City at \$8,282 per month, which calculates to an hourly rate of \$71.68; and
- SRO removal beyond 1 hour per pay period shall permit District to reduce payment to the City by \$71.68 for every hour, beyond two hours of SRO absence for the pay period at issue exclusive of vacation, sick leave, or family leave.
- The rate shall increase to reflect any salary increase for all members of the Operating Engineers Local Union No. 3 Public Safety Unit during the contract period.
- District shall pay overtime costs incurred by the SRO where District requests attendance at non-school day and/or non-school hour events beyond the 40-hr. work schedule. Costs shall be actual overtime costs paid by the Corning Police Department plus actual administrative costs to process said overtime. The Police Chief has the discretion to limit overtime hours of the SRO and the overtime paid shall be in addition to the compensation set above. All overtime costs are in addition to compensation described in Section II. A.

#### **RECOMMENDATION:**

APPROVE PROPOSED ADDENDUM TO AGREEMENT BETWEEN THE CITY AND CORNING UNION HIGH SCHOOL DISTRICT FOR SCHOOL RESOURCE OFFICER (SRO) SERVICES EXTENDING AGREEMENT THROUGH JUNE 30, 2026.

### FIRST ADDENDUM TO AGREEMENT BETWEEN THE CITY OF CORNING AND THE CORNING UNION HIGH SCHOOL DISTRICT FOR THE PROVISION OF SERVICES AND PLACEMENT OF A SCHOOL RESOURCE OFFICER

This First Addendum ("First Addendum") to the Agreement between the City of Corning ("City") and the Corning Union High School District ("District") for the Provision of Services and Placement of a School Resource Officer ("Agreement"). Collectively, the City and the District may be referred to as the parties.

#### RECITALS

WHEREAS, the City has provided a School Resource Officer at Corning School which has been originally funded through various grants, but changed in Fiscal Year 2018/19 to be split between the District and the City, with the City's portion coming directly from the general fund; and

WHEREAS, on September 1, 2022, the City and the District entered into the Agreement memorializing the City's agreement to place a School Resource Officer at the Corning High School, with the term set to expire on June 30, 2023; and

WHEREAS, the City and District seek to amend the Agreement through this First Addendum to extend the term for an additional three (3) years from July 1, 2023 through June 30, 2026, and to include a provision permitting termination should funding sources cease to exist.

NOW, THEREFORE, the City and the District mutually agree that the above recitals are true and correct and incorporated into this First Addendum, and agree to amend the Agreement as follows:

1) It is mutually agreed that Article III of the Agreement, titled "TERM" be amended and replaced with the following:

"This Agreement shall commence on July 1, 2023 and shall thereafter terminate on June 30, 2026. This Agreement can be extended for a greater duration upon the mutual and written assent of the parties to be affixed to this Agreement as an addendum."

- 2) It is mutually agreed that Article IV of the Agreement, titled "TERMINATION" be amended and replaced with the following:
- A. If District and/or City materially fail to perform its responsibilities as established in this Agreement, the non-breaching party shall have the right to terminate the Agreement for cause effective immediately. Upon termination, the District shall pay the City for services rendered through the date of termination. There is no limitation on damages, type, or amount that either party can pursue against the other following an allegation of breach or other warranted basis.
- B. The Agreement can be further terminated if the funding sources for either Party no longer be available to support the position. Should this occur, the terminating party shall provide notice to the non-terminating party as soon as it is determined the funding is not available.
- 3) All other terms of the Agreement shall remain in full force and effect.

### AGREEMENT BETWEEN THE CITY OF CORNING AND THE CORNING UNION HIGH SCHOOL DISTRICT FOR THE PROVISION OF SERVICES AND PLACEMENT OF A SCHOOL RESOURCE OFFICER

This Agreement is entered into between the **City of Corning**, a municipality of the State of California ("City") and the **Corning Union High School District** ("District"). Collectively, the City and District shall be referred to as the parties.

1.

#### **RESPONSIBILITY OF PARTIES**

- 1. Pursuant to the terms and conditions herein, the City agrees to perform all of the following:
  - A. Under the supervision of the Corning Police Chief or other person so designated by the Police Chief, a sworn Police Officer shall be assigned to the District as a School Resource Officer during regularly scheduled school days as specified on the District's school calendar, which is attached hereto as EXHIBIT "A" and made part of this Agreement by express reference. Notwithstanding the preceding, should any school day be an official Holiday of the City, the School Resource Officer ("SRO") shall not be assigned to work on any such day.
  - B. City, through its Police Department, shall assign the SRO to the District at a 40-hour per week assignment. The City, through its Police Chief or other responsible person of the Department shall have the discretion to remove the SRO from his or her regular 40-hour per week assignment for purpose of responding to any critical incident or emergency. A critical incident or emergency as used herein is intended to mean any act necessitating SRO response as determined by the City, through its Police Department, including but not limited to staffing shortages. City shall inform the District of any SRO removal as provided in this paragraph and further inform the District of when, approximately, the SRO will resume services at the District. Removal of the SRO as allowed herein shall result in a reduction in the amount of compensation payable by the District to the City pursuant to this Agreement. In such an event, the parties shall establish a per-hour reduction in what the District pays City for the pay-period in which the SRO was absent as provided for critical incidents and/or emergencies. The parties shall consider the total monies paid to the City if the Agreement is completed with zero SRO absence from the District for critical incidents and/or emergencies, which is \$67,848.38. Being 52 weeks in a year, and a 40-hour per week work schedule as mandated by this Agreement, it equates to 2.080 hours or work at \$65.24 per hour. Any SRO removal beyond 1 hour per pay period shall permit District to reduce payment to the City by \$65.24 for every hour, beyond two hours, of SRO absence for the pay period at issue exclusive of vacation, sick leave, or family leave.
  - C. The SRO shall coordinate enforcement details, including truancy, and utilize the resources available to the Corning Police Department in doing so. It is the goal of the Corning Police Department to maintain a low rate of truancy at the District through enforcement and counseling of students and parents. The SRO, among other duties, shall target violence, gangs, and illegal drug activity occurring at the District, and to work with District Staff, Students, and Parents in combatting these problems.
  - D. The SRO, through use of its Police Department resources and any applicable youth violence prevention program, to educate parents of students attending the District of gang member recognition, early warning signs of illegal drug use, and other issues relating to the health and safety of the students attending the District. The SRO will also attempt to contact parents of any student believed to be involved with gangs, violence, illegal drugs, or other matters of concern to request parental involvement to aid in redirecting the student's behavior.

- E. The SRO shall work with District Staff and Administrators to seek the safest learning environment for the District students, which can include, but is not limited to, communication enhancement, prevention, planning and in school safety training to prevent criminal conduct within the District.
- F. The City, through its Police Department, will complete quarterly reports of the SRO activity, including total time spent at the District, statistical tracking of crimes reported, and arrests made at the District as the SRO, citations issued by the SRO, the number of truancy contacts, and counseling sessions had through SRO contact and/or diversion efforts. The quarterly reports will be provided to the District Superintendent.
- **G.** The person assigned to the SRO position may change during the term of the Agreement. Notwithstanding, the City recognizes the benefit in maintaining assigned consistency in the position and will attempt, in good faith, to allow the person designated SRO to maintain the position for the duration of the Agreement unless circumstances require a change as determined by the Police Chief in his or her absolute discretion.
- 2. Pursuant to the terms of this Agreement, and during the term thereof, the District agrees to perform all of the following:
  - **A.** Compensate the City as provided in Section II entitled "Compensation" of this Agreement.
  - B. Provide to the City Police Chief a schedule of the calendared school days for the school year and any planned events of which the District desires the SRO to attend that are not regularly scheduled school days and/or within the regularly scheduled school hours. This information is to be provided in writing upon execution of the Agreement for a period of one month. Thereafter, this information is to be provided to the Police Chief every month for the following month's calendar to allow for proper planning and scheduling by the Police Department. Additionally, the City Police Chief may adjust the SRO schedule to allow his or her presence at the non-scheduled school day and/or non-school hour events, which District acknowledges will prevent the SRO from being at the District for 40-hours for the given week in which the non-school day and/or non-school hour events occur.

#### II.

#### **COMPENSATION**

- A. District shall pay \$67,848 to the City for the SRO services described in this Agreement. This amount is calculated at the hourly rate of \$65.24, which shall be billed on a 40-hour week and payable to the City at \$7,538.71 per month for the 9-month school year term (September through May). The parties recognize that the hours may differ each month with Holidays and scheduling, and that at the end of the term the parties will reconcile as needed to ensure payments made for services performed are met; however, for convenience, the parties elect to pay as agreed. This rate shall increase to reflect any salary increase for all members of the Operating Engineers Local Union No. 3 of the International Union for Operating Engineers AFL-CIO for Public Safety Employees of the City of Corning during the contract term.
- **B.** District shall pay City of a net-30 basis, and this provision shall survive the term of this Agreement.
- C. District shall pay overtime costs incurred by the SRO where District requests attendance at non-school day and/or non-school hour events beyond the 40-hour work schedule. This cost shall be the actual overtime costs paid by the Corning Police Department plus the actual administrative costs to process the overtime. The Police Chief has the discretion to limit overtime hours of the SRO. The overtime paid shall be in addition to the compensation set above. All overtime costs are in addition to compensation described in Section II, A.

#### III. TERM

This Agreement shall commence on September 1, 2022 and shall thereafter terminate on June 30, 2023. This Agreement can be extended for a greater duration upon the mutual and written assent of the parties to be affixed to this Agreement as an addendum.

#### IV.

#### **TERMINATION**

A. If District and/or City materially fail to perform its responsibilities as established in this Agreement, the non-breaching party shall have the right to terminate the Agreement for cause effective immediately. Upon termination, the District shall pay the City for services rendered through the date of termination. There is no limitation on damages, type, or amount that either party can pursue against the other following an allegation of breach or other warranted basis.

#### V.

#### ENTIRE AGREEMENT, AMENDMENTS, HEADINGS, EXHIBITS/APPENDICES

- A. This Agreement supersedes all previous MOUs relating to the subject of this Agreement and constitutes the entire understanding of the parties hereto. City and District specifically acknowledge that in entering into and executing this Agreement, each are relying solely upon the provisions contained in this Agreement and no others, whether oral or written.
- **B.** No changes, amendments, or alterations to this Agreement shall be effective unless in writing and signed by both City and District.
- C. The headings that appear in this Agreement are for reference purposes only and shall not affect the meaning or construction of this Agreement.
- **D.** If any ambiguity, inconsistency, or conflict exists or arises between the provisions of this Agreement, such ambiguity, conflict, or inconsistency shall not be construed against one party over the other.

#### VI.

#### **NO ASSIGNMENT AND NON-WAIVER**

This Agreement is not assignable. The waiver by either party of any breach of any requirement of this Agreement shall not be deemed to be a waiver of any other breach.

#### VII.

#### INDEPENDENT CONTRACTOR

The parties are construed as independent contractors and nothing in this Agreement is intended nor shall be construed to create an employer-employee relationship, a joint venture relationship, or to allow one party over the other to exercise discretion or control over the professional manner in which they perform their work or services that are the subject matter of this Agreement.

#### VIII.

### INDEMNIFICATION, DEFENSE AND HOLD HARMLESS AND INSURANCE COVERAGE

A. To the fullest extent permitted by law, City shall indemnify, defend, and hold harmless District, its Elected Officials, Officers, Employees, Agents, and Volunteers against all liability, claims, suits, actions, costs, expenses, damages, judgements, or decrees arising from the provision of services undertaken by the SRO pursuant to this Agreement. City shall also, at City's own expense, defend the District, its Elected Officials, Officers, Employees, Agents, and Volunteers against any liability, claim, suit, action or proceeding brought against District, its Elected Officials, Officers, Employees, Agents, and Volunteers, arising from the actual work performed by the SRO. The obligations of this paragraph survive the termination of this Agreement.

- **B.** District shall, at District's own expense, defend the City, its Officers, Employees, Police Department and its Officers, Board Members, Agents, and Volunteers against any liability, claim, suit, action or proceeding brought against City and/or any of its Police Department members or the Department itself, its Elected Officials, Officers, Employees, Agents, and Volunteers, arising from the District's performance, or non-performance, of any obligation set forth in this Agreement and/or for performance of non-obligations beyond the Agreement that create liability, loss, damage, or harm of any kind in which the City and/or any of its paid Staff are made a party to the litigation as a result of such actions or non-actions of the District. The obligations of this paragraph survive the termination of this Agreement.
- C. District shall secure and maintain, at all times during the term of this Agreement, Commercial General Liability Insurance, or participation in a Self-Insurance Program with minimum limits of one million combined single limit bodily injury and property damage. On request by City, District shall provide a Certificate of Insurance or other evidence demonstrating compliance with this provision of the Agreement.
- D. Each party has the absolute discretion to determine whether a settlement of any claim, liability, lawsuit, demand, or litigation, as to that party, is acceptable or should otherwise be had; however, where the claim, liability, lawsuit, demand, or litigation is the sole obligation of the other party as established in Section VIII (A) or (B), the party responsible for indemnification, defense and/or hold harmless obligations shall have the right to take control of the matter through their retained counsel so long as the obligations of this Section are being met and are thereafter satisfied, including but not limited to any indemnification and/or defense obligation.

### IX. MISCELLANEOUS

- A. Each party shall promptly notify the other of any claim being threatened or advanced that arises from the terms of this Agreement. Notice shall be prompt and timely if given within 30 days following the date of receipt of a claim or 10 days following the date of service of process of a lawsuit. This provision shall survive the termination, expiration, or cancellation of this Agreement.
- **B.** Any dispute between the parties, or any claim for declaratory relief seeking an interpretation of this Agreement, shall be governed by the laws of the State of California, and shall be filed and prosecuted through dismissal or judgement in the Tehama County Superior Court.
- C. Neither party shall discriminate in employment practices or in the delivery of services on the basis of race, color, creed, religion, national origin, sex, age, marital status, sexual orientation, medical condition (including cancer, HIV, and AIDS) physical or mental disability, use of family care leave under either the Family & Medical Leave Act or the California Family Rights Act, or on the basis of any other status or conduct protected by law.
- D. District represents that it is in compliance with and agrees that District and City shall continue to comply with the Americans with Disabilities Act of 1990 (42 U.S.C. sections 12101, et seq.), the Fair Employment and Housing Act (Government Code sections 12900, et seq.), and regulations and guidelines pursuant thereto and actually and legally applicable to the City.
- **E.** If any portion of this Agreement or application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction or if it is found in contravention of any

E. If any portion of this Agreement or application thereof to any person or circumstance is declared invalid by a court of competent jurisdiction or if it is found in contravention of any Federal or State statute or regulation or County and/or City Ordinance, the remaining provisions of this Agreement, or the application thereof, shall not be invalidated thereby and shall remain in full force and effect to the extent that the provisions of this Agreement are severable.

A. Any notices required or permitted pursuant to the terms and provisions of this Agreement shall be given to the appropriate Party at the address specified below or at such other address as the Party shall specify in writing. Such notice shall be deemed given: (1) upon personal delivery; or (2) if sent by first class mail, postage prepaid, two days after the date of mailing.

#### **SUMMARY:**

Staff requests the City Council authorize payment of invoice #21712 in the amount of \$40,631.00 and invoice #21788 in the amount of \$32,504.80 for a combined total of \$73,135.80 to COAR Design Group for work done on the Corning City Plaza and Recreation Center Project. This will be the first and second payment for this contract.

#### **BACKGROUND**:

On March 14, 2023 the City Council awarded the Corning City Plaza and Recreation Center Request for Proposals (RFP) Project to COAR Design Group in the amount of \$898,000 for Architectural and Engineering Design Services for the development, design and construction of the Corning City Plaza and Recreation Center.

#### **BACKGROUND:**

At the February 14, 2023 City Council meeting, Staff was directed to purchase playground equipment from Kompan after completing the Community Development Program Income (CDBG) analysis. The analysis has been completed and it was determined that the new playground equipment for the kiddle playground at Northside Park was not a good fit for the CDBG funds.

The Kopman quote expired on April 11, 2023 and Staff reached out to have the quote updated and were informed that the price has increased. The allocated \$106,259 in the 2022/2023 budget has been rolled over into the 23/24 budget to replace the kiddle playground equipment at Northside Park. The existing dinosaur will remain in the playground.

The attached quote does not include removal of the existing equipment or installation of the fall material. The City's Public Works Staff will remove the existing playground equipment and spread the fall material.

Exhibit A on the attached details the approximate cost of equipment and installation totaling \$106,440.56 from Kompan. This quote includes the following:

- 1) Kompan play structures and installation of equipment.
- 2) Kompan's Bid does not include wood chip fall material, which will cost approximately an additional \$5,590.

Pursuant to Section 3.12.082.4 of Municipal Code, this purchase is exempt from City purchasing procedures as the playground equipment has already been put out to Bid through OMNIA Partners, a public purchasing organization.

#### **FINANCIAL:**


This was a fiscal year 2022/2023 budgeted item that has been rolled over into the 23/24 budget in the amount of \$106.259. Should the City Council choose to move forward with the original proposal and purchase presented and approved at the February 14, 2023 City Council Meeting with the updated price quote, the Council will need to approve an appropriation of \$5,772 from the City's General Fund Reserves for the unbudgeted additional amount. This would bring the project final cost to \$112.031.

The City Council could choose to remove the Magic Garden from the previously approved project. lowering the Bid for the equipment to approximately \$103,433 plus the addition of the fall material at \$5,590 for a total project cost of \$109,023. Should this option be chosen, a general fund appropriation of approximately \$2,764 would be required. If chosen, this option would reduce the required general fund appropriation by \$2,764 for this project.

#### **BACKGROUND:**

Within the 2022/2023 budget, \$106,259 was allotted to replace the kiddle playground equipment at Northside Park with the exception of the dinosaur, which will remain. Staff has obtained two quotes for City Council to consider, select, and authorize the purchase.

Staff received two quotes for the new playground equipment which are listed below. The below quotes do not include removal of the existing equipment; City Public Works Staff will remove the existing playground equipment.

• OPTION 1: Park Planet Playground Equipment:

**Exhibit A** details the approximate cost of equipment and installation totaling \$104,554,09 from Park Planet. This quote includes the following:

- 1) Park Planet play structures, installation of equipment, and wood chips.
- 2) Photos depicting the completed playground.

**Exhibit B Park Planet Playground Equipment with ADA Swing** details the approximate cost of equipment and installation totaling \$109,153.93 from Park Planet, and if selected will require an appropriation of \$2,894.93 from General Fund Reserves. This quote includes the following:

- 1) Park Planet structures, installation of equipment, and wood chips.
- 2) Photos depicting the completed playground.
- OPTION 2: Kompan Playground Equipment

#### SUMMARY:

Staff flew a flyer on social media as a trial, offering free swim day sponsorships. As a result, Staff have been contacted by multiple businesses/organizations. In response, it was determined that the City Council should be made aware of the trial.

Currently businesses/organizations can pay \$250 to sponsor the free swim day at the City Pool allowing the children in the community to swim free for a day. Pool staff will be doing head counts to see if we are getting more children at the pool on those free swim days than on non-free swim days. Business and Organizations will receive social media advertising along with a flyer at the Pool and a scroll on the City's Marquee.

This pilot program is doing several things that staff feel are important for the community.

- 1. Primarily, this Program provides an option for more youth to get out of the house this summer and become more active and social amongst their peers, this is especially important coming out of the Pandemic. Currently, we have approximately 20 kids coming to day swim and 50 to the night swim on average.
- 2. It is a wonderful way for a business or organization to invest in their community, and the youth within it.
- **3.** It is building great professional relationships between our local businesses and organizations and the Corning Recreation Department.

If this pilot program is successful staff would like to bring this back to City Council for the 2024 swim season to solidify the Program and set a fee.
