Rose Mumau and Kathleen Wheelock also expressed their viewpoints. Alan Shaddinger moved, Renee Hayes seconded to approve the January 21, 2021 meeting minutes as presented. Vote - All Approved.

Treasurer's Report and Bill List

DCED Questionnaire and Zoom Meeting on October 13, 2021

Jeff Amon listened to the Zoom Meeting held by DCED with representatives from various Tax Collector Committees from around the Commonwealth. He noted there were 63 participants and 32 responded to the questionnaire. He reviewed the Tax Collector Committee Conversation PowerPoint document that was presented. Approve 2022 Meeting Dates and Authorize Advertisement

Replacement of Bryan Hobson on Management Committee

Rose Mumau moved, Alan Shaddinger seconded to appoint Kristen Eckart to replace Bryan Hobson on the Management Committee to fulfill the vacancy left through the end of his term. Vote - All Approved.

Presentation of Proposed 2022 Budget and Allocation Amounts

Jeff Amon discussed the 2022 Budget. He stated allocation amounts should be collected in 2022, as in past years we've collected every other year to try to maintain a balance in the checking account for insurance and other noted expenditures. The 2022 Budget would be considered for approval at the January 20, 2022 meeting.

Resolution No. 2021 - 1 for Berkheimer Inc to Collect the Allocation Amounts

Resolution No. 2021 -1 would enable Berkheimer Inc to deduct the 2022 allocation payment from the taxing entities of the Crawford County Tax Collection Committee and then remit the allocation directly to the Crawford County Tax Collection Committee; with the deduction and allocation payment to take place in February of 2022. Bill Leonard noted similar resolutions have been passed in other counties and this would eliminate invoices and reminder emails as well as alleviate the extra work in trying to get the monies collected from each entity. One check would be provided to the Treasurer in late February. Renee Hayes moved, Kristen Eckart seconded to approve Resolution No. 2021 -1, as presented. Kevin Cole and Rose Mumau noted this seemed a better way to collect the fees at no charge from Berkheimer. Vote - All Approved.

Resolution No. 2021-1

A RESOLUTION TO AUTHORIZE BERKHEIMER INC. TO COLLECT AND REMIT TO THE CRAWFORD COUNTY TAX COLLECTION COMMITTEE THE FEES ASSESSED TO EACH TAXING DISTRICT FOR THE ANNUAL OPERATIONAL EXPENSES OF THE COMMITTEE

Whereas, the Tax Collection Committee is responsible under Pennsylvania Law for collection of the Earned Income Taxes for all taxing districts located within the Crawford County Tax Collection Area. Each Taxing District participating in and served by the Tax Collection Committee is assessed a fee, (which is apportioned based on Taxing District's population), each year to cover the Committee's operational and administrative expenses, which have historically been less than \$10,000.00 per year. The Committee has been informed that the Tax Collector that performs the tax collection services for the Taxing Districts in the Tax Collection Committee area, will make payment of the assessments of each Taxing District from the earned income taxes collected for that Taxing District, to the Committee. The Tax Collection Committee desires to authorize this means of receiving the assessments for the convenience it provides to both the Taxing Districts and the Committee.

Now, Therefore, Be It Resolved by the members of the Crawford County Tax Collection Committee (CCTCC), Crawford County, Pennsylvania, and it is hereby resolved by and with the authority thereof as follows:

Section 1. Authorization For Collection and Distribution of Annual Tax Collection
Committee Assessment. Subject to applicable provisions of law, the Crawford County Tax Collection
Committee hereby authorizes and directs Berkheimer Inc. the Tax Collector retained by the Tax
Collection Committee, for the collection of Earned Income Taxes, to remit from the Earned Income
Taxes collected for each Taxing District within the Crawford County area, the amount of the assessment
made by the Tax Collection Committee for the calendar year in which the taxes are being collected.

Section 2. Effective Date. This resolution shall become effective immediately.
