

SMALL GENERAL SERVICE RATE G-1

AVAILABILITY

Service under this rate is available for all purposes when the average use is less than 10,000 kilowatt-hours per monthly billing period, but not for resale. Sales for resale are strictly prohibited. A Customer may be transferred from rate G-1 at the Electric Division's discretion if the Customer's average monthly usage exceeds 10,000 kilowatt-hours per monthly billing period for three consecutive months. (See Terms and Conditions).

BILLING RATES

Basic Monthly Charge

\$5.00 per monthly billing period

Energy Charge

8.60 cents per kilowatt-hour for all energy billed under this rate.

Minimum Charge

The minimum charge per month is the Basic Monthly Charge

PURCHASED POWER AND FUEL ADJUSTMENT CHARGE

As provided in the Electric Division's "Purchased Power and Fuel Adjustment Clause," applicable to all energy billed under this rate.

SALES TAX

Where applicable, Massachusetts sales tax on energy will be billed to the Customer as determined by the gross monthly charges to the account. Sales tax will not be added to bills for Customers with currently valid (annual) exemption certificates on file with the Electric Division, consistent with the provisions of law.

DISCOUNT

A five (5) percent discount will be applied to the Customer's bill if full payment is received at the Electric Division's billing office no later than fifteen (15) days from the billing date, provided the Customer's account was not in arrears at the time of the bill. Such discounts shall not apply to the portion of the bill which is billed under the "purchased power and fuel adjustment charge".

FARM DISCOUNT

Customers who meet the eligibility requirements for being engaged in the business of "Farming" or "agriculture" as defined in M.G.L. Chapter 128 Section 1A at their service location are eligible for an additional discount from their distribution service rates. The discount will be calculated as 10% of the Customer's total bill for service provided by the Electric Division before application of this discount. Customers who meet the requirements of this section must provide the Electric Division with appropriate documentation demonstrating their eligibility for a discount under this provision. Such documentation must be provided to the Electric Division on a yearly basis.

POWER FACTOR PENALTY CHARGES

A power factor penalty charge may apply when a Customer's average power factor is determined by the Electric Division to be less than 90% over the course of one (1) billing cycle. Customer If the Customer receives notification from the Electric Division that the power factor is below 90%, the Customer will have one (1) probationary billing cycle to employ power factor correction measures to bring its power

factor within the 10% threshold. After the probationary billing cycle, each subsequent billing cycle the Customer is found to be below the power factor threshold, the Customer will be charged 1% of that billing cycle's total bill for each 1% the power factor is below 90%.
