# Water Use Mitigation Program—Rain Barrel Rebate Application

## APPLICATION GUIDELINES

- Rebates are available to Danvers Residents only. Applicants listed must be Water Account holders with all active accounts in good standing. If account is not active or in good standing, rebate will not be processed. Rebate application will not be processed until application and checklist is complete. Incomplete applications will be returned. Please call 978-777-0001 x3011 for guidance.
- If the rebate is for an apartment tenant or condo owner, the “Account Information” should be for the apartment owner or condo association. Unit information should be filled under “Installation Address”. These applications require both applicant signature and account holder signature below.
- The Rain Barrel rebate will reimburse customers for the actual purchase price of the rain barrel up to a maximum of \$100. Rain barrel accessories, shipping costs and sales tax are not eligible for rebate. The Town of Danvers will rebate up to 1 rain barrel per address per calendar year.
- Application requires the proof of purchase with a clear line item displaying the product purchased in the form of the sales receipt, a product specification sheet that verifies water gallon storage and a **completed and signed** Rebate Application.
- The rebate program is on a first-come, first-served basis and is effective until the funding is exhausted or the program is discontinued.
- Rain Barrel(s) must be installed at the Danvers account location.
- Danvers Water Division reserves the right to inspect the installation on premises.
- Applicant agrees and understands that the Danvers Water Division does not guarantee that the installation of a rain barrel will reduce water consumption on your quarterly water bill.
- Danvers Water Division does not warrant, endorse or assume liability for the quality, performance or safety of the contractor and/or retailer or wholesaler or performance of any rain barrel. Responsibility for product chosen is solely the applicant’s.
