### Eligibility Requirements & Restrictions:

- \$500 maximum in appliance rebates per residential account per year.
- Your electric account must be active, residential, and in good standing. Applications from accounts not in good standing will be held until full payment is received. A DPW representative will contact you for payment.
- Offer is subject to funding and can expire at any time. DED can also terminate the program at any time.
- Equipment must be purchased for use at service address' location.
- Danvers Electric Division does not warrant, endorse or assume liability for the quality, performance, or safety of the contractor, retailer and/or wholesaler or performance of any appliance, fixture, or equipment use. Responsibility for choosing the product is solely the applicant's. The town of Danvers assumes no liability for installation or use.
- Equipment must be electric, cordless, and battery powered (replacing a gas-powered or wired piece of equipment)
- Applications require a copy of your sales receipt, Proof of Purchase (must include description of item, purchase date, price paid, and purchased from) and this form. Incomplete applications will delay processing by 4-6 weeks. Normal processing time for complete applications is 8 -10 weeks.
- Rebate payment will be issued as a check payment from our rebate partner, Energy New England (ENE)
- You agree to allow DED to inspect appliance installation on your premises. Applicant agrees and understands that the Danvers Electric Division does not guarantee that the installation of an Energy Star-certified fixture will result in energy savings, as site-specific energy consumption varies.
- Equipment rebate applications must be submitted within 180 days (6 months) of purchase.
