**ALL nomination papers** for the May 3, 2022 Annual Town Election **must be filed with the Town Clerk no later than Tuesday, March 22, 2022, at 5 P.M.** The Town Clerk, acting as the Clerk to the Board of Registrars, will accept them for certification by the Registrars. No nomination papers shall be received or be valid unless the written acceptance of the candidate thereby nominated shall be filed therewith. (Authority, Chapter 53, §7: 42 days, 3/22/22) .

Each nomination paper for a particular office (Town Officials) must contain at least fifty (50) good signatures (registered voters in Danvers), except for those individuals seeking election as Town Meeting Members, who must have ten (10) good signatures (registered voters) within their precinct. For those Town Meeting Members seeking re-election, the Clerk has prepared a letter, which they will receive through the mail, stating that, if they desire to seek re-election without nomination papers, they must sign an affirmation and return it to the Town Clerk no later than Tuesday, March 15, 2022. (Authority, Chapter 53, §10). This year, there are vacancies to be filled in each of the eight (8) precincts and Town Official positions, as indicated below.
