A RESOLUTION OF THE CITY OF DE LEON, TEXAS CANVASSING THE RESULTS OF THE MAY 6, 2017 GENERAL ELECTION FOR AT LARGE COUNCIL MEMBERS FOR PLACE THREE, PLACE FOUR, AND PLACE FIVE.
