CALL TO ORDER

Mayor Pro-Tem, Michael Reyna, called the meeting to order at 6:01 p.m.

PUBLIC COMMENT (Limited to Five minutes per person)

Lee stated that he is so proud of De Leon and the Vol Fire Department and the job that they pulled off for the Cogburn benefit. Gynnlyn stated that she was just blown away from the quality of stuff and the turn out. Michael said that you know that you have a great community, when you have to turn items away because you have too many already.

Councilmen Reyna and Beck were okay with the bid presented, but Councilwoman Abbe stated that she was not for it at all, but for this amount I would definitely like to go out for bids on this.

Councilwoman Abbe said that she just is sorry, but that is a lot of tax payer dollars to put into AC for something that is only used part of the time. Councilmen Beck asked if she would be interested in getting bids on this. Abbe stated that yes, she would be, but can we justify spending 25,000 on this building for family reunions, birthdays, dances, etc. Beck stated that it would be nice to keep the functions here in town. Reyna said that if we spend money on the AC then we will catch it for not doing the repairs to the road. Mayor said if they call it a community center, then why can't the community donate money for it. Abbe said that sometimes it best to cut away from having the city as an umbrella.

Councilmen Abbe made a motion to take no action on this item. Councilmen Reyna seconds that motion. Motion carried unanimously.
