

MINUTES OF A CALLED PUBLIC MEETING October 19th, 2016

CALL TO ORDER:

Mayor Adams called the meeting to order at 6:00 pm.

ROLL CALLS

CONSENT (AUTOMATIC APPROVAL) AGENDA:

Approval of Minutes - Regular Meeting on October 11th, 2016 - Councilman Reyna made a motion to approve the minutes for the Regular Meeting on October 11th, 2016. Councilman Baugh seconds that motion. Mayor Adams, and Councilman Johnson are in favor. Motion passed.

Add for Texas Trails Maps - Cindy McCormick presented the Texas Trails map of the City to the Council. Councilman Johnson made a motion for the city to approve payment of \$355.00 for the City's add on the Texas Trails Map for FY 16-17. It would be the same add that was used for FY 15-16. Mayor Adams seconds that motion. Councilmen Reyna and Baugh are in favor. Motion passed.

De Leon Rail Road Depot - Jon Awbrey from Developing De Leon Today (DDT) addressed the Council regarding the Rail Road Depot, saying that it was in the County's hands but due to a legal matter the County could not give the Rail Road Depot directly to the DDT. He said that the City could take it off the County's hands, and give it to them though, since the DDT was and EDC founded by the City. Councilman Reyna made a motion to accept the Rail Road Depot from the County, to give to Developing De Leon Today. Councilman Johnson seconds that motion. Mayor Adams, and Councilman Baugh are in favor. Motion passed.

MAYOR REPORT - Mayor Adams reported that Secretary Harbour, and Assistant Secretary Cogburn would be out of the Office next week for training.

POLICE CHIEF REPORT - Police reported that the School Zone wasn't having a lot of speeders, and that one officer would be sitting at the elementary in the mornings to help with traffic control.

CITY SECRETARIES' REPORT - Secretary Harbour reported to the Council that City Offices would be handing out Candy on Halloween from 4 to 5:30 pm. Cogburn added that Trick or Treat was not a City hosted event, more just the City handing out candy at a set time and encouraging other businesses to do the same. Harbour commended the chamber on the Rusty Truck Fall scene on the corner of South Texas and East Reynosa.
