Be It Remembered, that on this 11 day of August, A. D. 1970, at a regular meeting of the Mayor and City Commission of the City of DeLeon, Texas, held at the City Hall in the City of DeLeon, Texas, the Mayor and all of the Commissioners being present and participating, there came on to be considered the map or plat of SHADY OAKS ADDITION, a Resubdivision of Block 9 and part of Block 8 of Oak Lawn Addition and part of Ross Second Addition to the City of DeLeon, Texas, containing 5.2 acres of land, said 5.2 acres of land having been subdivided into 14 lots, numbered 1 to 14, inclusive, as shown on said plat prepared on the 4th day of AUGUST, 1970, by Forrest A. Eisenrich, and the dedication of said SHADY OAKS ADDITION having been duly executed by Forrest A. Eisenrich on the 4th day of AUGUST, 1970, and same being attached to said plat, wherein all streets and alleys shown on said plat are dedicated to the public use forever; and said plat and dedication having been at this time submitted to said Mayor and City Commissioners by the said Forrest A. Eisenrich, the owner of all of said 5.2 acres of land and said plat of SHADY OAKS ADDITION, with the request that said plat and dedication be accepted, approved and authorized by said Mayor and City Commissioners, in order that same may be entitled to record in the Deed Records of Comanche County, Texas:

Whereupon Commissioner Asmus read and moved the adoption of the following ordinance, to-wit:

BE IT ORDAINED by the City Commission of the City of DeLeon, Texas, that the plat of SHADY OAKS ADDITION, a Resubdivision of Block 9 and part of Block 8 of Oak Lawn Addition and part of Ross

Second Addition to the City of DeLeon, Texas, containing 5.2 acres of land, and the dedication thereof, as submitted to said Mayor and City Commissioners by Forrest A. Eisenrich, be and the same is hereby in all things accepted, approved and authorized, and the said Forrest A. Eisenrich is hereby authorized to file said plat and dedication in the office of the County Clerk of said County of Comanche, Texas, and the County Clerk of said County is hereby authorized to record same in the Deed Records of said County, all as provided by law.

BE IT FURTHER ORDAINED that this ordinance be spread upon the minutes of the City Commission of the City of DeLeon, Texas, as the official act of said City and that a certified copy hereof be delivered to the said Forrest A. Eisenrich to be attached to and recorded with the aforesaid plat and dedication.

The aforesaid motion was thereupon seconded by Commissioner Powell and being by the Mayor submitted to a vote of said Commissioners, all of said Commissioners voted in the affirmative and none in the negative.
