AN ORDINANCE OF THE CITY OF DELEON, TEXAS, AMENDING ORDINANCE NO. # 022-03; A BUDGET FOR THE ENSUING FISCAL YEAR OF OCTOBER 1, 2003 TO SEPTEMBER 30, 2004; APPROPRIATING THE VARIOUS AMOUNTS THEREOF, AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, a proposed budget for the fiscal year beginning October 1, 2003 and ending September 30, 2004 for the City of De Leon, Texas was adopted September 30, 2003.

WHEREAS, the City Council has adopted the amendment of the current budget to reflect the transfer of funds for the amendment of the current FY 2003-2004 Budget per the City's Auditor, Burl Lowery's recommendation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DE LEON, TEXAS THAT:

SECTION 1: Findings. The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made apart for all purposes as findings of fact.

SECTION 2: <u>Budget Amendments</u>. The General Fund and the Utility Fund have shortfalls mainly due to the increase in insurance for workers compensation, and showing each entities insurance breakdown. Also, the K-9 Unit was added after the budget was adopted and line items were added to show proper income and expenditures for that entity. See attached "Exhibit A" for itemized amendments totaling \$ 47,038.00.

SECTION 3: <u>Open Meetings</u>. It is hereby officially found and determined that the meeting at which this ordinance is passed was open to the public as required and that public notice of the time, place, and purpose of said meeting was given as required by the *Open Meetings Act, Chapt, 511, Tex. Gov't Code*.
