ORDINANCE NO. # 003-04

AN ORDINANCE AUTHORIZING EXECUTION OF THE TML INTERGOVERNMENTAL EMPLOYEE BENEFITS POOL INTERLOCAL AGREEMENT; ADOPTING A PLAN OF HEALTH BENEFITS FOR THE CITY POLICE OFFICERS AND EMPLOYEES; REPEALING ALL ORDINANCES IN CONFLICT; PROVIDING AN OPEN MEETINGS CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City desires to provide health benefits coverage to its officers and employees;

WHEREAS, TML Intergovernmental Employee Benefits Pool is a health risk pool established pursuant to Texas Local Government Code Chapter 172, Texas Government Code Chapter 791, and the Texas Trust Code to provide health benefits coverage for the police officers and employees of Texas political subdivisions under an Interlocal agreement;

WHEREAS, the City of De Leon desires to provide health benefits coverage to its officers and employees through TML Intergovernmental Employee Benefits Pool; and

WHEREAS, the City of De Leon desires to select a plan of benefits for its officers and employees to be provided by the Tml Intergovernmental Employee Benefits Pool; and

WHEREAS, executing the TML Intergovernmental Employee Benefits Pool Interlocal Agreement is in the best interest of the City of De Leon, Texas, its police officers and employees, and the public generally;

NOW, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DE LEON, TEXAS, THAT:

SECTION 1. The foregoing recitals are incorporated into this Ordinance as findings of fact.

SECTION 2. The City of De Leon hereby elects to join the TML Intergovernmental Employee Benefits Pool by executing the Pool's Interlocal Agreement.

SECTION 3. The City of De Leon adopts the following benefit plans to be provided to its police officers and employees through the TML Intergovernmental Employee Benefits Pool:

<u>Medical Insurance Coverage</u>. The benefit plan herein adopted are attached hereto as Exhibit A and incorporated herein for all purposes.

SECTION 4. John R. Adcock, Mayor, is hereby authorized to execute the TML

Intergovernmental Employee Benefits Pool Interlocal Agreement on behalf of the City of De Leon, Texas.

SECTION 5. The City Secretary is hereby ordered to enter a copy of this Ordinance in the City of De Leon minutes.

SECTION 6. All existing City ordinances in conflict with the provisions of this Ordinance are repealed to the extent of the conflict.

SECTION 7. It is hereby officially found and determined that the meeting at which this Ordinance was considered was open to the public as required and that public notice of the time, place and purpose of said meeting was given as required by the *Open Meetings Act, Chapter 551 of the Texas Government Code*.

SECTION 8. This Ordinance shall be effective immediately upon its passage.
