**Proposed 2017-2018 Budget** – Bob Whitney made a motion for the DIDC to adopt the proposed budget for FY 2017-2018. Tim Beaty seconds that motion. Prather and Caraway were in favor. Motion passed.

Acquisition of land, or other assets from the City – Prather said the City had yet to get appraisals done, and that the ball was in their park. No action was taken.

**Discussion with Peach and Melon Festival concerning land and building needs, and possible action to be taken** – No one was present to represent the Peach and Melon Festival. Prather asked if the board was happy with the lease that had been presented at the last meeting. Everyone concurred that they were. No action was taken.

**Amendments to the 2016-2017 Budget** – Tim Beaty made a motion to move \$661.25 overage from the Legal Expense line-item to the EDC Coordinator line-item. Bob Whitney seconds that motion. Prather and Caraway were in favor. Motion passed.

- Report for month ending Prather nominated Cogburn, Beaty, and Caraway to a finance committee, to overhaul the DIDC's accounting.
- Accounts Receivable Beck, Paredes, and Debord were all behind on their payments. Cogburn advised them that Beck had said he would make his payment around the 1st.

Beaty made a motion to approve the Financial Reports. Whitney seconds that motion. Prather and Caraway were in favor. Motion passed.
