

AN ORDINANCE APPROVING RATE SCHEDULES TO BE CHARGED BY TEXAS ELECTRIC SERVICE COMPANY IN THE CITY OF DELEON, TEXAS, APPROVING SERVICE REGULATIONS FILED BY TEXAS ELECTRIC SERVICE COMPANY, PROVIDING FOR AN EFFECTIVE DATE FOR SUCH RATE SCHEDULES, AND PROVIDING CONDITIONS UNDER WHICH SUCH RATE SCHEDULES MAY BE CHANGED, MODIFIED, AMENDED OR WITHDRAWN.

WHEREAS, on May 30, 1978, Texas Electric Service Company filed with the City Secretary a request for an increase in rates to be charged within the City and for approval of Service Regulations to be observed in the City;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DELEON , TEXAS

1.

That the tariffs, rates, and charges and service regulations for electrical service of the several types shall be as provided in the "Schedule of Rates," a document dated May, 1978, and filed on May 30, 1978, in the office of the City Secretary. Said rate schedules and service regulations and all provisions therein contained are incorporated herein by reference and specifically made a part hereof, and same shall become effective for all billings made on and after

OCTOBER 24, 1978.

Notwithstanding the foregoing provision, however, the tariffs, rates and charges and service regulations for electrical service of the several types and the classes of customers to which such several types shall apply, unless otherwise provided by subsequent amendment to this Section, shall not exceed nor become effective prior to (1) those tariffs, rates and charges and service regulations set and allowed by order of the Public Utility Commission of Texas in response to the Petition to Set Rates filed by Texas Electric Service Company with the Public Utility Commission of Texas at Docket No. 1903, or (2) those tariffs, rates and charges and service regulations which may be permitted by judicial stay or suspension pursuant to Section 85 of the Public Utility Regulatory Act (Article 1446c, V.A.T.S.) or which may be permitted by court order upon judicial review of the tariffs, rates and charges and service regulations set and allowed by order of the Public Utility Commission of Texas.

The setting of tariffs, rates and charges and service regulations and the effective dates thereof, as provided above, shall not preclude Texas Electric Service Company from placing into effect lesser tariffs, rates and charges, or from delaying the effective dates thereof, in order to make the level of such tariffs, rates and charges and the effective dates thereof coincide with the tariffs, rates and charges and effective dates thereof to be charged and collected by Texas Electric Service Company generally throughout its service area.

2.

The filing of the "Schedule of Rates" and the approval of same by the City Council does hereby constitute notice to the consumer of electricity, within the municipal boundaries of the City, of the availability and application of such "Schedule of Rates."


3.

This Ordinance shall become effective from and after its passage and publication as provided by law.

4.

It is hereby found and determined that the meetings at which this Ordinance was passed were open to the public, as required by Texas law, and that advance public notice of the time, place and purpose of said meetings were given.
