APPOINTING DIRECTOR TO THE BOARD OF DIRECTORS OF UPPER LEON RIVER MUNICIPAL WATER DISTRICT.

WHEREAS, Upper Leon River Municipal Water District was established by Chapter 405, Acts of the 57th Legislature of

the State of Texas, Regular Session (Vernon's Ann. Civ. St. 8280-257); and

WHEREAS, pursuant to the Act creating the District each City contained in the District is entitled to two Directors on said Board:

WHEREAS, each Director serves for a term of two years with his term expiring on May 31 of his second year in office; and

WHEREAS, the said Act requires this body to appoint a Director each year to replace the Director whose term expires.

- 3. The Director hereby appointed shall subscribe to the Constitutional Oath of office and shall give bond for the

faithful performance of his duties in the amount of \$5,000.00.
