Place Three Councilmember: **Laura Brown** receiving (85) eighty-five votes for early voting and (79) seventy-nine votes for election day for a total of (164) one hundred sixty-four votes

Place Three Councilmember: **Marie Glover** receiving (18) eighteen votes for early voting and (21) twenty-one votes for election day for a total of (39) thirty-five votes

Place Four Councilmember: **Heather Armstrong** receiving (65) sixty-five votes for early voting and (56) fifty-six votes for election day for total of (121) one hundred twenty-one votes.

Place Five Councilmember: **Dewitt (Buddy) Welch** receiving (67) sixty-seven votes for early voting and (61) sixty-one votes for election day for total of (128) one hundred twenty-eight votes.

Proposition No. 1: For receiving (92) ninety-two votes for early voting and (79) seventy-nine votes for election day for total of (171) one hundred seventy-one votes.

Against receiving (18) eighteen votes for early voting and (15) fifteen votes for election day for total of (33) thirty-three votes.




Mayor Scott adjourned at 5:43 p.m.
