

RESOLUTION #005-21

A RESOLUTION OF THE CITY OF DE LEON, TEXAS CANVASSING THE RESULTS OF THE MAY 1, 2021 GENERAL ELECTION FOR AT LARGE COUNCIL MEMBERS FOR PLACE THREE, PLACE FOUR, AND PLACE FIVE.

WHEREAS, an election was held at the City of De Leon, Texas, on May 1, 2021 for the purpose of a General Election for at large Council Members for Place Three, Place Four, and Place Five;

WHEREAS, the City Council of the City of De Leon (the "City Council") has reviewed and investigated all matters pertaining to this election, including the ordering of the election, notices, election officials, conducting the election and returns thereof;

WHEREAS, the City Council, hereby, canvasses the returns of this election, at which there was submitted to all resident qualified electors of the City of De Leon for their action thereupon, the General Election for at large Council Members for Place Three, Place Four, and Place Five;

WHEREAS, the City of De Leon has diligently inquired into the poll lists and the official election returns which were duly and lawfully made to the City Council by the judges and clerks holding and conducting the election; the poll list and the official election returns showing separately the resident, qualified voters casting votes in the election and the number of votes cast in the election;

WHEREAS, from these returns, this City Council hereby finds that the following votes were cast in the election by voters who were resident, qualified electors of the City; and

WHEREAS, each of the candidates in said election received the following votes:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DE LEON, TEXAS, THAT

Section 1. The City Council officially finds, determines, and declares that the election was duly and properly ordered; that proper legal notice of such election was duly given in the English language and the Spanish language; that proper election officials were duly appointed prior to the election; that the election was duly and legally held; that all resident, qualified electors of the City of De Leon were permitted to vote at the election; that returns of the results of the election have been made and delivered; and that the City of De Leon has duly canvassed such returns, all in accordance with the laws of the State of Texas and of the United States of America and the resolution calling the election.

Section 2. The following person is elected to the Office of Place Three Council Member for a term of two (2) years:

Section 3. The following person is elected to the Office of Place Four Council Member for a term of two (2) years:

Diana Klepac

Section 4. The following person is elected to the Office of Place Five Council Member for a term of two (2) years:

Lisa Amick

Section 5. This ordinance is enacted without the benefit of two readings because it was enacted by an affirmative vote of all members of the City Council in accordance with Article VII, Section 10 of the City Charter.
