OPEN VOLLEYBALL RULES AND REGULATIONS

- Players on the opposite team will call lines to determine if the ball was in or out.
- There must be 6 players per team on each side of the court.
- Each match consists of 3 games, **rally** scoring, to 25 points. A team must win by 2 points or the first to hit 27 points.
- If teams are waiting, games can be played up to 15, rally scoring.
- A coin toss or rock, paper, scissors will determine which team has the starting option: choose to serve first OR choose which side they would like to start from.
- Teams alternate side after each match.
- No catching, carrying, or lifting the ball at any time.
- A team is entitled to three hits (in addition to blocking) for returning the ball. The ball may touch any part of the body, including the foot. A player may not hit the ball two times consecutively except when fielding the ball from a spike or serve and must be one single motion.
- The ball must cross the playable portion of the net to be considered a legal return. A ball may not hit the volleyball pole, antennas, any wall, or area dividers during any portion of the play. The ball may make contact with the net during the 3-hit cycle.
- Teams must rotate after every side out -- players must rotate from the front right to the back right position. The player rotating in is now the server. If a team has 8 or more players, they may substitute one player from the front line and one player from the back line during each rotation. In this case: front right rotates out, substitutes enter to serve; back left rotates out, and substitute enters front left.
- The team that wins 2 out of the 3 games wins the match. All 3 games count towards the standings.
- Schedules are subject to change.

CONDUCT - DHS Recreation reserves the right to suspend or terminate the privileges of members who do not conform to these rules. DHS Recreation adopts a ZERO tolerance policy regarding

inappropriate conduct. Such conduct may include {but is not limited to) loud, boisterous, or obscene language and/or gestures, lewd conduct, harassment, attempts to reprimand staff, conduct that may endanger the best interest of other players, staff, or guests.

DAMAGES - Any damage to DHS Recreation's property by any member, or guest shall be paid for by the member. Premises inside and outside are monitored by security camera system.

DRESS CODE - Shirts must cover back and chest; shorts/pants must cover the entire gluteus maximus; closed-toed and non-marking athletic shoes are always required.

SMOKING - DHS Recreation is proud to provide a completely non-smoking environment. Smoking is prohibited anywhere on the premises, this includes all types of smoking i.e., vape pens, cigars, and hookah {water pipes}.

SOLICITATION - All persons cannot post or circulate advertisements of any kind on premises. Solicitation of funds is prohibited and can cause for request to leave the premises.

PROHIBITED ITEMS - Weapons of any kind, illegal paraphernalia and alcoholic beverages are prohibited on the premises.

PERSONAL PROPERTY - DHS Recreation is not responsible for any lost, stolen or damaged personal property brought in by members. There is no lost and found area on premises. All items left behind will be thrown away at the end of the day.
