MINOR DEVELOPMENT PERMITS are intended to provide a method whereby minor changes may be made to existing, previously

approved land use entitlements, without any additional impact or expansion of use or structure(s), pursuant to Section 17.120 of the Zoning Code. At the time of application submittal, a review of the location, design, configuration and impact of the proposed use shall be conducted by comparing such use to established standards and design guidelines. This review shall determine whether the permit should be approved by weighing the need for the benefits to be derived from the use against the impacts it may cause.
