### III. Tactics

- A. Tactical considerations
  - 1. Avoid over-dependence
  - 2. Cover and distance
  - 3. Other available force options/back-up officer
  - 4. Landing zone
  - 5. Preferred deployment
  - 6. Cuffing under power
- B. Contingencies
  - 1. Limited or no effect
  - 2. Weapon malfunction
  - 3. Transitioning to other force options

#### IV. Smart Use Considerations

- A. Using the Taser as a force option
  - 1. Consider alternative options if no exigency exists
  - 2. Give warnings prior to using force, if practicable
  - 3. Give reasonable opportunity to comply
  - 4. Cease using force once compliance is achieved
  - 5. Justify each discharge
  - 6. Avoid continuous/repeated discharges
  - 7. Avoid use on higher-risk populations
  - 8. Avoid drive-stuns

- 9. Monitor subjects after CEW discharge
- 10. Use within law/policy

#### V. Standards

- A. Fourth Amendment
  - 1. Officers must comply with 4<sup>th</sup> Amendment as related to CEW use
  - 2. Agencies set policies which may be more restrictive than the 4<sup>th</sup> Amendment
- B. Fourteenth Amendment
  - 1. Use of Force on pretrial detainees Kingsley v. Hendrickson
- C. Eighth Amendment
  - 1. Use of Force on convicted prisoners Whitley v. Albers

#### VI. Medical Risks

- A. Higher risk populations
  - 1. Pregnant women, children, elderly, etc.
- B. Injuries from falls
  - 1. CEWs frequently cause uncontrolled falls
  - 2. Consider the environment around the subject
- C. Increased injury risk
  - 1. Elevated position
  - 2. Flammability
  - Cardiac risks (heart-to-dart distance/duration of electrical discharge)

- D. Physiologic/Metabolic risks
  - 1. Blood pressure/blood chemistry
  - 2. Respiration
  - 3. Heart rate and rhythm
  - 4. Adrenaline and stress hormones

### VII. Use of Force/Taser Policy

- A. Department policy
  - 1. Use of the Taser
  - 2. Medical aid
  - 3. Reporting procedure
- B. Relevant case law
  - 1. Bryan v. McPherson (immediate threat)
  - 2. Young v. County of Los Angeles (force options)
  - 3. Armstrong v. Village of Pinehurst (resistance not equal to threat)
- C. Penal Code 835a

#### VIII. Skills Demonstrated

- A. Manipulation of the weapon
  - 1. Bring weapon up on target
  - 2. Safety switch (on/off)
  - 3. Trigger pull (fire with no cartridge)
  - 4. Reload

- B. Static target discharge
  - 1. Loading cartridge
  - 2. Bring weapon up on target
  - 3. Safety switch (off/on)
  - 4. Discharge live cartridge
  - 5. Remove expended cartridge
  - 6. Reload
- C. Practical scenario
  - Students will confront a suspect and appropriately discharge the Taser
  - 2. Evaluation of student's actions
