b. Project Charter Adoption

- Initially the language was not clear, this is a project for the county and if it can serve all agencies, great, rather than a plan for all the agencies for Marin. The language suggested is an improvement.
- ii. Suggestion to define "internet" as high-speed internet, that can work for school and business and make internet viable. "High-speed" is better rather than "broadband".
- iii. Ensure we are crystal clear on the language and what we are doing.
- iv. Project is being started and funded by the county. The vision is that we would bring the different sectors and education to adopt it, this is not a master plan and helps guide collaboration.
- v. Add "affordable" to high-speed internet.

c. Elevator Pitch

- ii. Effort in designing a roadmap for the project and have opportunities to collaborate and be more efficient.
- iii. Holistic view of the internet divide and connection. What the needs are and how can we get the government to respond and meet those needs through digital mechanism.
