# 1. Minutes

Mr. Wainwright: This is to replace the existing driveway gates, they will be no more than six feet above grade, there will be no lighting, and will be painted white and sheets were previously distributed showing basically a standard white gate. Bob Hefner, do you have any questions or comments?

Mr. Hefner: I do not see any objection to the proposed gate. It is very similar to what is there now.

### 4. Smithie, LLC - 20 Main Street

Mr. Wainwright: Next item on the agenda is 20 Main Street, I do not know if Joan Denny is going to call in or not, they are asking for approval to install a split air conditioning unit with a compressor that would sit on the rear roof of the building, the compressor is not visible from the street, dimensions of the compressor are 33 inches in width, 13 inches in depth, 34 inches in height. It is a very simple split air conditioning system, I have three of them myself. I walked the other day in the back of the parking lot and if anything is to be visible it only would be visible from their own parking lot.

Mr. Siska: Right.

Mr. Bluedorn: And are they quiet?

Mr. Wainwright: Oh, they are...

Mr. Siska: Super quiet.

Mr. Wainwright: They make almost no noise at all.

Mr. Bluedorn: Okay.

Mr. Corwin: There is one right behind Bruce.

Mr. Siska: That is the indoor one.

Mr. Wainwright: That is right, that is in the indoor side and the compressor is somewhere outside. They work really well.

Mr. Siska: They work really well, super quiet, super-efficient.

Mr. Wainwright: Any questions, comments, thoughts?

Mr. Corwin: No objections.

Ms. Bluedorn: No objections.

Mr. Nower: To compensate for audio delay, we do not have any callers on the line right now but I would suggest that we just hold up for a little bit and make sure that no one is calling in because, again, there is about, between 20 seconds to 40 seconds on transmission and then on line there is a little bit different too.

Mr. Wainwright: That I understand. I think if Joan does call in, it will be just to repeat what I just repeated.

Mr. Nower: We have Joan, Joan is just calling in right now, give me a second.

Mr. Wainwright: Okay.

Mr. Nower: Joan, you are up.

Mr. Wainwright: Joan?
