Ms. Dalene: Aye.

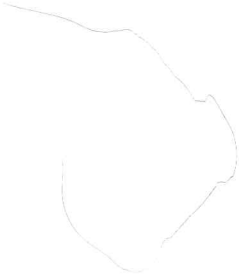
