# VILLAGE OF EAST HAMPTON BOARD OF TRUSTEES DATE: MARCH 20, 2020 MEETING, 11:00 A.M. LOCATION: EMERGENCY SERVICES BUILDING, 1 CEDAR STREET, EAST HAMPTON, NY

R. Lawler: Before we begin, please all stand for the Pledge of Allegiance.

All: I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one under God, indivisible, with liberty and justice for all.

**R. Lawler:** Because of the circumstances we won't be hearing from Hugh King today, so we'll get right into our meeting. I just want to have a few announcements first.

Pursuant to Executive Order No. 202.2, the public is not permitted to attend this meeting in person. This meeting will be published by Local TV, Channel 20, 22 public access. Public may submit comment by e-mail to jlester@easthamptonvillage.org, fax to 631-324-4189, or mail to the Board of Trustees, Village Hall, 86 Main Street, East Hampton.

So, before we begin with our resolutions, just quickly to bring you up-to-date with the latest things we've done to combat the virus. Obviously, we've closed Village Hall and all our public buildings, to the public. We've cut our staffing in half, in some cases even less, by that I mean our non-essential staff. We've made arrangements to receive permit applications via e-mail, or in some instances where that's not possible, then you can call Village Hall or whatever office it is you want to do business with prior to and make arrangements for you to deliver it to us in whatever manner discussed on the phone. It will be safer for each of you. To give you an example, even the postman at Village Hall has to ask permission to drop off the mail. We are adhering to the Governor's guidelines strictly. Additionally, we've closed the playground in Herrick Park, the park itself is still open, but we've roped off the playground equipment - because you may or may not know, the virus can survive up to reventy-two hours on plastic or metal. We felt it necessary to do that. Certain areas of the Emergency Services Building are still open to the public. Protocol is that you be buzzed in, then follow whatever protocol they ask you to follow once you're inside the building. We're getting close to one hundred percent compliance with the Governor's Executive Orders. We did have one situation where they were out of compliance, but it was more of a situation where they were, the fact that they were not aware of this particular item in the Governor's Executive Order, it was not a deliberate situation, so they were asked to close and they complied. That's been the only exception so far.

As of 8:00 p.m. tonight, the Governor directed all non-essential businesses and not-for-profits to use tele-communications were possible to conduct business. A list of the essential and non-essential businesses is on the Governor's website. You can get that information there. AN example of some of the essential businesses would be healthcare facilities, hospitals, food supply businesses, at this point, still the building trade, those sort of things. The Governor's order just came out a short while ago, indicating that Barbara shops should be closed. That's very recent, in addition to the Governor's Executive Orders.

Just a reminder – when you go to the supermarket please don't buy an excessive amount of individual items. That is what in fact creates shortages on store shelves. Supply chain is fine. Goods are getting to the stores, but if you buy an excessive amount of some items than you immediately empty the shelves and of course nobody else has access to it. It just creates a sense of panic, which is un-necessary, so please refrain from doing that. In fact, I believe, certain grocery stores have already started limiting people as to how many they can buy of certain products.

In addition to that, we've also noticed that there's been an increase in litter – rubber gloves, masks – that sort of ching, outside some of our business establishments. If you could please remember that if you're in the business establishment and you're donning those items, when you take them off could you please dispose of them properly rather than just dropping them on the ground. That would be very much appreciated.

I also want to remind everybody we have already in place, and have for many years, mutual aid agreements with surrounding jurisdictions for help if we should need it – that is for fire services, ambulance services and police services. In the event something should happen and we need extra police, or fire, or ambulance, those agreements are already in place and we of course reciprocate when asked to.

Also, I want to remind people of the practice we should be following at this point. Obviously – social distancing – which requires at least six feet distance between you and another individual and that applies to young adults as

well. Recently, they've discovered that young adults are susceptible to the virus as well. They may not get as sick, and in some cases may not realize they have it, but it is possible for the young adults to transfer the virus to older more susceptible people, so therefore we're asking those young people to abide by those practices as well. Please wipe down frequently touched surfaces – like doorknobs as regularly as possible. Wash your hands frequently. Use anti-bacterial soap or lotion. Even if you don't have those items, if you just use soap wash thoroughly for about twenty seconds – that will do just as good a job. If you feel ill, please self-quarantine, and by that I mean if you have a cough, a fever or congestive lungs, please self-quarantine. If you have any one of those symptoms – I should say if you have three of those symptoms call your doctor and get instructions from him. If you feel like you should get tested they are doing some tests at Southampton Hospital but they have just opened a mobile test site at Stony Brook Hospital in Stony Brook. To get an appointment there you should call either 311 or 888-364-3065 and you will be triaged over the phone and if warranted than you'll be given an appointment to come in for a test. The test site is the South Lot P at Stony Brook Hospital.

So far, we have, as of last night's telephone call with the County Health Department – there are 239 confirmed positive cases in Suffolk. We still have the same number of 1 positive in East Hampton Town and 1 positive in East Hampton Village. Just in general, I want to say, after talking to our police chief and some other services people in general, in the Village and Town have been very cooperative about following these guidelines. I'm very thankful for that.

R. Lawler: Anybody else?

**B. Borsack:** I just want to mention that for anybody that is sick or has a minor injury if it's not an emergency please don't call your local ambulance, because supplies are limited and they have to treat every patient as though they could be a carrier – so they have to use protective equipment on for every call. So, please be aware of that, and if you feel like you need to go to the hospital you might call your doctor first and check with them and get some guidance from them just so we're not over-taxing our system. I also want to thank our Mayor and our Administrator Becky Hansen for doing a yeoman's job in this crisis. I think you've both put in an amazing number of hours and have done an amazing amount of work and I really appreciate it. Thank you very much.

R. Brown: I think we all do. We also appreciate all of those on the front lines you mentioned — our fire department, our police, our ambulance personnel, we all feel fortunate to live in a close-knit community like this and we'll get through it together. I also wanted to let people know that the East Hampton School District is doing a meal distribution program, breakfast and lunch for anyone 18 years and younger. You can go to the High School and they're having a take-out situation, where they're able to give breakfast and lunch weekdays, between nine and eleven. There's also, for those sixty years and older, through the Town Social Services Department, they're also doing a delivery program — set up for errands such as groceries, prescriptions and so forth and their number is 631-329-6939, and of course there's Meals On Wheels, and the food pantry if people are in need. It's a time for all of us to use an abundance of caution and think of others as well.

A. Graham: I also want to add my voice to what everyone has already said. The ambulance is stressed, they're all short on supplies. More will be coming – the answer is no one knows when, so keep the use of the ambulance to an absolute necessity. Thank you.

#### **RESOLUTION # 16 - 2020**

WHEREAS, the discovery reform laws passed in the 2019-2020 New York State Budget overhauled the discovery process, requiring an expedited timeline to provide materials such as police reports, radio transmissions, body-worn and dash-cam video, along with other data related to prosecution; and

WHEREAS, the New York State Criminal Procedure Law (CPL) Section 245.20 protects law enforcement personnel from disclosure of name and adequate contact information in this process to protect them and their families from threats, the same protection was not extended to first responders, who are in many instances called upon to provide services at crime scenes; and

WHEREAS, emergency personnel should have the same privacy protection as law enforcement officials, so they are not subject to retaliation or witness tampering; and

WHEREAS, a bill has been introduced to the New York State Legislature that would provide emergency personnel the same privacy protection as law enforcement officials and the Village of East Hampton would support said protection, now therefore be it

RESOLVED, that the Village of East Hampton adopts this memorializing resolution in support of proposed 2019 New York Assembly Bill No. 9107, "Relates to ensuring privacy protections for all emergency personnel present at a crime scene." This legislation would ensure privacy protections for all emergency personnel present at a crime scene including ambulance services or advanced life support first responder services, certified first responders, firefighters, emergency medical technicians or advanced emergency medical technicians, who are employed by or enrolled members of any such service.

WHEREAS, the Mayor of the Village of East Hampton issued an Emergency Order on March 13, 2020 as a response to minimize the threat from COVID-19 to the public health and welfare of the residents, employees and guests of the Village of East Hampton; and

WHEREAS, while the residents of the Village of East Hampton deal with this emergency health crisis and people are being urged to stay home, the Board of Trustees recognize that certain people may have building permits that are set to expire in the next few weeks pursuant to Section 104-7A of the Village Code; and

WHEREAS, Village Hall is currently closed to the public; and

WHEREAS, the Board of Trustees feel that homeowners should be given additional time to renew their building permits; and, now therefore be it

RESOLVED, all current building permits, which expire pursuant to Section 104-7A of the Village Code in March or April shall be granted an additional sixty (60) days from the date of this resolution.
