Everybody. So welcome to the East Hampton Village Board Meeting. Today is June 17th, 2022, and I'd like to start the meeting with a pledge, if Dave Collins will lead us.

Mayor's Announcements

J. Larsen:

All right. So I have a few announcements, and then we'll get into our regular meeting. My first announcement is, I would just like to thank Rose Brown, who's not running for re-election, for all her service that she's provided to the Village over the years and if you wanted to say a few things, Rose, feel free.

R. Brown:

Sure. Yes, this is my last public meeting. I think it's been almost 24 years of public service to the Village, which I've truly enjoyed, and it's been very rewarding. It's been a great run. I don't know really where the time has gone. It's such a cliché, but time is flying. I wish we could hit the pause button. But I feel it's been an honor and privilege to serve the Village resident and the community, and I feel fortunate and so lucky to call this place home, as I know we all do. Such astounding beauty and historic character and comprised of such a close-knit community that I'm so appreciative of. And of course, as you just mentioned, I'm stepping away from this seat, but I'll still stay involved. I have three kids that keep me very busy and a job, and so forth. So I'll be involved in other ways in the Village, through community organizations and such. But again, I thank the community residents for their support over the years. I've always tried to make each and every decision based on their best interest, and I thank them.

J. Larsen:

Thanks, Rose. We really appreciate all you've done for the Village. Thank you.

R. Brown:

Thank you.

J. Larsen:

That leads us into the next announcement. Village Election will be this coming Tuesday, June 21st, at the firehouse on North Main Street and Cedar Street. It'll be on the second floor this year. We're hoping everyone will come out and vote. That will start at noon on Tuesday, and the polls close at 9:00 PM. So hopefully everybody can come out and vote.

My next announcement is about the Pride Parade. Last weekend, we had a Pride Parade, first one ever in the history of the eastern end of Long Island, and it was well attended. We've been lucky to have great weather, and it was just a terrific turnout and a lot of fun. So we're going to make that an annual event. That'll be the first Saturday of every June.

Next, we have free yoga, just to remind everybody. Free yoga at Main Beach on Saturday mornings at 8:30, and parking is... You don't need a permit from 8:30 until 10:00. We also have Tuesdays at Main Beach; our music events will be starting at 6:00 PM on June 28th. Will be the first Tuesday, and they will go until September 6th. And thank you for all of that, Brad. Doing a great job with the foundation.

Next, I bring up a photo. Jody, do you have a photo? Just as we had promised, Chief Tracey is in his last 18 months of service for the Village, and we promised we'd have on a photo of him at every board meeting. So if you could pop that photo up. And then Chief, could you explain this photo to the audience? And this will be done every board meeting, so the photos are going to get a little different each meeting. Do you have that photo, Jody?

J. Gambino:

Should be up.

J. Larsen:

Jody can't hear us, apparently.

J. Gambino:

I can hear.

J. Larsen:

Can you text him, Marcos? The photo is of you vacuuming yesterday at Village Hall.

M. Tracey:

Well, it's interesting. I just happen to have a couple of photos here, but I'd like to show this one first. It appears to be a Chief of Police shoveling the Main Beach parking lot. This one here is the Chief doing dangerous electrical work in the basement of dispatch, closely followed by the Chief acting as a fuse for the main emergency panel at Police Headquarters. Not to be outdone, the chief vacuuming the rear of Village Hall yesterday. I was prepared just in case there was any photos available for today. And as you can see, I was willing to lend a hand and brought my own photos.

J. Larsen:

Yeah. Well, thanks for that. Now you just covered four meetings for us. All right, Chief, why don't you talk about Juneteenth? Chief Tracey was given the task of putting together a celebration for Juneteenth and he's done a great job and if you could explain what you've done and what's going to be happening, that would be great.

M. Tracey:

Yep. Thank you very much. So back in March, the mayor and Reverend Thompson got together and began talking about Juneteenth and what would be a suitable presentation to the Village residents and to our neighbors on Juneteenth. I met with the Reverend several times along with the mayor and Marcos, the Village administrator, we collectively decided that Herrick Park would be the best place. We then began planning a presentation. We figured for the first Juneteenth celebration, we were going to do it without food, very low key and bring in some local speakers as well as some from the outside. Our goal is really to educate the community about the importance of Juneteenth and I think we did quite well with a group of representative speakers. We're very, very lucky. I've got some super nice people. The Reverend was able to bring in... Well, you'll see by the list. And we have, in fact, the Reverend has a Dr. Lewis Brogdon coming. He's going to be our keynote speaker. He's the Associate Professor and the Director of the Institute for Black Church Studies in Louisville, Kentucky. Obviously, the Reverend Thompson will be speaking for us and giving us some words of wisdom as well. Arthururine Dunn. She's a well-known local English teacher at the high school. She is the chairman of the department also. She's going to be speaking about some experiences in her life and her childhood, and I think it will be very interesting. We also have Hugh King, our Historian, and we also have Evie Rattray who, as most of you know, worked on the Plain Sight Project. She's going to be bringing us some additional information on what they've been working on lately. Overall, I just think it's an outstanding lineup. I think we also have two local singers who are going to be working with us. They're going to perform for us several songs during the ceremony and in between the speeches. And it's really going to be a nice time, but I would like to also introduce Reverend Thompson. He's here with us today and he's really driving force that basically made this happen this year. And it was a great guidance to me and...

Marco Baladrón:

Mayor, I think there was interference with Mike's mic.

Rev. Thompson:

Was he finished?

J. Larsen:

Yeah, I think he has some interference with his mic Reverend, so.

Rev. Thompson:

Okay. Well let me just...

J. Gambino:

I'm going to mute you two.

Rev. Thompson:

Did you mute Mike?

Chief Tracey:

Yeah, mine is going in and out.

M. Baladrón:

Chief Tracey, can you mute yourself?

J. Gambino:

I got him.

Chief Tracey:

Yeah, every time I mute it and unmuted, it kicks me off.

J. Larsen:

Have to shut it off. All right, Reverend.

J. Gambino:

Okay, here we go.

Rev. Thompson:

Oh, thank you, Mayor Larsen. Thank you, Mayor Larsen, for cutting off that sound. I think you provided a great introduction. I am looking forward to this weekend. It's been a full weekend of just celebration and excitement in the Village of East Hampton. And as the pastor of Calvary Baptist church located in East Hampton, I am proud to be able to, along with the Mayor Larsen and Chief Tracey and the entire administration of East Hampton, as we look forward to this time of liberation, you know that historically back in 1865, there was a liberation and manumission of the enslaved people down south. They received, of course, a word of their liberation, their deliverance and freedom by the signing of the Emancipation Proclamation by President Lincoln. What our focus is, along with the Village, is to really highlight our acknowledgement of that liberation and to celebrate as a community together. I believe this is an opportunity for us to begin to coalesce together and collaborate as we move forward as a model for other communities to see how we can celebrate the diversity that we share in this community and bring about social, political and economic change for all people as we

work together. I'm excited about this day and the keynote speaker. Matter of fact, I am on my way to the airport now to pick up Dr. Brogdon, but I just want to thank the administration, thank the Village again, Mayor Larsen, Chief Tracey, for their working together to bring about a great day and a highlight what will be, I think a great moment in the history of East Hampton. As I will say on Sunday, we are coming together, not so much to highlight the pain of the past, but also to rather than scattering the darkness we've come to gather the light. I just put it like that. It gives us an opportunity to shine as a community and understanding that there is unity in diversity. I'm so excited. I saw the flags down main street and it's just an exciting time in the air. It's Father's Day as well and so it's just an exciting time. So, I'm looking forward to having a great day on Sunday. Are there any questions for me?

A. Graham: I have a question. What time will this be starting at Herrick Park?

J. Larsen: It's going to be two o'clock. Two o'clock, Tiger. Two o'clock Reverend, could you

explain the symbol on the flag to everybody?

Rev. Thompson: Well, of course, the star of course represents Texas. Of course, I grew up was raised in

Houston, Texas. Of course, which was 60 miles from Dallas, Texas. Right? The star of course represents the state of Texas, but the red, white and blue is inclusive that it is not just African American history, but it is American history, which is inclusive. The star, of course, represents Texas. The red, white and blue represents the totality of

who we are unifying the nation together in bringing a closure to a dark past.

J. Larsen: Thanks very much. It's from two to four at Herrick Park and we hope everybody can

come out. It is Father's Day and we're going to have a really nice time. We have a great bunch of people speaking and singing and should be a really nice time for the whole community. So hopefully everybody can join us. I just want to thank Tarbert and Lester, the law firm of Tarbert and Lester who paid for the banners up and down main street in Newtown and the foundation, Brad, thank you for your contribution of sponsoring this event as well. Of course, thank you, Reverend, without you, we

wouldn't be able to have it. So, thank you very much.

Rev. Thompson: Well, I thank you for your leadership and your willingness to step out front, along with

me together. So I'm looking forward to it and having a great time with the Village and

all the people in our community.

J. Larsen: Me too. So, I'll see you there Sunday and thank you for coming on. Drive safe.

Rev. Thompson: Thank you all.

J. Larsen: All righty. The next presentation will be from Hugh. Hugh?

H. King: Hi, everybody. About two months ago, I gave everybody a name to investigate and

then it got lost because I wasn't at a meeting and then apparently everybody didn't get my email, but I think trustee Graham has a report, but a couple of these have

something to do what's going to happen on Sunday and Saturday. So, Trustee Graham,

Lyman Beecher, who was the preacher East Hampton from 1798 to 1810, and then

you were supposed to do Isabella Beecher Hooker, right?

A. Graham: Yes. Isabella Beecher Hooker born in Litchfield, Connecticut. She was the daughter of

moved to the congregational church in Litchfield, Connecticut, 1810 to 1826. Isabella Beecher Hooker was born in Hartford. Her mother was Lyman Beecher's second wife, Harriet Porter, who he married in 1817 in Litchfield. Isabella's stepsisters were Catharine Esther Beecher, Harriet Elizabeth Beecher Stowe. She had five stepbrothers and three full brothers. Now she attended her sister Catharine's school in Cincinnati and Hartford. She married John Hooker in 1841 and spent the next 25 years raising her children. In 1861, her ideas around women's rights came into focus after attending a lecture in Hartford by 19-year-old, Anna Dickinson, on behalf of the Republican party. In 1870, she wrote a letter published in Putnam's magazine, a mother's letter to a daughter on women's suffrage. After attending women's rights conventions in New York and Boston, she founded the Connecticut women's association and society for the study of political science. Originally concentrating on women's rights to own

property. In addition to suffrage, she spoke on the need for female police officers as well. Isabella Beecher Hooker was at the forefront of the woman's movement. While

not as famous as her stepsister, Harriet, she was arguably the most influential member of the Beecher Family and it is not really known if she ever stepped foot in East Hampton.

H. King:

Yes. Thank you. Did anybody else get to do one? Okay, let me just skip to a Harriet Beecher Stowe because she was not born in East Hampton, but her book, "Uncle Tom's Cabin" was a huge influence leading up to the American Civil War. Roxanna Beecher was the first wife of Lyman Beecher. She lived in the house where Village headquarters are and she had a school there. Catharine Beecher also lived in the house in East Hampton and her description of the inside of the house is one of the few ways that we know where things were when the Beecher's lived there. Catherine Beecher, Roxanna, we did Harriet, Isabella and then Cornelia Huntington is important to the Civil War because in 1861, they put a flagpole, a Liberty Pole up on Main Street in between the Hunting Inn and the LVIS building, which in those days belonged to the Huntting family and the Gardiner family. Her odes were sung in 1861 at the beginning of the Civil War. Two more things and then I'm done. Tonight there's going to be a Historic Walking Tour sponsored by the East Hampton Historical Society, up and down Main Street and then tomorrow at 9:30, the Town is going to rename the park on Abrahams Path in honor of Lee Hayes, the great Tuskegee airman. That's all I got.

J. Larsen:

Great Hugh. Thank you very much. All right, next step June, we have two public hearings. Could you read the first?

The first is a public hearing with respect to the acceptance of a conservation easement from Lily Pond Equities by the Village of East Hampton over property located at 33 Lily Pond Lane, East Hampton, also known and designated on the SCTM as 301-13-13-11.1.

J. Larsen:

Great. Billy, would you mind just telling everybody what this is about?

B. Hajek:

Good morning, Mr. Mayor and members of the board. This is a requirement to comply with the Zoning Board of Appeals determination. The scenic easement covers the dune area on the seaward side of the property, and it just adds an extra layer of protection over the dune area. The benefit is that it puts future owners on notice that the area is to remain in a natural state free of structures.

J. Larsen:

Great. Any questions from the board?

A. Graham:

Yeah. I just had one. I got a lot of answers yesterday. Thank you, Billy. But there was one, they had lights in that front structure, those are going to be removed?

H. King:

Yes. Correct. The lights and the fencing are to be removed.

A. Graham:

Alright. So, all it's going to be left is the walkway down to the beach.

B. Hajek:

Correct and they have a stone revetment, obviously, that remains.

A. Graham:

Anything that saves and conserves property is a good thing.

J. Gambino:

There are no callers on the line.

Jody? No callers. He just sent me a text. No callers.

I saw the text. All right. So, can I get a motion to close the hearing?
