## **Mayor's Announcements**

Deputy Mayor Chris Minardi conducted the meeting in Mayor Larsen's absence. Mr. Minardi stated that all Village Beaches are closed due to poor weather conditions on Friday, September 15, and Saturday, September 16, and that this is also in effect within East Hampton Town.

# Hugh King - Parades and Village History in the Month of September

Village Historian Hugh King stated that the total number of parades held this year in the East Hampton Area, both Village and Town, is the highest ever. This includes the St. Patrick's Day Parade, Pride Parade, Hispanic Day Parade, 375<sup>th</sup> Anniversary of the Town of East Hampton Parade, and the Veteran's Day Parade. Mr. King then provided information on what had been accomplished in the month of September in Village history from 1920 to 1929. This included Village Voters defeating a proposition to pave Ocean Avenue and James Lane in 1921 and Village Ordinance #7, which allowed the Village Board or the Fire Chief or his assistant to enter buildings to check on improper storage of flammable or combustible materials with a fine of \$10 if found. Additionally, Edward Morfid, the first Police Chief in East Hampton Village, resided at what is now the 1770 House. During his time as chief, he opened up Dayton Lane in 1926, and managed the East End Hardware Corporation. In September of 1927, the purchase of Home Sweet Home was voted on by Village Residents and was bought for \$60,000. Mr. King then listed various shops' names and locations from the 1920's, and what stores are located there today.

# **Acting Chief, Captain Jeffrey Erickson**

Deputy Mayor Minardi announced that Captain and Executive Officer Jeffrey Erickson will be stepping forward as the Acting Chief of Police in absence of Police Chief Michael Tracey, who is utilizing accrued vacation days until he retires on March 1<sup>st</sup> of 2024. Mr. Minardi stated that it is a privilege and an honor to work beside Mr. Erickson. Village Administrator Marcos Baladrón explained Mr. Erickson's role as Executive Officer and his ability to be a part of every process that is accomplished at the Police Department. Mr. Erickson stated that he is both honored and humbled by the Board's decision to extend this opportunity. He then thanked the Emergency Services Department for their commitment to providing reliable service to the public. Mr. Erickson commended Lieutenant Jack Bartelme, who is being promoted to Executive Officer, for his loyalty and ability to cooperate with others. Acting Chief of Police Erickson thanked the Village Administrator Marcos Baladrón and Village Treasurer Dominique Cummings for their efforts in supporting the Police Department when creating the Village Budget. East Hampton Village Police Department is well funded, which is a reflection on the equipment, response time, and technology used daily to help those in need. He concluded by thanking his wife and daughter for their support throughout his career.

# **Executive Officer, Lieutenant Jack Bartelme**

Deputy Mayor Minardi congratulated Lieutenant Jack Bartelme who is being promoted to Executive Officer under Acting Chief of Police Jeffrey Erickson.

## New Hire, EMT - Paramedic Robert J. Capozzola

Mr. Minardi announced that Robert J. Capozzola is to be hired as an EMT. He added that the Village is excited to have Mr. Capozzola, as he will be a great addition. Acting Chief Erickson stated that Mr. Capozzola has worked part-time for the Village as a Paramedic for two years and that he stepped up when a full-time paramedic resigned. The Board of Trustees support the hiring of additional EMS personnel.
