Mr. Preiato: Good morning, Robert, Members of the Board. Also I think we wanted to be sure that included in this application was the additional retaining wall fencing that had changed substantially. Billy and I met on site and went over the fencing, both the wire fencing and the stockade fencing, and how it would be screened out front with the hedging and I do not have any zoning concerns at this point.
