With our continued partnership with MABAS 54, we saw many opportunities to provide mutual aid to our outlining communities and receive much-needed support during our calls for services throughout the year. Because of the level of risk during calls for service, our mutual aid support systems with our neighboring communities remain vital to our emergency operations. Last year we added Teutopolis Fire Protection District on automatic aid for all working fires in our district.

In closing, I would like to thank the members of this department and their families for their dedication to this organization and our community. We are fortunate to have an Administration and City Council supporting our mission to deliver the highest level of emergency service possible to the City of Effingham.

#### **Fire Department Highlights:**

2022 was a busy year for the Effingham Fire Department in terms of both call volume and overall operations. We were able to get back to normal after the past few years of COVID restrictions.

Station tours were able to resume after all the COVID restrictions were lifted. We were able to continue our Annual Open House and were able to team up with the Kasey Dog program for the open house and Fire Prevention Week. The program was available for two days during Fire Prevention week for local schools to attend.

Last year was our first year for our Santa Run. We drove Santa around all the neighborhoods of Effingham. It was a big success, and we plan on doing that again in December 2023.

Effingham City EMA had a transition. Dave Budde retired, and former paid-on-call firefighter Larry Thies took his position. Larry has been doing an outstanding job.

Our department's Facebook page had 530 new followers, which we strive to continually improve in reaching out to our community. To date, we have 6,933 followers on Facebook.

Our department provides various community training, including fire extinguisher training and all city employee CPR and Stop the Bleed training.

We added three new paid-on-call firefighters who began their firefighter training in the fall of 2022.

We received our new truck (575) in December, and members have been working hard to get it ready for service in early 2023. We also received new Scott SCBAs in December, and crews have been training with them to get them in service in the first part of 2023.

Calls for Service in 2022 totaled 687, an increase of 100 calls from the previous year. The call response summary for 2022 is as follows:

## Fire Prevention Bureau Summary - Assistant Chief Matt Kulesza:

Fire Prevention Bureau (FPB) over saw many projects in 2022 throughout the City of Effingham. FPB was involved with numerous new constructions as well as remodeling of existing businesses. Assistant Chief Kulesza worked hand in hand with newly appointed Chief Brant Yochum.

2022 was a successful year for FPB construction projects in Effingham. New construction and remodeling projects moved at a record pace for the 3<sup>rd</sup> continuous year. FPB worked with all business owners located along Fayette Ave. to relocate to new locations for the Fayette Ave. Road construction project.

FPB made changes to the department operations by assigning pre-plan inspections of commercial properties to the department duty crew. Each day, duty crew personnel were assigned business locations to visit and record the square footage of buildings, fire alarm locations, fire sprinkler locations, electrical and gas shut off, and building construction (wood-metal, etc.). Business owners and employees were able to recognize the importance of building pre-plans as a pro-active measure in the event of an emergency at their location.

There were over 48 projects reviewed/facilitated in 2022.

## **Emergency Management Overview - Coordinator Larry Thies:**

The City Emergency Management Agency plays a pivotal role in preparing the City for emergencies and coordinating the responses of State and Federal resources in the event of an emergency or natural disaster.

During 2022, EMA Coordinator Larry Thies oversees the movement of the Emergency Operations Center to a secure location within the City and will continue to work with City Staff to get the EOC fully operational during 2023. The primary goal is to make this space cohesive for all City Emergency Services and Departments to continue to operate for the betterment of our citizens when normal, everyday services that may be interrupted due to an unplanned event. The overall design will accommodate for interagency coordination and executive decision making that will play a critical role of the on-scene response.

EMA Thies will continue to respond to the scene directly serving as the primary liaison with homeowners that may need assistance from The American Red Cross and/or The Salvation Army. His other responsibilities will be providing and overseeing firefighter personnel support with any assistance they may need during a physically demanding structure fire.
