NOTICE IS HEREBY GIVEN that Early Voting for the April 6, 2021 Consolidated Election will commence at the County Clerk's Office on Friday, March 12th and conclude on Friday March 19th. Early Voting hours at the County Clerk's Office will be Monday through Friday 9:00 a.m. to 5:00 p.m. Early Voting will extend to the additional <u>sixteen</u> sites in Lake County on Monday, March 22nd and end on Saturday, April 3rd. During the weeks of March 22nd and March 29th, Early Voting hours are Monday through Friday 9:00 a.m. to 5:00 p.m., and Saturday 9:00 a.m. to 2:00 p.m. The four State Mandated Early Voting sites will remain open Sunday, March 28th from 10:00 a.m. to 4:00 p.m. During the week of March 29th, the four State Mandated Early Voting sites will extend their hours to 7:00 p.m. Monday through Friday, and to 4:00 p.m. Saturday through Sunday. On Monday, April 5th, the four State Mandated Early Voting sites will remain open from 9:00 a.m. to 7:00 p.m.

Grace Period Registration and voting will be offered at all Early Voting locations. Registered voters may access the Lake County Clerk's website at www.LakeVoterPower.info for information on their local Early Voting site. Early Voting sites, including hours, addresses, and phone numbers, are listed below. Each Early Voting site serves all Lake County voters.
