NOTICE IS HEREBY GIVEN that Early Voting for the April 6, 2021 Consolidated Election will commence at the County Clerk's Office on Friday, March 12<sup>th</sup> and conclude on Friday March 19<sup>th</sup>. Early Voting hours at the County Clerk's Office will be Monday through Friday 9:00 a.m. to 5:00 p.m. Early Voting will extend to the additional **sixteen** sites in Lake County on Monday, March 22<sup>nd</sup> and end on Saturday, April 3<sup>rd</sup>. During the weeks of March 22<sup>nd</sup> and March 29<sup>th</sup>, Early Voting hours are Monday through Friday 9:00 a.m. to 5:00 p.m., and Saturday 9:00 a.m. to 2:00 p.m. The four State Mandated Early Voting sites will remain open Sunday, March 28<sup>th</sup> from 10:00 a.m. to 4:00 p.m. During the week of March 29<sup>th</sup>, the four State Mandated Early Voting sites will extend their hours to 7:00 p.m. Monday through Friday, and to 4:00 p.m. Saturday through Sunday. On Monday, April 5<sup>th</sup>, the four State Mandated Early Voting sites will remain open from 9:00 a.m. to 7:00 p.m.

Grace Period Registration and voting will be offered at all Early Voting locations.
