Contractor shall furnish all material, do all work, pay all costs and shall in a reasonable time restore the Highway to a condition similar or equal to that existing before the commencement of the described work.

The installation shall be constructed at least two feet below the service and to the satisfaction of the Highway Superintendent. The Highway Superintendent shall conduct a post construction inspection. Contractor will submit building plans to Highway Department within 30 days of completeness.

Contractor shall assume all risk and liability for accidents and/or damages that occur due to the construction being conducted by Comcast.

Non-refundable fee of \$50.00 shall be paid to the Ela Township Highway Department upon issuance of permit per location.

**Right of Way Use and Standard Specifications**

- 1) Standard Specifications – The Illinois Department of Transportation Standard Specifications for Road and Bridge Construction, latest edition shall govern all work, except as modified herein.
- 2) Review Time - The Township Highway Commissioner shall require a minimum of \_\_\_\_\_ days for the purpose of reviewing plans, specifications and permit applications.
- 3) Fees - Non-refundable fees in the amount of **\$50.00** shall be paid to the Ela Township Highway Department upon issuance of the permit per location.
- 4) Installations – Any installations completed in the Ela Township Highway Department right-of-way shall be placed at no less than two feet from the surface.
- 5) Restoration – the Contractor shall restore the roadway & easement to a condition similar or equal to that existing before the commencement of work.
- 6) Adjoining Roads – All adjoining Roads shall be kept free of dirt and construction debris. Any dirt or construction debris tracked onto adjoining roads shall be removed as often as necessary throughout the course of the days to assure proper and safe travel of the motoring public.
