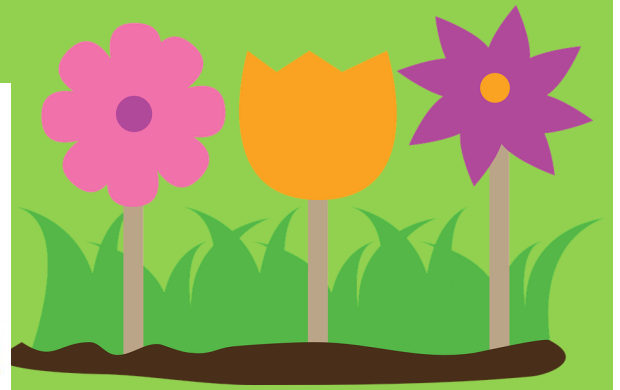

Drop Off & Pick Up:

Participants should be dropped off and picked up **inside** the main entrance of the Ela Township Community Center. Participants must be accompanied by an authorized adult (parent/guardian, baby sitter adult, etc.) to/from the Community Center for drop off/pick up, as we require participants to be signed in/out by their authorized adult. Arrival time is between 9:00 and 9:30; late arrivals are subject to director approval. Drop off at field trips is strictly prohibited.

******The Ela Township Spring Break Camp program ends promptly at 4:30 pm******

A \$5.00 fee will be assessed for late pickups. Up to the first 15 minutes is \$5.00 and an additional \$5.00 for every 15 minutes thereafter.

Behavior Expectations:

The following behavior expectations are in effect at all Ela Township Youth Department programs. Ela Township Youth staff may develop more expectations as they pertain to individual programs.

- * Children take responsibility for their actions.
- * Children respect themselves, other children and staff, and program equipment and environment.
- * Children participate in program activities to the best of their ability.

Program Dismissal:

Ela Township has the right to dismiss any child whose behavior, attitude, or action is, in our judgment, contrary to the best interests of our program community. This includes but is not limited to: destruction of property, excessive fighting or other aggressive behavior, harassment, bullying, sexual behavior, theft, excessive disobedience, or for other conduct that is ruining another child's experience or is harmful to the program. Ela Township will not dismiss any child without first consulting with the child's parent.

Child Behavior Contract

COVID-19 Information

The Ela Township Spring Break Camp program will be following all guidelines set in place by the CDC, the guidelines of District 95, field trip locations, the State, and the guidelines of the Ela Township. This can include but is not limited to policies set in place in regards to masks, social distancing, wellness questions/screenings, and more. Policies can vary with location (buses, and the field trip locations, in-door/outdoor areas). Vaccination policies will depend on each location as well. Parents picking up may be asked to either wait outside, or also follow all guidelines recommended by the CDC and the Ela Township.

Please be sure to stay home and notify staff if the participant, or anyone in the family is feeling ill, or has been exposed to a confirmed case of COVID-19. Our number one goal is to ensure the safety of all participants, staff, and members. The Ela Township must be aware of any possible risk to ensure we get out communication in a timely manner.

Assumption of the Risk and Waiver Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to be spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Ela Township Spring Break Camp program has put in place preventative measures to reduce the spread of COVID-19; however, Ela Township Youth Staff cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, **participation in the program could increase** your risk or your child(ren)'s risk of contracting COVID-19.

READ CAREFULLY BEFORE SIGNING-INITIAL EACH PARAGRAPH

____INITIALS By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending Spring Break Camp and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at Spring Break Camp may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Ela Township employees, and program participants and their families.

____INITIALS I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at Spring Break Camp participation in Spring Break Camp programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless Ela Township Spring Break Camp, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Ela Township Spring Break Camp, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Ela Township Spring Break Camp program. I DO NOT HOLD Ela Township, Ela Township Staff, and members of the Ela Township accountable for any accidents or the spread of COVID-19 that may occur as a result of participation in Spring Break Camp. I hereby authorize the Ela Township Youth staff to act for me, according to their best judgement, in any medical emergency.
