



## Discretionary Funding: Our Focus Today

### **Mandatory Federal Funding**

All spending that doesn't take place through appropriations

Entitlement programs (Social Security, Medicare)

Required interest spending on federal debt

¾ of federal government's own activities and spending

Typically, but not always, ongoing

### **Discretionary Federal Funding**

Subject to the appropriations process

Changes each fiscal year

Accounts for about a third of the federal government's own activities and spending

Sometimes in an omnibus bill

Department of Defense, major programs as well as other smaller programs

Almost all educational spending is discretionary with a few exceptions

Department	Programs
Agriculture including Rural Development	Farmers' Market & Ag Promotion; Ag Census; Senior/Youth Farm Purchasing programs; WIC/SNAP Through USDA RD: Water/Waste Infrastructure; Rural Housing; Electric Cooperatives; Grant/loan combination for w/ww, community facilities, business incubation; disaster recovery
Justice	Law enforcement grants for various audiences, to increase capacity internally and externally to meet new constituent needs
Commerce	Small Business Loans; EDA – TA, grants, loans, disaster recovery
National / Community Service	AmeriCorps, PeaceCorps, FoodCorps, etc.
Education	Multiple smaller programs; typically offered via states / school districts
Health & Human Services	Family & Youth Services Bureau; Aging; Primary Health Centers;
Housing & Urban Development	Rental assistance programs; developer incentives; TA in some cases; weatherproofing and home renovation for LMI populations (some by state vs fed); CDBG & Continuum of Care (CoC) programs
Transportation	DOT cost-shares and road financing, grants for bike/ped, and TA/planning Includes rail, aviation, water, transit, etc. as well as highways
Environmental Protection	Grants for pollution prevention, environmental education; Brownfields/Blueways
Nat'l Endowment for the Arts	Art, library, and community initiative programs
Interior	Historic, natural, and cultural preservation programs

## We don't need no stinkin' budget

It is the 23<sup>rd</sup> year in a row that Congress failed to pass appropriations prior to the start of the new fiscal year.

When this happens, we get a CR (Continuing Resolution) that allows the government to stay open temporarily – in this case, through Nov. 21, 2019.

#### **US House of Representatives**

- Passed 10 of 12 spending bills on time

#### **US Senate**

- Failed to pass any bills by the deadline

#### **Current Senate Status**

After failed negotiations after the end of the fiscal year, considered an omnibus of five bills:

- Agriculture, Rural Development, and the Food & Drug Administration;
- Commerce, Justice, and Science;
- Interior and Environment;
- Military Construction and Veterans Affairs; and
- Transportation and Housing & Urban Development

## Current Status of Budget Negotiations

#### Four Bills Passed October 31, 2019

- Agriculture, Rural Development,
   and the Food & Drug
   Administration;
- Commerce, Justice, and Science;
- Interior and Environment;
- Military Construction and Veterans Affairs; and
- Transportation and Housing & Urban Development

#### **August Agreement to Raise Spending Caps:**

- <u>increases spending caps and budget by \$320 billion</u> and authorizes additional borrowing with no deficit offsets
- Domestic up by \$100 bn; \$2.5 bn for 2020 census; \$10 bn more domestic than military

#### **Budgetary Effect of Budget Deal**

Component	Ten-Year Cost/Savings (-)
Direct cost of cap increases	\$320 billion
Offsets	-\$55 billion
Interest	\$95 billion
Subtotal, Direct Cost	\$360 billion
Effect on baseline	\$1.2 trillion
Interest	\$155 billion
Total	\$1.7 trillion

## More for Local Governments

**Opioid epidemic response:** H.J. Res. 31 makes continued investments in key justice and public safety programs that help counties address the nation's ongoing opioid epidemic.



**Payments in Lieu of Taxes (PILT):** The FY 2019 appropriations bill fully funds the Payments in Lieu of Taxes (PILT) program, a majority priority for NACo and a critical source of support for public lands counties.



**Rural broadband:** The FY 2019 omnibus package makes new investments in rural infrastructure and pilots a program to build out broadband systems in rural areas without broadband.



**Homeless assistance and economic development funding sustained:** Essential federal funding streams counties use for economic development and housing assistance remain robust, including funding for the Community Development Block Grant (CDBG) and homeless assistance grants.



**State Criminal Alien Assistance Program (SCAAP):** The State Criminal Alien Assistance Program (SCAAP) receives a funding increase, helping states and counties recoup costs for incarceration in local jails.
