Dear Fairfax and San Anselmo Council members

While I'm against large scale, out of character building in Ross Valley towns, and adding more residents than town infrastructures can handle (roads, schools, grocery stores, parking, not to mention limited local job opportunities leading to more commute traffic), I do believe Ross Valley towns need to find ways to offer housing to people of diverse incomes.

I'd like to suggest Town sponsored workshops explaining various creative housing solutions to potential renters and buyers as well as current landlords and potential landlords.

A comprehensive workshop, which I think could be led by volunteers, would offer explanations of things such as; existing shared housing models, buying tenants in common, how to best navigate creative loan and financing options, navigating current laws and assessing the cost/benefit analysis of building JADUS and ADUS, and how existing real estate laws and local ordinances affect tenants and landlords.

I also propose towns offer free help to first time small scale landlords -especially the elderly, in renting out cottages and rooms - how to select tenants and do background checks so the landlord feels safe and supported in the process. This will help remove current hurdles to affordable infill rentals. (As a 30 year owner of two Fairfax cottages, I know first hand that the current Fairfax just cause ordinance and vilification of landlords is inhibiting potential landlords from renting and therefore reducing, not expanding the number of available rentals.)

Lastly Towns could establish a volunteer commission to host meetings about shared housing models (Danish Co-Housing, for instance) and keep lists of people looking for such options, both to buy and to rent. The commission could work with local realtors to get promptly notified of properties suitable for shared living. There are properties in places like Oak Manor and Sleepy Hollow that could easily be renovated to accommodate two families and even three with an ADU, potentially mixed ownership and rental.

I grew up in Fairfax in a low income family and my parents often housed friends in need. Many of us long term Ross Valley people know the value of a diverse community and are proponents of low income rentals. We'd like our elected leaders not to be punitive to small scale landlords but to be proactive, realistic and creative about how affordable rentals could be offered- without overbuilding/overcrowding our unique and beloved towns with huge projects stating up front that 80% of the units will be 'moderate' prices.

Thank you for considering this perspective on how Ross Valley Town leadership can support affordable housing options.


