DISCUSSION

Every month, each Councilmember provides a list of the meetings they attended in the preceding month on behalf of the Town, for inclusion in this report. Under the agenda section entitled "Council Reports and Comments" Councilmembers may choose to highlight one of those meetings.

Mayor Coler

March 5, 12, 25 – met with Town Manager on Council matters.

March 9 – Wall Property Fundraiser held at the Women's Club - primary speaker was Wendy Dreskin, naturalist who has identified many of the species at the property and taught St. Rita's classes there and more

March 13 – Wall Property meeting with MOST reps. FOSC rep and the property owner. Other speakers were Councilmember Cutrano, Bill Long of MOST and Christine Kelly of FOSC. Susan Pascal Beran Chair of FOSC led the evening, about 50 people attended.

March 13 – Ross Valley Fire Board meeting – attended as the alternate Board member as Fairfax reps could not attend due to other conflicts. Chief Mahoney stated that March 23rd there will be a Countywide Alert test at 10am (this is the 1st countywide test).

March 14 – Marin Wildfire Prevention (MWPA) Ad Hoc Committee meeting on JPA Agreement amendments. When completed with the Ad Hoc, the agreement will be brought to the Marin Managers and then the Operations Committee. Then, ~June/July, the agreement will be presented to the full Board for review/approval when completed. The JPA amendment will be brought to Member jurisdictions subsequently for approval~ December 2024 or January 2025.

Mar 16 – Attended Wall Property fundraiser hosted by several Town businesses.

Mar 19 - Agenda setting mtg - for April 3rd Council meeting with Vice Mayor Blash and Town staff.

March 19 – Wall Property meeting with MOST representatives, TM Abrams, PW Director Umbertis and Councilmember Cutrano to discuss due diligence matters.

March 21 – Marin Wildfire Prevention Authority (MWPA) – The Board adopted a Resolution increasing the MWPA tax levy by 2.4% for the 2024-2025 tax year, as permitted by Measure C. The Board approved: the 7th amendment to the professional services agreement with Charlotte Jourdain for consulting services (not to exceed \$100K) – she works on strategic goals, develops grants and more; the proposed legal services agreement with Remy Moose Manley, LLP ("RMM" – annual not to exceed \$100k) for continued environmental compliance legal work; and a modification to "Environmental Compliance for Core Projects" for a FY2023-24 Work Plan Item for a San Rafael CORE project. The Workplan update included info on two field trips held by MWPA: the 2nd annual Field Skills Refresher course for Member Agency staff on February 22 - topics included rare plants, invasive plants and Early Detection and Rapid Response protocols, nesting birds, environmental regulations around riparian protections, and erosion

and slope stability; the ESP Partnership, San Rafael Fire, Ross Valley Fire, and the Town of San Anselmo hosted a public field trip to view the initial treatment area within the San Rafael – San Anselmo Fuel Reduction Zone Project on February 13. Approximately 50-60 people attended -more info and updated FAQS—are https://www.marinwildfire.org/project/the-san-rafaelsan-anselmo-fuel-reduction-zone-project-san-rafael-zone-cost-share. Fire Safe Marin and MWPA will hold Ember Stomp 2024 on Saturday, September 7 from 11-5 – SAVE THE DATE! Staff presented how Willow Labs is doing wildfire risk modeling – their work is progressing towards the development of a data-driven wildfire risk assessment framework, enabling member agencies to prioritize the most impactful risk reduction efforts, across the conceptual division of built environment (Defensible Space/Home Hardening) vs. open space (vegetation management and splats), and over time. In FY 2024-25, Willow Labs will include Fire Pathways Modeling and Strategically Placed Local Area Treatments (SPLATS) in its risk assessments. Staff provided summary of a white paper prepared by MWPA staff as well as current and future related resources on Shaded Fuel Breaks.

March 21 – MCE Clean Energy – The Board approved: the Proposed Fiscal Year 2024/25 budget. Staff presented a discussion of proposed transfers to a new reserve account for potential acquisition of power supply facilities and a MCE building (rather than renting) – Coler and others on the Board asked for evaluation of using excess reserves to lower MCE rates again (to be an even greater delta less than PGE), for creation of committee(s) to further evaluate the potential acquisitions (community members who attended also asked for a more inclusive, longer term evaluation of such acquisitions).

March 22 – Fairfax Age Friendly meeting – Discussion of April 13 Senior Fair at the Library, some Age Friendly reps will table there. Next meeting is May 17.

March 25 - Marin County Mayors & Councilmembers (MCCMC) Legislative Committee meeting -Kyra Ross our lobbyist reported that the three leaders (Senate, Assembly & the Governor) are seeking early action to cut \$17-18B from the budget deficit (LAO states there is a \$73B deficit which is much larger than the Governor's estimate of \$38B). The Legislature is in recess until early April, over 2,100 bills have been introduced this session. The Committee voted to send a support letter on: AB 1778 (Connolly) – for Marin only, no one under 16 can ride a Class 2 e-bike and those 16 and over must wear a helmet of Class 2 e-bikes (locals have to adopt resolutions). Oppose letters will be sent on: AB 3005 (Wallis) - suspends the Motor Vehicle Fuel tax adjustments; SB 937 (Weiner) - defers collection of development fees until a Certificate of Occupancy is issued. Several bills will continue to be watched or action may be taken on positions at the April meeting. MCCMC LEGISLATIVE COMMITTEE SCOPE OF ADVOCACY: Fiscal Protection: protect city revenues from state Local Control: support legislation that enhances local control of resources to provide services while supporting regional co-operation. Oppose unfunded mandates and preemption of local authority and control of land use Transportation Investment: promote stable transportation finance structure for state and local government. Multimodal, enhancing livable communities Housing/Land use: protect local government land use authority. Oppose punitive housing legislation, and legislation that restricts or reduces local discretion on land use decisions. Other legislation can be recommended to MCCMC at a regular meeting.

March 25 – Fairfax Chamber of Commerce monthly meeting - with Mayor, Town Manager, Deputy Town Clerk and reps from the Chamber - Reps attending were Minna Kim, Breanna Gubbins and Stacy Messerschmidt.

March 27 – Land Use Element update discussion (which is required to complement the Housing Element) with Town staff, Councilmember Cutrano and Housing Element Consultants.

In November of 2022, the Marin County Board of Supervisors authorized an increase in the living wage in Marin from \$16.80 to \$18.00, which had a great impact on In-Home Supportive Services workers in the County. Marin still pays less for these workers than many Bay Area counties. This event was intended to highlight the value of caregivers in Marin County and how their dedication and skill has made a difference in the lives of our community's disabled persons and older adults in need of homecare.

HIGHLIGHTS

Marin Emergency Radio Authority (MERA)

As reported in the Marin Independent Journal on March 1st, the Marin Emergency Radio Authority's upgrade from our first-generation system to our "NextGen" system is nearing completion. The \$74 million upgrade for Marin County's emergency radio system is on track to finish construction this month and to begin operating by October. You can read the IJ story here.

As a refresher, twenty-five law enforcement, fire and public works agencies across the county communicate to dispatch centers using the MERA system; however, the first-gen system designed in 1998 has reached the end of its life, requiring equipment that is no longer made. MERA staff continue to rely on spare parts from other outdated systems around the country to ensure that the first-gen system can successful maintain the more than 2.3 million calls annually made over the system.

Fortunately, we are nearing completion! Below you will find the project chart from when I joined MERA in March of 2021. Alongside that chart is the project update from our most recent Governing Board meeting. (Green is good.)

<u>Transportation Authority of Marin (TAM)</u>

The Town of Fairfax's partnership with the County of Marin to rehabilitate Fairfax-Bolinas Road is proceeding. And I wanted to share some exciting updates below:

- Earlier this year, Supervisor Mary Sackett, as a member of the Marin County Board of Supervisor's Legislative Subcommittee, visited Washington D.C. with Talia Smith, Principal Administrative Analyst in the County Executive's Office, to advocate for several projects in Marin. They met with Congressman Huffman, Senator Butler and Senator Padilla's staff, and the Department of Transportation to discuss the rehabilitation of the Fairfax-Bolinas Road. (They also lobbied for federal support for the Fairfax San Anselmo Children's Center.)
- On Wednesday, February 21st, Town Manager Abrams, Public Works Director Umbertis and I joined Congressman Jared Huffman, Supervisor Katie Rice, County staff, Marin water staff, and representatives from Marin Office of Emergency Services and Marin County Fire for a tour of Fairfax-Bolinas Road and a discuss of the vital role this roadway plays for regional water supply, wildland fire access, emergency evacuation, and recreation.  Our tour of Fairfax-Bolinas Road was the front-page story (see below) for the Marin Independent Journal on Thursday, February 22nd. You can read the IJ story here. Congressman Huffman also tweeted his support for the project and his commitment to help us get federal funding (see below)



 On Wednesday February 28th, the County of Marin, in partnership with The Town of Fairfax, officially submitted our 36-page grant proposal to the U.S. Department of Transportation (USDOT) for their Rebuilding American Infrastructure with Sustainability and Equity (RAISE) discretionary grant program.
