May 16 – Marin Wildfire Prevention Authority Board meeting – The Board: approved the Annual Budget for FY24/25 (the projected revenue for FY 2024/25 is \$21,907,664); adopted the extensive FY 24/25 Workplan (the Operations Committee developed the strategy for the FY 24/25 WP as: Continue the "House Out" approach; • Continue to reduce wildfire risk to communities by providing resources directly to residents for home hardening and defensible space activities; • Prioritize shaded fuel breaks directly adjacent to communities and explore the potential for strategically placed local/landscape area treatments (SPLATs) informed by pathways modeling; • Expand the use of prescribed fire and public education and involvement around beneficial fire; • Continue to prioritize evacuation planning and projects to improve safe and efficient evacuations; • Partner with insurance companies and the Insurance Institute for Business & Home Safety (IBHS) to help avoid insurance cancellations and control costs for homeowners; and • Increase public education, particularly to new audiences. Support activities that fire agencies and Marin residents can take, such as home hardening and defensible space (particularly Zone 0); safe evacuations; and reducing human-caused ignitions). The Board: acknowledged that the JPA-wide Direct Assistance Program CEQA was completed and approved the Project (a program to assist residents

in performing certain defensible space activities identified during defensible space inspections by working with contractors directly to perform the work – it would be managed by Marin Wildfire staff in collaboration with Member Agencies and defensible space inspectors. Activities would prioritize fire hazardous fuels within 30 feet of homes (zones 0 and 1) but could include work within up to 100 feet of homes in some cases – up to \$266K allocated for FY 24/25); authorized the EO to sign an agreement with Panorama Env. for continued environmental services; authorized the EO to designate staff members to sign Task Orders less than \$200k. Letters of intent were requested by June 1 for those wishing to be considered for Board President and VP (Rachel Kertz is current VP and should ascend to President in July). Note: the Chipper Program budget has been increased to \$1.5M.

May 16 – Countywide Priority Setting Committee (PSC) meeting – the PSC makes recommendations to the Board of Supervisors (BOS) on allocations of HUD \$\$ (and some State \$\$) primarily to non-profits—this year for the entire County there is: CDBG (HUD) ~\$1.6M, HOME (HUD) \$705K, and PHLA (State) \$1.2M. The funds are allocated BTW Housing, Capital and Public Services by specified formulas. The PSC is made up of electeds from each of the cities/towns/County and community reps of protected classes

from the planning areas. Recommendations were made by the PSC that will go to the Board of Supervisors June 4th for finalization prior to sending to HUD. Two representatives on the PSC have sadly passed away – Kevin Carroll, Larkspur Councilmember (on the PSC a short time but made a large impact) and Cathy Cortez (the at large community member who made a tremendous impact over eleven years). May 20 - Marin County Mayors & Councilmembers (MCCMC) Legislative Committee meeting -The Committee approved sending oppose letters for: SB-937 (Weiner) defers cities collection of fees on developments until certificate of occupancy is issued; AB - 1886 (Alvarez) builders remedy stays available until HCD declares that Housing Element is in compliance (can take months or years); AB 1893 (Wicks) – oppose unless amended position – builders remedy is available if the City has failed to adopt a compliant HE – but they can deny if the developer may have not met objective development standards. The Committee approved sending a support letter on AB 2485 (Carrillo) which requires HCD to reveal their analyses, data and methodology for determining RHNAs. The Committee took an emergency action to allow Chair Fredericks to send an oppose letter on the proposed budget taking excess ERAF money away from cities/counties and providing to Charter Schools - this would allow our lobbyists to lobby against this new position (in Marin County this would cut \$700K from the County budget that is distributed to cities/towns. MCCMC LEGISLATIVE COMMITTEE SCOPE OF ADVOCACY: Fiscal Protection: protect city revenues from state Local Control: support legislation that enhances local control of resources to provide services while supporting regional co-operation. Oppose unfunded mandates and preemption of local authority and control of land use Transportation Investment: promote stable transportation finance structure for state and local government. Multimodal, enhancing livable communities Housing/Land use: protect local government land use authority. Oppose punitive housing legislation, and legislation that restricts or reduces local discretion on land use decisions. Other legislation can be recommended to MCCMC at a regular meeting.

May 23 – Community Media Center of Marin (CMCM) Board meeting – The Board discussed the need for a new Designated Access Provider Agreement (DAP) with the Marin General Services Authority (MGSA)

- MGSA will grant an extension of the current DAP for a year; the CMCM Board voted to provide an extension resolution to MGSA for one year & that the Executive Committee (Bruce Bagnoli, Greg Clarke, Coler) plus Steven Tulsky will work on revisions to the current DAP. CMCM staff have filmed over 50 government meetings since the last Board meeting a month ago.

May 24 – Age Friendly Fairfax meeting – held at Victory Village - discussion of 10-year anniversary of Age Friendly Fairfax; tabling at the Fairfax EcoFest; Oct 19 for 90+ celebration. Annie Young of Bennet House, Shaun Duncan of VV (she hosted the mtg) and Julie Young of the San Geronimo Community Center all met and shared ideas for programs at their respective locations for older adults. Willow Taraja of the Fairfax Library discussed the success of the Maker Faire on May 18 and upcoming programs with ESCOM teaching IPhone/Android and Protecting Online Privacy at the Library in June and July, respectively.
