SUBJECT:	Adopt Five Resolutions Setting Taxes to be Collected by the Marin County Auditor-Controller for Fiscal Year 2024-25

RECOMMENDATION

Staff recommends that the Town Council adopt the five resolutions necessary to set various tax rates to be collected by the Marin County Auditor-Controller for Fiscal Year 2024-25.

BACKGROUND

Annually, the Town of Fairfax is required by the County Auditor-Controller to adopt resolutions or ordinances that establish new or continue existing tax assessments crucial for funding municipal services and obligations. This year's proposed resolutions are vital for maintaining the consistent delivery of town services and meeting our fiscal responsibilities. These include taxes supporting general municipal services, utility usage, pension obligations, stormwater pollution prevention, and infrastructure improvements through general obligation bonds.

DISCUSSION

Tax rates to be collected by the Marin County Auditor-Controller for Fiscal Year 2024-25:

- 1. **Special Municipal Services Tax**: Extended by voter approval in November 2019, the tax rate is set at \$215 per unit for FY 24-25, reflecting a statutory \$5 increase from the previous year. The rate may increase annually by up to \$5 until reaching a cap of \$250.
- 2. **Utility Users Tax**: The rate remains steady at 4% of telephone, gas and electricity usage, unchanged from the previous year. The ordinance allows for up to 5% to be charged.
- 3. **Pension Tax**: Set at \$.091 per \$100 assessed valuation, this rate remains consistent with the previous year to support Fairfax's pension obligations.
- 4. **Stormwater Pollution Prevention Fee**: The fee is set at \$15 per runoff unit, unchanged from the previous year, to fund local stormwater pollution prevention activities.
- 5. **Measure K Bond Assessment Tax**: The rate remains steady at \$.0225 per \$100 assessed valuation to fund payment of the Measure K General Obligation Bonds which funded road repairs.

FISCAL IMPACT

The adoption of these resolutions is essential for ensuring the projected revenues required to balance the town's budget for FY 2024-25.

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX SETTING THE AMOUNT OF THE SPECIAL MUNICIPAL SERVICES TAX FOR FISCAL YEAR 2024-2025

WHEREAS, Ordinance No. 839 was approved by the voters of the Town of Fairfax at a special election held in the jurisdiction on November 5, 2019; and

WHEREAS, Ordinance No. 839 authorizes the Town of Fairfax to levy a Special Municipal Services Tax to be imposed and levied through June 30, 2031; and

WHEREAS, the Town Council has reviewed a preliminary Operating and Capital Budget for Fiscal Year 2024-25 as presented by the Town Manager, and has determined that in order to maintain the current level of municipal services as well as the long-term fiscal health and stability of the Town, and to maintain the Town's excellent bond rating, the full assessment of this Special Municipal Services Tax for Fiscal Year 2024-25 is a necessity; and

WHEREAS, the Town Council has also determined that for the fiscal year commencing July 1, 2024, without the levy of this Special Municipal Services Tax, the cost of providing municipal services will exceed the amount of funds and revenues generated from all other sources of income;

NOW, THEREFORE, BE IT RESOLVED, that the Town Council of the Town of Fairfax authorizes the amount of the Special Municipal Services Tax to be levied and imposed for the 2024-25 fiscal year pursuant to Fairfax Ordinance No. 839 shall be as follows:

- a) A tax is hereby levied and imposed upon improved residential property at the rate of two hundred and fifteen dollars (\$215.00) per dwelling unit.
- b) A tax is hereby imposed and levied upon improved business property at the rate of two hundred and fifteen dollars (\$215.00) for each business occupant and two hundred and fifteen dollars (\$215.00) per dwelling unit.

The foregoing Resolution was duly passed and adopted at a regular meeting of the Town Council of the Town of Fairfax held in said Town on the 5th day of June 2024, by the following vote, to wit:

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX SETTING THE AMOUNT OF THE UTILITY USERS' TAX FOR FISCAL YEAR 2024-2025

WHEREAS, Ordinance No. 552 requires that the rate of the Telephone, Gas and Electricity Users' Tax shall be set annually by Resolution; and

WHEREAS, the Town Council has reviewed a preliminary Operating and Capital Budget for Fiscal Year 2022-23 as presented by the Town Manager, and has determined that in order to maintain the current level of municipal services as well as the long-term fiscal health and stability of the Town, and to maintain the Town's excellent bond rating, the assessment of this Utility Users' Tax for Fiscal Year 2024-25 is a necessity; and

WHEREAS, the Town Council has also determined that for the fiscal year commencing July 1, 2023, without the levy of this Utility Users' Tax, the cost of providing municipal services will exceed the amount of funds and revenues generated from all other sources of income; and

WHEREAS, the Town Council has also determined that for the fiscal year commencing July 1, 2023, the cost of providing municipal services will require a 4% rate for the Utility Users Tax, which is the same as was assessed for Fiscal Year 2023-24.

NOW, THEREFORE, BE IT RESOLVED that the Town Council of the Town of Fairfax authorizes the amount of the Telephone, Gas and Electricity Users' Tax for Fiscal Year 2024-25, shall be at the rate of four percent (4%).

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX SETTING THE PENSION TAX RATE TO SUPPORT FAIRFAX PENSION OBLIGATIONS FOR FISCAL YEAR 2024-2025

WHEREAS, the Town of Fairfax has had a Pension Override Tax as an assessment since the 1960s; and

WHEREAS, the Pension Override Tax serves to pay toward the funded and unfunded pension obligations of the Town for Safety and Miscellaneous employees; and

WHEREAS, the Town Council has reviewed a preliminary Operating and Capital Budget for Fiscal Year 2024-25 as presented by the Town Manager and has determined that in order to maintain the current level of benefits and meet the funded and unfunded pension liability through the California Public Employees' Retirement System (CalPERS), the full assessment of this special municipal services Tax for Fiscal Year 2024-25 is a necessity.

NOW, THEREFORE, BE IT RESOLVED, that the Town Council of the Town of Fairfax authorizes the amount of the pension tax rate upon all of the taxable property within the Town of Fairfax to support Fairfax Pension Obligations for Fiscal Year 2024-25 to be \$.091 per \$100 assessed valuation.

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX S ETTING A FEE FOR THE PURPOSE OF FUNDING LOCAL STORMWATER POLLUTION PREVENTION ACTIVITIES FOR FISCAL YEAR 2024-25

WHEREAS, Ordinance No. 646, Adopting a Regulatory Fee to Fund Clean Stormwater Activities was adopted by the Fairfax Town Council in December 1995, after due consideration and public input; and

WHEREAS, Ordinance No. 646 allows the Town to recover the costs of specified projects and activities through the establishment of a fee per "run-off unit;" and

WHEREAS, the Town Council has reviewed the stormwater pollution prevention activities and projects which are to be funded by the fee "per run-off unit" and considered the needs of the Town of Fairfax for these important activities and projects.

NOW, THEREFORE, BE IT RESOLVED, that the Town Council of the Town of Fairfax authorizes the fee per run-off unit is established for Fiscal Year 2024-25 at fifteen dollars (\$15) which is to be collected annually by the Marin County Tax Collector with the property tax billings.

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX SETTING THE TAX RATE IN CONNECTION WITH ITS GENERAL OBLIGATION BONDS (MEASURE K BOND ASSESSMENT) FOR FISCAL YEAR 2024-2025

WHEREAS, more than two-thirds of the qualified voters in the Town of Fairfax (the "Town"), voting at a municipal election on November 2, 1999, approved the issuance of up to \$6,830,000 of general obligation bonds to finance the acquisition and construction of capital improvements to various streets and storm drains within the Town and to the Town's community facilities within the Town; and

WHEREAS, pursuant to the authorization received at such election, the Town has issued three series of general obligation bonds authorized as described above in an aggregate principal amount of \$6,830,000; and

WHEREAS, bonds are general obligations of the Town payable solely from *ad valorem* property taxes levied by the Town and collected by the County of Marin and the Town Council is empowered and is obligated to annually levy *ad valorem* taxes for the payment of the bonds and the interest thereon upon all property within the Town subject to taxation by the Town, subject to the limitations set by the voters on November 2, 1999;

NOW, THEREFORE, BE IT RESOLVED that the Town Council of the Town of Fairfax authorizes the levy of an *ad valorem* tax for fiscal year 2024-25 for the payment of the bonds on property in the Town at the rate of **.0225** per \$100 of assessed valuation.

This resolution shall take effect from and after the date of its passage and adoption.
