DISCUSSION

The Planning Commission serves as an advisory body to the Town Council on planning policies and regulations. The Commission is responsible for bringing a broad variety of expertise and experience in reviewing:

- Planning applications
- Fairfax ordinances
- The Town General Plan and Housing Element.

There is currently one vacancy on the Planning Commission. The term of this vacant position is a full four-year term. The Town began soliciting for Planning Commission applications in April by advertising the vacancies on the Town's website and in several newsletters. The Council conducted one interview at the June 5, 2024 regular meeting, but did not make an appointment to allow for other candidates to interview.

I received both undergraduate and graduate degrees in Urban Planning from Cornell University. After graduate school, I went to work for Nelson\Nygaard, a dynamic, national transportation consulting firm, which afforded me five years of varied, complex transportation planning experience across the country. I devised contextually sensitive plans in the fields of bicycle and pedestrian planning, Transportation Demand Management, and parking management, and authored reports on the links between transportation and land use. I wrote general plans, station access studies, and bicycle and pedestrian plans. In 2015, I changed gears and went to work in private real estate development. Since then, I have managed the design process, approvals process, financing process, and construction of four mixed-use infill projects in Sonoma and San Luis Obispo counties. My role has given me a front-row seat to the interface between the public and City Planning Commissions. My current role also includes public outreach efforts, public meetings, and cross disciplinary collaboration, all of which I believe are useful skills to have in a future Commissioner.
