SUBJECT: Adopt a Resolution Authorizing the Town Manager to Purchase and Outfit

Two Police Department Patrol Vehicles (HYBRID) for an amount not to

exceed \$170,000.

RECOMMENDATION

1. Adopt a resolution authorizing the Town Manager to purchase and outfit two (2) Police Department Patrol Vehicles for an amount not to exceed \$170,000.

2. Appropriate \$170,000 from the Field Equipment/Vehicle Replacement Fund (03-923-921) for this purchase.

BACKGROUND

The Town council approved the adopted FY23-24 Town Budget funds for the purchase of necessary Town Vehicle for Fleet Electrification as shown in the Field Equipment/Vehicle Replacement Fund 03-923-921.

DISCUSSION

To support the Town Council in achieving the goal of reaching 100% Zero Emissions Vehicle Sales in California by the year 2030 (as adopted by resolution in November of 2020), and in accordance with the Town Fleet Zero-Emissions Vehicle Policy adopted on November 1, 2023, Staff identified the 2025 Ford Explorer PIU Hybrid as a viable option for a Hybrid Police Department Patrol use vehicle.

Two (2) 2025 Ford Explorer PIU Hybrids will be purchased through the government and state bid pricing from Towne Ford and outfitted by our authorized vendor, LEHR. The quote for the two (2) new vehicles, emergency equipment and outfitting are approximately \$164,262.08 including taxes. While not anticipated, Staff is requesting authority for a not to exceed amount of \$170,000 to account for any unforeseen pricing or installation charge changes.

The purchase of first 2025 Ford Explorer PIU Hybrid vehicle will replace a fully gas operated 2014 Ford Taurus that is no longer serviceable. Maintenance costs/repairs over the past three years have exceeded approximately \$21,300 for this vehicle in order to keep it in service. Current pending and necessary repairs exceed the value of the vehicle. The purchase of the second 2025 Ford Hybrid vehicle will replace another fully gas operated 2014 Ford Taurus that is no longer serviceable. Maintenance costs/repairs over the past three years have exceeded approximately \$14,800 for this vehicle in order to keep it in service. Current pending and necessary repairs exceed the value of the vehicle.

One of the outgoing 2014 Ford Taurus vehicles will be disposed of through public auction or sale or declared as junk. It is customary procedure to declare by Resolution such vehicles as surplus in order to

dispose of them. The other 2014 Ford Taurus will be converted into a non-patrol use vehicle and used for other means that can provide a service to the police department, such utilizing the vehicle for our mobile radar program, training use, extra patrol efforts, and special enforcement operations.

FISCAL IMPACT

The Field Equipment/Vehicle Replacement Fund 03-923-921 has an available total amount of \$195,002 as approved by the Town Council in the adopted FY23-24 Town Budget.

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX AUTHORIZING THE TOWN MANAGER TO PURCHASE AND OUTFIT TWO POLICE DEPARTMENT PATROL VEHICLES (HYBRID) FOR AN AMOUNT NOT TO EXCEED \$170,000

WHEREAS, the Town Council approved the adopted FY23-24 Town Budget, which includes funds for the purchase of necessary Town Vehicles for Fleet Electrification as outlined in the Field Equipment/Vehicle Replacement Fund 03-923-921; and

WHEREAS, the Town Council has set a goal of achieving 100% Zero Emissions Vehicle Sales in California by the year 2030, as adopted by resolution in November 2020, and in accordance with the Town Fleet Zero-Emissions Vehicle Policy adopted on November 1, 2023; and

WHEREAS, the 2025 Ford Explorer PIU Hybrid has been identified as a suitable vehicle for the Police Department's Patrol use; and

WHEREAS, two (2) 2025 Ford Explorer PIU Hybrids will be purchased through government and state bid pricing from Towne Ford and outfitted by our authorized vendor LEHR, with a quote for the two new vehicles, emergency equipment, and outfitting totaling approximately \$164,262.08 including taxes; and

WHEREAS, staff requests authority for an amount not to exceed \$170,000 to account for any unforeseen pricing or installation charge changes; and

WHEREAS, the first 2025 Ford Explorer PIU Hybrid will replace a fully gas-operated 2014 Ford Taurus that is no longer serviceable, with maintenance costs over the past three years exceeding its current value and current pending repairs exceeding the vehicle's value; and

WHEREAS, the second 2025 Ford Explorer PIU Hybrid will replace another fully gas-operated 2014 Ford Taurus that is no longer serviceable, with maintenance costs over the past three years exceeding its current value and current pending repairs exceeding the vehicle's value; and

WHEREAS, the Fiscal Impact on the Field Equipment/Vehicle Replacement Fund 03-923-921 has an available total amount of \$195,002 as approved by the Town Council in the adopted FY23-24 Town Budget, enhancing the efficiency and sustainability of the town's fleet.

NOW, THEREFORE, BE IT RESOLVED that the Town Council of the Town of Fairfax, California hereby authorizes the Town Manager to:

- 1. Purchase and outfit two (2) Police Department Patrol Vehicles (2025 Ford Explorer PIU Hybrids) for an amount not to exceed \$170,000.
- 2. Appropriate \$170,000 from the Field Equipment/Vehicle Replacement Fund (03-923-921) for this purchase.
- 3. Dispose of one of the outgoing 2014 Ford Taurus vehicles through public auction sale or by declaring it as junk and convert the other 2014 Ford Taurus into a non-patrol use vehicle.
