#### Parks & Recreation Commission

#### Climate Action Committee

There are currently two vacancies on the Climate Action Committee ("CAC"). The applicant being considered tonight is Adrianna Smyth.

The CAC was established to help implement the Climate Action Plan, <u>adopted by the Town Council</u> on February 5, 2014. Its mission is to mitigate the production of greenhouse gas and compile existing and potential strategies to address climate change.

CAC develops an annual Action Plan as well as any recommended amendments to the Climate Action Plan.

I have a PhD in Ecology from UC Berkeley and have been passionate about sustainability throughout my entire adult life. I am currently doing a second PhD at Prescott College in Sustainability Education, which focuses not only on traditional topics in sustainability but also on social and environmental justice as bedrocks of true sustainability. Currently I am a high school science teacher at San Domenico School, and for years have taught and refined a course in Climate Change for high school junior and seniors. I have spearheaded climate change and sustainability initiatives and committees at several Bay area private high schools, and have had two students win Brower Youth Awards. I am currently the upper school Sustainability Lead at San Domenico. I love working with others to engage in sustainability solutions!

# Q8

#### What is your vision for the Town of Fairfax?

I imagine Fairfax being a model for what is possible in terms of climate action and sustainability. As a relatively small town with loving and engaged citizens, many of whom are passionate about protecting natural systems, enhancing social and economic equality, and maintaining our strong sense of community, we are poised to show what is possible. In my vision, we drastically reduce vehicle traffic, while enhancing open community space, free of asphalt, throughout the central part of town. There is no end of cool ideas of how this space could be utilized, but native plants and signage about their importance to biodiversity should be everywhere, and we should consider rooftop gardens to fight warming and provide food wherever feasible. Roads in and around town need to be safer and friendlier to bicycles, and the vast majority of people are using ebikes or other non-gas powered vehicles to get around. Electric shuttles to key destinations are free and people can hop on and off to get to the Good Earth, or to

Deer Park, or Victory Village, or into San Anselmo. We need to put our heads together to figure out a solution for the flotillas of delivery trucks making multiple visits to the same streets every day - putting fumes and CO2 into the air, clogging traffic, making a lot of noise, and generally reducing quality of life for everyone. At the same time, we need to confront the desire for convenience that drives so many people to order items from across the world - that exploit workers, create excessive carbon emissions in production and transportation, and lead to tremendous amounts of packaging waste. In my perfect world, we want less stuff, and can easily find what we really need at local businesses. We can make climate resiliency a foundation of our community, holding very visible and wellpublicized workshops and other events each month. Ideally this could eventually lead to neighborhood climate resiliency projects where neighbors build community through things like neighborhood gardening projects, grey water irrigation systems, solar power and battery storage, etc. We are a well educated and well connected group of people who can help write grants for local sustainability projects, and bring in inspirational speakers each month to pull community together and spark new ideas for projects to initiate. To make all of this meaningful we need to ensure that all of our residents are taken care of, and that those who want to work in Fairfax can actually live here. For example, a very large number of my colleagues at San Domenico commute from communities in areas with cheaper housing - this adds to increased emissions and pollution, while being a physical and mental burden on people who have chosen a career of service. This problem is widespread throughout Marin, and Fairfax could provide an amazing model if it could provide affordable housing allowing people to live and work in the same community. This would obviously enhance the diversity we all say we want, and with that diversity would come more ideas regarding sustainability. I have many other thoughts, but will leave it at this for the moment!
