### Dear Stephanie,

I appreciate you taking the time to speak with me on Sunday. From our conversation, I gathered that you and The Council do not know much about what has and has not been going on at 10 Olema Rd. I am going to take this opportunity to reiterate a brief overview of some of the topics that have been spoken in conversations and emailed to various members of the Planning Commission and Town Council since March of 2024.

- 10 Olema was first red tagged on or around March 12, 2024. Nothing was done to stop the work, even after visits and emails to the Building Official who assured me that "more drastic steps would be taken next week if they do not obtain permits." Permit requests were never submitted and there were never any drastic steps taken or consequences.
- A second red tag was issued on July 25th. Again, without consequences.
- Myself and various neighbors continued to voice concerns, in person and via email, to the Planning Commission throughout the spring and summer, to no avail.
- 10 Olema hosted an open house on August 24th which turned our neighborhood into a traffic circus for most of the afternoon. Alcohol was freely available and loosely monitored. All merchandise had a price tag and was available for retail sales. The neighbors were not notified of this event and there were no police present to direct traffic or even to assess the very large event that was happening.
- At least two "Private Events" have taken place, most recently on the evening of Thursday September 26th. At this private event, 10 Olema had two parking attendants to help fill the parking lot and once the lot and street were full, redirected people to the Fairfax Library parking lot. Again, no notice to neighbors and no police presence.

The history of 10 Olema is long and layered and I cannot accomplish all that I want with this email. My purpose is to get a thread going and to acquire some real information on next steps Fairfax is taking to make the owners accountable.

I have attended and spoken at the most recent Town Council and Planning Commission Meetings with the goal of drawing attention and establishing this issue on the town record.

Our neighborhood is a real community with families and retirees who both own and rent their homes. 10 Olema has not made an effort to be a part of our community or Fairfax as a whole, which is evident with their blatant disregard for the town's processes and inconsideration for the neighborhood with their large events.

10 Olema has been following their own agenda since day one and they are getting away with it.

I appreciate your time and thoughts given this matter. I look forward to hearing back from someone about The Town's stance with regards to 10 Olema Road.

• O-let'-te Coyote-man, the Creator

The mythology of the Miwok Native Americans are myths of their world order, their creation stories and 'how things came to be' created. Miwok myths suggest their spiritual and philosophical world view. In several different creation stories collected from Miwok people, Coyote was seen as their ancestor and creator god, sometimes with the help of other animals, forming the earth and making people out of humble materials like feathers or twigs.<sup>[1]</sup>

According to Miwok mythology, the people believed in animal and human spirits, and spoke of animal spirits as their ancestors. Coyote in many tales figures as their ancestor, creator god, and a trickster god. The Miwok mythology is similar to other Native American myths of Northern California.


