## RECOMMENDATION

Adopt the resolution.

## DISCUSSION

The Annual Little League Parade and Opening Day ceremonies are scheduled for Saturday, March 8, 2025, at 9:30 AM. In previous years, the Town has facilitated the parade by temporarily closing certain streets for traffic control and safety. The proposed closures for this year are identical to last year's, covering:

- Center Boulevard from 740 to the west end
- Broadway from Center west to Bank Street
- Bank Street to the Little League Field, including the connecting intersections of Pacheco, Claus, and Bank Street at Broadway

Council sponsorship is required to avoid charging West Marin Little League (WMLL) for any Town costs associated with the street closure. These closures are critical for ensuring the safety of parade participants and spectators.

**A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF FAIRFAX AUTHORIZING THE TEMPORARY CLOSURE OF CERTAIN STREETS TO FACILITATE THE FAIRFAX LITTLE LEAGUE OPENING DAY PARADE ON MARCH 8, 2024, AND APPROVING SPONSORSHIP OF THE PARADE**

**WHEREAS**, the Town of Fairfax has a longstanding tradition of supporting community events that foster a sense of community;

**WHEREAS**, the Annual Little League Parade and Opening Day ceremonies are scheduled for Saturday, March 8, 2024, at 9:30 AM;

**WHEREAS**, these street closures are essential for ensuring the safety and security of parade participants and spectators alike;

**WHEREAS**, Vehicle Code section 21101(e) authorizes the temporary closure of public streets for celebrations and parades if, in the opinion of the Town, the closure is necessary for the safety and protection of persons participating in an event on those streets during the temporary closure;

**WHEREAS**, the proposed street closures include Center Boulevard from 740 to the west end, Broadway from Center west to Bank Street, and Bank Street to the Little League Field, including the connecting intersections of Pacheco, Claus, and Bank Street at Broadway;

**WHEREAS**, Council sponsorship of the parade is necessary to avoid imposing any costs on the West Marin Little League (WMLL).

**NOW, THEREFORE, BE IT RESOLVED** by the Town Council of the Town of Fairfax hereby authorizes the temporary closure of the specified streets to facilitate the Fairfax Little League Opening Day Parade on March 8, 2024, and approves the sponsorship of the parade.
